Dear Mr. Onley:

I wish to supplement my letter of February 16th last relative to the Japanese situation in Mendocino County, and advise you that since that time I have discovered that there resides in a house on Lot 14 in Block 28 of the City of Fort Bragg, Mendocino County, one Mrs. Hannah Piggott, a Japanese, whose maiden name was Hannah Hori. She married one Harry H. Piggott in Seattle, Washington, on April 23, 1912, and she came to Fort Bragg in that year as a prostitute. In 1926 she was permitted to register as a voter due, in my opinion, to a bona fide belief by her and the registration clerk that she had become a citizen because of her marriage to said Piggott, who was a citizen. She is 74 years of age at the present time.

If there is any more information you desire in regard to Mrs. Piggott, please let me know.
