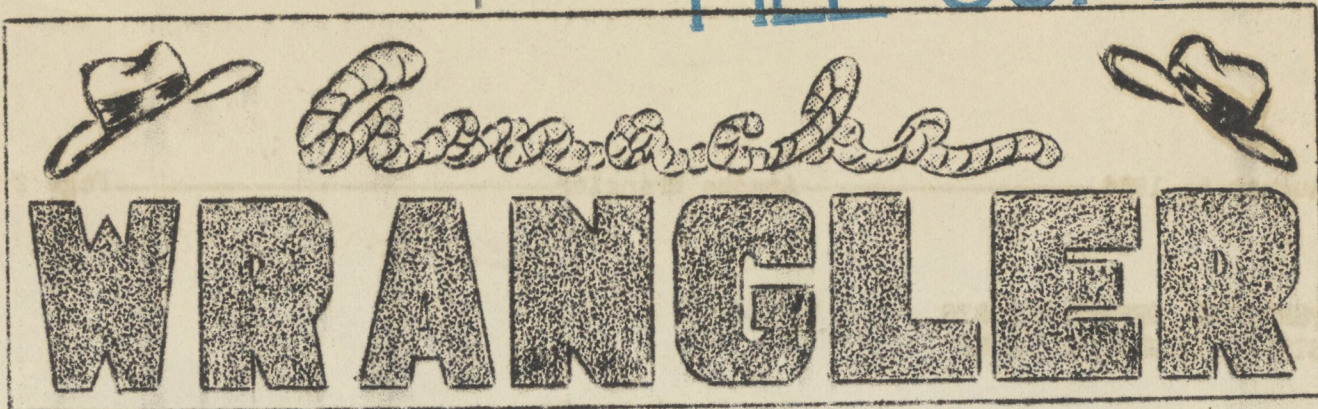

FINAL DRIVE PUTS FIFTH WAR LOAN OVER THE TOP WITH 104% OF QUOTA

A last-minute push, headed by Assistant Project Director W. Ray Johnson, who takes top honors with the purchase of three \$1000 war bonds, put the WRA staff over its goal in the Fifth War Loan with 104 percent of quota, announces Joe McClelland, bond drive chairman.

A total of \$17,163.60 went into War Bonds and stamps during the drive. Of this amount, \$9,682.25 represented payroll-allotment bonds and \$7,481.35 were in cash sales.

"All the bond salesmen worked hard on the drive and turned in good reports," McClelland said. "To Lowell M. Jackson, secondary school teacher, goes the honor of selling the most bonds. He made 22 individual sales."

COOPERATIVE DINING HALL COMMITTEE MEETS, ASKS FOR SUGGESTIONS

The committee which was appointed by Project Director. James G. Lindley to formulate a tentative plan for a personnel cooperative dining hall held its first meeting July 25, to discuss various proposals that had been received by the committee from interested individuals. Some of these ideas were:

(1) That the organization should be on a cooperative basis, and that each member should be assessed an entrance fee, probably about five dollars. 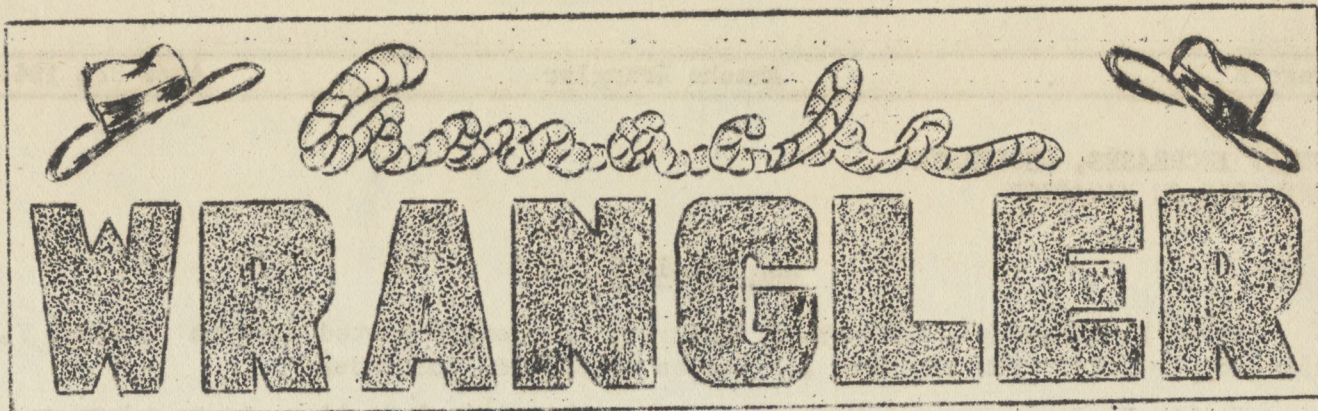

CAREFUL CONSERVATION ESSENTIAL
TO SAVE TRANSPORTATION FACILITIES

Col. L. E. Fiero, WRA Transportation Officer and Mileage Administrator, was at Amache Saturday through Monday August 12-14, to inspect our motorized equipment. He stressed the very serious necessity for better care of all our vehicles including tractors, by operators as well as in the motor pool.

Tires are of particular concern here, and the importance of correct inflation is being stressed. Col. Fiero's report stated as follows: "At the Army base in Pomona, California, I found that there were no new tires available and the seconds of a poorer grade than any I had seen on this project were being shipped to the South Pacific for use in the combat zones."

Col. Fiero appointed Assistant Project Director William Fuller as Mileage Administrator for the Granada Center. Fuller states that he will insist on conservation of gasoline and tires and better care of equipment. Your cooperation is essential, with transportation problems increasing not only at Amache, but throughout the nation. Cars are wearing out and parts are difficult or impossible to obtain. We must conserve everything we have.

Your little paper is a medium of assuring that the staff is getting necessary information.



SHARE-THE-RIDE PLAN SUGGESTED
TO HELP STAFF MEMBERS AT AMACHE

An organized share-the-ride plan has been suggested by Henry F. Halliday as a method of assisting staff members who live on the Project but do not have autos to get rides to Lamar and Granada for shopping trips.

Definite suggestions as to how the plan could best function are requested by Halliday. Perhaps a "ride-list" could be maintained at the P-X, showing names of those wanting rides and those who have extra room in their cars. The P-X might also be used as a meeting place for riders and drivers.

The problem is mainly one of contacts, as there seem to be ample cars on the Project to take care of ordinary transportation needs for shopping purposes. YOU CAN INCREASE YOUR PAYROLL ALLOTMENT
FOR WAR BONDS AT ANY TIME

MEMORANDUM for the Personnel of the Department of the Interior
(Departmental and Field).

Like all previous bond drives in the Department, the Fifth War Loan Drive, which closed July 31, was a success. It is a grand feeling to know that you may be depended upon when the Government asks for your help to finance the war. Sharing responsibility makes any burden lighter, and the returns show that all bureaus and offices of the Department participated.

Our continuing effort in the war bond program is the Pay Roll Savings Plan, and while those who are participating are giving a good account of themselves, the Department's percentage of participation is low. The Departmental Service is 83.8 per cent and the Field Service is 85.7 per cent. Combined for the Department, it is 85.4 per cent. We have not been able to reach 90 per cent participation after two years operation of the plan.

By this memorandum, I am asking administrative heads of all bureaus and offices to cause a complete recanvass to be made with a view to bringing each employee under the plan. If employees realize the benefit to themselves, and the service to their country, there should be no hesitancy in reaching the desired goals of at least 90 per cent participation and at least 15 per cent allotment of gross pay rolls.

NATIONAL WAR FUND WILL HELP OUR BOYS OVER THERE

During the next several days, Amache will conduct its part of the National War Fund, announces John D. Neal, Community Activities Supervisor, who is chairman of the local drive.

"The National War Fund is a group of agencies interested in providing services to members of our Armed Forces which are not available from any other source, and in furnishing relief to exiles from the occupied areas," Neal says. He continues:

"The largest and best known agency is the United Service Organizations, familiarly known as the USO. Theirs is a program of operating Service Clubs, Canteens, Dormitories, and similar facilities for the benefit of men and women in the Armed Forces while on leave. They have more than 3,000 such clubs in the western hemisphere, in localities ranging from Alaska to Brazil. The USO also has 87 entertainment units traveling abroad, giving shows in Red Cross Clubs, Army Camps, and wherever there are large concentrations of soldiers.

"The War Prisoner's Aid is an American organization which furnishes recreational and educational equipment to prisoners of war in enemy countries. It operates much as does the Red Cross, but in no way duplicates the work of that organization. It is easy to understand the distressing need that exists among the exiled refugees scattered all over the world. This campaign is the only request for funds made by them to the American people."

In addition to the WRA staff campaign, the evacuee residents of Amache will contribute to the National War Fund. This year, the quota for Amache is \$500; all funds above that amount contributed in the drive will be used by the local Amache USO and Blue Star Service Club.

Donald T. Horn is vice-chairman of the campaign. Team captains are: #1 - Roy Chamberlin, hospital; #2 - Lloyd A. Garrison, education; #3 - Walter N. Moers, personnel; #4 - Jacob Gerrild, welfare; #5 - Wm. M. Fuller, operations; #6 - John N. Spencer, agriculture; #7 - Jerry Sullivan, fire protection; #8 - Walter J. Knodel, relocation; #9 - Jack G. Bohon, finance.

may be of the following nature: (1) Eliminating of unnecessary functions, practices or procedures, (2) expedition of necessary work through a more effective application of present practices, (3) improvement of the quality of work, (4) reduction of administrative or operating expenses, (5) increase the scope of services rendered so as to effect a saving elsewhere. (Presentation of a personal grievance, wage-rate, or classification matter of any kind will not constitute a suggestion.)

"There are four types of awards given monthly. (1) Awards of Excellence may receive cash prizes of from \$10 to \$1000 each in addition to a meritorious within-grade promotion or a War Bond, (2) The Award of Outstanding Achievement carries with it a cash prize up to \$1000. (3) An Award of Merit will win a cash prize of from \$10 to \$300, and is accompanied by a signed letter from the Secretary, complimenting the employee. (4) A Certificate of Honorable Mention may be accompanied by a cash prize of from \$10 to \$100."

Memorandum for Personnel of the Department of the Interior.


