Dear Mr. Kunihiro:

I received the copy of your letter of April 15th addressed to the Immigration Service in Philadelphia which contains your request for deportation to Japan.

Inasmuch as you first arrived in the United States in February of 1943 and have now resided in the United States for a period of seven years, you are entitled to apply for a suspension of deportation and to apply for permanent residence status in the U. S. If you wish to apply for that suspension and residence status, both will be granted to you after a hearing by the Immigration Service and the approval of the Attorney General and Congress. That would enable you thereafter to visit Japan for a maximum period of one year whereupon you could return to the United States and thereafter visit Japan when and as you saw fit.

If you depart from the U. S. without first having obtained a suspension of deportation and been granted permanent residence status in this country, you would not be permitted to return to the U. S. in the future except as a temporary visitor when Congress authorizes Japanese aliens to visit the U. S.

It is my suggestion to you that before you make your final decision to return to Japan you should apply for a suspension of deportation and a permanent residence status in this country and thereafter you would be enabled to visit Japan.

I suggest you discuss the matter thoroughly with Mr. Yasuhiko Ohashi before you decide to go to Japan.

Dear Mr. Kunihiro:

Enclosed find copy of letter of June 20, 1950, sent to me by Richard H. Hawkins, Jr., First Secretary of U. S. Embassy at Lima.

Each of the Peruvian groups who now is desirous of returning to Peru should obtain an assurance from some responsible person in Peru guaranteeing work and food to each Peruvian who returns to Peru. It is likely that the persons in Peru who are to act as the guarantors for the intended repatriates can apply direct to the Foreign Minister at Lima to ascertain whether or not any special forms will be required to be filled out by the guarantors.

The Peruvian Government wishes to be certain that repatriates will be employed in Peru and will have food and shelter so that none of them will fall upon relief rolls in Peru.

The Immigration Service, pursuant to my understanding had with them several years ago, will provide the free transportation of repatriates to Peru from the agreed point of embarkation.

If you wish to change your mind about returning to Japan and desire to remain permanently in this country, you may apply for discretionary relief. My suggestion to you again is that you reconsider the matter. It seems to me that unless you are assured of employment in Japan that you would do better by remaining in the United States.

In addition thereto, if you have sponsors in Peru, it is now possible for you to return to Peru if you so desire. You should consult Mr. Murono immediately on the steps which you can take to be restored to Peru. Your sponsors can apply direct to the Minister of Foreign Affairs and fill out the necessary application form and affidavits that are required by that office.



This matter is before us by reason of communication from the aforementioned counsel dated July 25, 1950, wherein it is requested that the order and warrant of deportation predicated thereon be amended to provide for the alien's deportation to Japan instead of to Peru.

This case was last considered on February 19, 1947, at which time an order of deportation to Peru was entered and execution of the warrant of deportation was deferred pending the outcome of litigation involving the same subject matter.

In connection with the present motion, counsel states that the alien is anxious that his deportation to Japan be expedited.

After careful consideration of all of the evidence of record, it is the conclusion of this Board that the motion should be granted.

ORDER: It is ordered that the motion be and the same is hereby granted and that the outstanding order be amended to provide for the alien's deportation pursuant to law.


Dear Mr. Kunihiro:





Final arrangements relative to securing transportation for this alien from San Francisco to Japan will be made as soon as he is in custody of this Service completely ready for deportation. Please inform the subject that during the ocean voyage he will be limited to 175 pounds of baggage and of this total he must retain in his possession only the minimum amount necessary for his personal needs during the ocean voyage. The balance of his baggage will be checked aboard the vessel upon departure and such checked baggage must be placed in suitcases or trunks or adequately crated. His baggage cannot contain household effects, equipment or furniture.


Dear Mr. Kunihiro:
