At it, there was  
Report by Maki on YWCA meeting. Much talking and planning regarding war effort. The hard facts were faced, and post-war reconstruction discussed. Negro and Indian problems came up. They were made aware of all these other problems. She told the meeting of meeting an Indian girl who said the trees at Lake Tahoe got in her way in trying to scan horizon. May be we too will get to love the desert.

## YWCA

Very serious topics occupied most of the meeting. Fruits not being harvested, negroes cannot get jobs because not trained, U.S. O. work. One was night/given to Japanese problem. They had to understand the heat. She tried to explain the dust storms. The meeting drew up a resolution to keep up with girls in the camps and send material. "I didn't want them to stop at being Lady Bountiful, good old lady missionary type." We need them to interpret the Japanese to their communities and to watch bills that come up. They can help Japanese in free communities to adjust, and get students who go out in touch with friendly groups. S

She feels that many people are "going to bat for us" because it is happening to a group of Americans. There is some hope of getting out.

We must guard against getting provincial here, having only "Postonian angle." Here we are unpacked physically and not mentally. We are hoping we will be gone in two months. There is also the heat. These things modify YW program of the city type.

MR: Powell: We need lively intercourse with the present, political issues in New York, labor in California.

Miss Findley: How are we to meet the problem of unmarried mothers? Two have been reported to me. I hear there are many more. What is the background of this in Japanese opinion and attitude? What is done in Japan?

MISS CHENEY: The family is eager to arrange marriage. In new rich circles, men

often have more than one home -- concubines. The prejudice is about the same as here.

Miss Tsukao: The girl is done for. She often commits suicide. IN L.A. they tried to arrange a marriage. If not, the girl goes to a home. They try to arrange for the mother to work and support the baby. Usually mothers tend to neglect the baby after some months.

MR. POWELL: No chance here for the mother to move and achieve anonymity.

MISS FINDLEY: Miss A. is 20. Her mother died when she was 14. Her father is ill. She cared for the family, working long hours in cheap places. She has six brothers and sisters, the center of her life. She got them through high-school. Only the 18 year old sister knows. She applied to the hospital for a job as nurses aid -- she works here in the kitchen. The baby is to come soon. She is in fear of disgracing the family. She has evolved a plan of going to Phoenix to have the child and then come home. She can't do this, so she wants to move in with some woman here for two months to have the baby. Thus there will be no disgrace to the family. She has made her own arrangements with the hospital. She hasn't decided whether to keep the child.

MR. KIDO: Where is the man?

MISS FINDLEY: Not here. She doesn't want to talk about him. She is worried about the effect on her little sisters and brothers.

MISS TSUKAO: Do you think we can ignore this father? I think he should be taken into consideration. She seems to have a lot in her, making her own arrangements. She ought to be able to get somewhere. Could she and the father and sister be taken some place?

MISS. KUSHIDA: Probably she doesn't want to tell her father for fear he will

spread malicious stories and turn the other children against her.

MAHKI: He will find out sooner or later.

MR. TAKIDA: I don't see why she should take all the responsibility.

MISS FINDLEY: Dr. Wakatake sent her to Miss F. She was reluctant to talk about it at first. She wants to work up to the last minute because the family needs her.

Miss B. is about 18. She knew the man intimately. He was a helper of her father. They had relations for a long time. He is older than she and would marry her. She doesn't want to. A young man in #2 wants to marry her, but she doesn't want to. Her brother has a contract with still another man elsewhere. But she doesn't want him.

MR. KIDO: She seems to be thinking of her self. We encourage marriage to protect the name of the child even if there is a divorce afterwards. That is how we handle it on the outside.

MISS TSUKAO: I don't like that idea. I had a case like that. The relatives pushed it. They never lived together. The man was a nice fellow and it ruined him.

MISS CHENEY: She might marry the outside man, but not the father of the child.

MR. KIDO: Maybe as long as we stay in Poston prestige of family won't count, but I hope eventually we will go back to civilization and these things will be questioned. I think matrimony should be the foundation of motherhood. Other things set a very bad example for morality.

MISS TSUKAO: County people are more puritanical and rigid than city.

Mr. Kido says ditto. Frequent abortion in city arranged by the family. In

California any sex relations with a girl under 18 is rape. We gave the girl a family whipping.

MR. HAAS: There is an age law here too.

MR. KIDO: I am very much concerned about prevention.

MR. HAAS: There will be a family relations committee in the council.

She askd me a lot f qstns abt t psychology f childrn and told me f som f her problems tryg to keep peace btween hers and she seemed v uncertain and insecure abt it, wondrg if sne wr dog t rt tg.

I askd wat wr t qestns and she sd ty wantd to kno whr t wrkr wd liv, wat qestns wd be askd n t survey~~x~~. Ts recald to me ta afr my spch to t tchrs abt ~~x~~ Dec 19 42 BS got up and askd me to tel specifically hw my recs ~~x~~ sd be carried out. Tn agn, n our discussn abt t futr f soc research n t post war and n t reconstructn period, he wantd me to tel him just xactly wat it wd be, and seemd to feel my ansrs vague and indef. He seemd to ant me to be abl to sa ~~x~~ just wat a persn who wnt into ts wrk wd be dog at 4 o'clock n t afternoon March 7th 1944. Wn I sugstd to Sadi ta perhaps Mr. F ddnt kno wat ~~x~~ qestns wd be askd and ddnt kno whr t ~~x~~ student wd liv, it seemd a surprise. She gotd Bob as beg afraid f politicl mis- use and I gav my usual line abt undrstandg promotg betr relatns and ig- norance makg tgs worse and ta t Jpns hd to giv tr frnds amunition w we to fite etc. It seems to ~~x~~ me ts cravg fr specificity w BS and possib SS s almost obsessive. Certainly tes comments re fld struck me as beg v out f ~~x~~ perspectiv f both situatn and Flds personality espcl wn takn n t lite f BS' genl intel. It seems to sprg fm a repetitiv pattern rathr tan t realities f a situ. It seems like obseesiv self protectn, like washg hands to be clean and safe, wantg concrete detail beyond wat s reasonabl to be safe. BS shortly bfr he left our dept askd fr his auto bio back, apparently to wrk ~~x~~ on it. He hs nt produced mo or givn it bac to me.

As we partd, she lookd pathetic, drawg t bac f her hand across her frhed and sayg, "I hv chnaged my mind so many times." Ts z just wat he sd to me wn discussg whthr he sd go nto tchg or nt. She sd ta she thot lots f othrs wd be betr suitd to t wrk ta fld hd n mind tan herself.

GE cam nto my ffile and askd if he cd spk w me privatel. He sd he thot I wd like to kno ts -- Twnsend s stil n Parkr and s writg up a rpx rpt on Poston. GE lookd rathr ill and he seemd to want to talk to me abt ts rathr tan just tel me bec z he thot I ot to kno. He showd me a k letr fm Twc swndd to me paranoid. It z poorly done fr a man f T's ap- parent ed and aprnce. He speld Gelvn Galvin, and usd farthr whr he mnt furthr. T main tenor f t letr z to heap vituperatn on GE, and al t othrs at Poston. It cam as a result f GE's telg him ta afr consultg w WH he cd nt grant a rqst f T's ta ty put n writg ta he z fired specifical bec z he ddnt get along w t Jpns. (Ty hd md it mo genl, nt ~~xzxxx~~ fitg n to t wrk -- I tq) Also T hd takn awa w him a copy f t files wc GE hd askd be returnd. T letr z scornfl f GE hvng to ask WH wat he sd do, sag ta GE hd sd ta WH z nt his boss to T on previous occasion -- wc GE sd z nt n t least tru. It intimated ta GE z weak and nt abl to stand up fr himself. It refused to giv bac t files b mysteriously referd to tm stil beg in Govt hands and ta ts tg z far bigr tan involvg just a handfl f men at Poston. He mentnd Findley and Pwl and t rest f t Jap lovg gang un-American gang

GE sd ta T z v unrelaibl n hs wrk aside fm all t trbl w t Jpns. U cd nevr depnd on his dog a tg, altho he talkd v convincgl. Fr xampl he went to LA and ordrd a whole lot f tgs on his own n t nam f t project. Many f tes hd to be returnd and ty r only nw getg straitnd out t mess he creatd. GE thot he z like a wrd boss and Caucs fwnd him v hard to get along w.

T letr as I sd hd a paranoid smell and t mo Empie talkd, t mo un- stabl t guy seemd to be, w a streak f t grandiose. I recald ta on 1 or 2 ocsns wn I wantd stuff fr a staff picnic, he mo tan loadd me w fd, turng trucks ovr to our use, all n a v grand manner. At t sam tim he z

peekg n t ice box to see if anytg z beg misused, tellg me hw he z sur t kitchn staff z makg ff w ts and ta. It s qite kxx likely ta ty wr, b s suspiciousness and his grand kindness struck me at t time as an odd contrast. I wondr wat his spinal fluid wd sho? May be an alco- holic w som cerebral damage, or presenile? Anyway I ~~xxxxxx~~ suspect somtg organic mixd w t personality type.

GE sd ta hs Niece Mrs. Hamilton told Mrs. E t othr dy ta T z soon gog to be comisd a col n t army. T letr GE showd me reffd to Rhienhart as Mrs. E's fathr. GE n commentg on t letr ddnt contradict ts part.

80. E.O. cam to my room on wrd 8 tody to see Mr. Fld who z ovr n t Ad bldg. He walkd bac to Ad 3 w me and tn bac agn w both f us, aprntl nt n t least concernd to be seen gog arwnd w me. He told Fld ta he z v ntrestd n t survey, b z politically unavailable rt nw until he got his name clrd n t community. Wl I z tr I hrd him sa ta n Aug or Sept he hd carried out a kind f Gallup survey on hundreds f I and fwnd ta al f tm thot ta ~~xxxxxx~~ al t Jpns whethr citizn or nt sd be treatd like Jpns, nt as Americans. Al Jpns sd be treatd alike. He also sd ta he hs ntrvud ovr 200 ppl snc t strike, b usg an ndirect techniq, nt askg direct qestns. Like RN he tqs t comunity s part fr and part agn t N gog nto t army. He personally tqs it s gd. He tqs t arrests and gogs on n 2 r gd fr l. A lot f ppl tq ta t admin s justified n wat it hs done, b a lot f othrs tq dif. He took credit fr hvng preventd t sam sort f tg hpng n l, when he talkd to t Kibes and hedd tm ff fm beatg up Dr. I.

MP FC told me this morning that when Catherine Embree took up a collection for  
 FC to get Xmas presents for the personnel mess help, Moody Palmer refused  
 to give. The amount asked was a dollar from each person. He said that he had  
 Edwards been us for his money. Edwards refused, turning to Art Harris and saying,  
 we're dog too much for these people, don't you think? AH said, you mean to, not for,  
 don't you? FC said that the 5th grade teachers told her that the city children speak  
 less Japanese than the country. The 5th grade among country people are Nisei while  
 NF in the city they are Sansei. The children know understand conversation in Japanese, but  
 Miss not ~~know~~ formal speeches. One of the reasons Miss Tsukao left Miss F's  
 Tsukao department is that she could not stand being made to feel so sorry for herself and  
 the Japanese by Miss F. She is very sore at the attitude, the lack of cooperation  
 with the administration, she is looking for a chance to leave camp. She likes doing  
 some service work for the school, kitchen and does well.

JE JE told me very confidentially that he had just ~~recently~~ recently  
 a telephone call from Mr. Collier and Joe McCaskille. Ty had received  
 RN wrd that there were no big dogs here as a result of Kido and other JACL members  
 RF wire in regard to taking Nisei into the army. JE reassured them. Ty told  
 him that when a few days when we would get a letter making segregation possible.  
 (WH saw a man in Sells for a Xmas vacation.) JE said that Roy Furuya said  
 he had heard from 33 people that Dick Nishimoto's dog about saying that Roy is an  
 FBI agent. Roy is very sore and JE wants the word passed on to Dick.

NF NF told me that Kay Nishimura used to tell the wives of the men who had  
 been interned that he could get their husbands out. She said very emotionally that  
 Dr Waketake was with the pickets for three nights during the strike. He did not  
 go because he wanted to, but because he was told that if he did not go, something would  
 happen to his family.

This evening attended the Mass choir. See program. I went around the  
 crowd making ~~samples~~ samples by counting groups of twenty in 6 different places.  
 Out of each 20 there were between 0 and 5 Issei to the rest N. The choir  
 looked very nice, all dressed in black and white. I was told afterwards that  
 the black for the boys was contributed by the GI P-coats.

He tgs t ppl hr r worried abt t szrzkz futr, mo so since t strike. Somtimes wn JE sz, Wat s t use? he feels just t sam wa. I askd hw soon he z gog on his vacatn, he sd he ddnt kno, nt fr a month yet. Hopes ta McCaskil wil com to take his place. Sd he recently wrote JC a 10 pafe memo on tgs he wantd done. He sd ta DM hd wantd to kno fm WH wn he z hr who wd sta on if t agreement w t IS wr cancelled. WH sd ta wd depend on Mr. C's attitude. As fr himself, he sd ta he wdnt sta on undr any circumstances and he ddnt tq many f t othrs wd eithr. He tgs ta TH needs a rest, and ta VK k nl see tgs n terms f bargaing.
