2. Council asked to cooperate in formulating a satisfactory labor breakdown to comply with the Washington requirements of the labor quota.
3. Cooperation of the Council was requested in speeding up the repair of broken pipe lines by voluntary block help.

1. The matter of the labor quota of 2620 for the project has been discussed with the Labor Committee of the Council and everything is being done to move satisfactory adjustments.
2. The Provo shooting incident aroused concern by the Council. A Council investigating committee was sent to the scene and their report was satisfactorily accepted.

The new Council, headed by Mas Narahara, former center Block Manager, and later employed in Relocation Division, and Seinosuke Fujita as vice chairman who has been head of C. A., appears to be headed for more active participation in important community affairs. Since the election June 14, there have been a number of resignations although replacements have been made in each case without delay. It is too early to predict what this shift means, although it may be only an individual disinclination to serve. The present Council appears to be more interested in important matters of policy affecting all residents, although its deliberations, representations and requests are as yet still largely determined by community pressure.

Two real needs that I have expressed to the chairman and individual Council members and Council committees, are first, to add to their committees, such as Relocation and Labor, certain non-Council leaders of the community. This would greatly strengthen the Council, bring about closer understanding between residents and Council and at the same time improve the work of the committees. The Council still seems to be somewhat defensive about any question as to their official representatives of the community and therefore are hesitant about adding non-Council members to their committees.

The other real need is for more of the appointive staff to appear before the full Council to answer questions directly and enlist their understanding and support on major problems, while at the same time showing the individual Council members that the appointive staff are interested and aware of the problems of the residents. A start has been made as so far too much of the Council deliberation and contacts with the staff is through representatives and committees going back and forth as reporters and without authority or responsibility to come to any agreement and decide, subject to approval of the Council on the necessary course of action.

We have had several discussions on Relocation with the Relocation Planning Commission, and with the Chairman and Vice Chairman and we are all hopeful that a much more active participation will be taken by this committee including the addition of representative leaders from non-Council groups.

Most Council committees have been active and are assuming

an important place in staff-Council relationships and program. Procedures for channeling reports and communications and recommendations have been worked out and agreed upon.

Separate reports have been made on the major controversial matters considered, most pressing of which this month was the Hospital services. Both the community and the project administration seem to be expectant and hopeful of a Council that will serve the community with increasing courage and intelligent and constructive leadership. I might add that we have had frequent and intensive discussion with Division and Section heads on their responsibilities and opportunities for more effective cooperation with the Council committees and Council members.

Unfortunately the Council after careful and thorough study of the various problems presented to them by the administration and by the community felt the necessity of making detailed and specific recommendations as to just how the problems should be handled and failing to get 100% approval from the administration which involved the transfer or dismissal of certain appointed staff members then felt the necessity of securing evidence of community support and resorted to petitions to show they had full community support. The results of all this are not as yet apparent but will be awaited with keen interest.

During the month, a new Council was elected, composed of a majority of former members constituting a substantial vote of confidence. The fact that the outgoing Council had adopted a policy of full cooperation with the Administration for the good of the community and were reelected with some exceptions, on the basis of results achieved was encouraging. Effort was made to streamline the Council before election, but little response to the proposal of the Chairman for a 7 or 9 men Council was received. The block representation will probably carry on for the life of the center.

The major work of the Council this month was accomplished through committees and the tireless work of the Chairman, although not reported in minutes or resolutions. Partly through such efforts, the Hospital secured 34 nurses aides, one from each block; the pipeline crew was increased to 50; Education Committee helped with teachers; and helpful mediation in several messhall disputes was given. The Council Chairman summarized the past six months as enjoyable, worthwhile and one of close cooperation, after a number of tough struggles following an earlier period of little cooperation, either way.

Our backing of the Council when the issue was in doubt was apparently the deciding factor, although at the same time, the residents were told, it was their problem and responsibility to decide who should represent them and that the Project Director would meet or "negotiate" if necessary with any truly representative body so designated by the residents in an official manner, but until so notified to the contrary by election, that body was the Council.**

2. **The major efforts of the Council were taken up with preparations for the all-center conference at Salt Lake City with some help from the Project Director and particularly the Salt Lake City WRA office.**

However, the election of the new council which took place the last week in June resulted in elections in all but three blocks with 12 new members and 19 re-elected. A majority of the new members are said to be identified with the so-called anti-administration or opposition group. This should make for real competition in the election of the new chairman, the result of which will pretty well indicate what stand the new council plans to take.

Block Managers desired a clarification as to how long a relocatee can leave his freight in the center warehouse. They wanted to know when checks are due so they would not make needless trips to the Finance Section. They asked that their subsistence allotments be clarified to them. They have recommended overtime for all evacuee workers.

7 The new Council, with Mr. K. Nodohara as Chairman and Mr. Hideshima as Vice-Chairman and Mr. Sugiyama as Secretary, met weekly with Project Director and later in month with Dr. Provinse and the Project Director. They were anxious to show full cooperation with administration, but concerned themselves more and more with routine and minor problems, taking up complaints of individuals feeling need of continuation of so-called luxury hospital services and more individual attention to special relocation services. The Project Director suggested they consider winding up Council activities or merging with the Block Managers through the Joint Committee, but there was little response. The Council gave a Farewell Banquet to the two evacuee doctors before their departure to California.
