I returned on Monday, May 1, after two weeks absence from the project during which time I attended the relocation conference in Chicago and visited the Denver area office. We accomplished the objectives of the conference, namely; To become acquainted with each other, discuss the problems common to each other, and we arrived at uniform interpretations of relocation policies. I believe that much good will come from this conference and I, for one, am thankful for the privilege of attending it. I believe they should be scheduled regularly at least once a year or when emergency changes are initiated.

I arrived at the project to learn that my assistant, Edward Nossuff was scheduled to leave the project on May 7, and that our Senior Relocation Adviser, Charles B. Olds was scheduled to leave the following week, both to be inducted into the Armed Forces and assigned to the language school at Ann Arbor, Michigan. Mr. Nossuff did leave the project on May 7. We, who have worked closely with him and have been in a position to observe his work, fully realize our loss. His sincerity of purpose and complete understanding of the relocation problems together with his sympathetic understanding of evacuation made him unusually well qualified as an employee of the Relocation Division. We know that he will likewise serve his country well wherever ordered.

The results of the relocation conference in Chicago was presented to the combined staff of the Relocation Division and Welfare Section at the regular bi-monthly Relocation Division meeting. The counseling program was also reviewed at this meeting. A copy is attached for details.

We were invited to attend the regular Community Council meeting held this time in Unit II on Thursday, May 4. We were promised cooperation by this group in our future relocation program.

Considerable time at the regular weekly Appointed Personnel staff meeting on Saturday afternoon was devoted to a report on the Chicago conference. Definite cooperation by the Appointed Personnel has been promised.

The weekly Selective Service report is as follows: Number of names submitted to us from Arizona State Selective Service Headquarters for induction proceedings to date, 195; number on project, 147; and number who have left the project, 48.

Attached are the weekly reports for the program, resettlement information, leave and field sections.




The California Selective Service board rules were obtained from several large boards indicating that any individual on the project would not have a chance for deferment and likewise indicating that if an individual, particularly over thirty years of age, was engaged in a necessary work contributing to the war effort, he would have a chance for deferment. As a result of this information, relocation interest has greatly increased.

The third preinduction physical examination was held in Poston on May 21. One hundred and thirty seven notices were sent out for the examination- 134 boys reported, 3 refused to report. Thirty-three notices were sent out for the induction on May 21- 22 boys were inducted, 7 cancelled, 2 held over for further examination, 2 refused to be inducted.

The Selective Service report to date is as follows: 884 names submitted to us from Arizona State Selective Service Headquarters, 568 were on the project and 316 had left the project; 26 in the Enlisted Reserve Corp; 13 boys had refused to take the preinduction physical examination.

The number of leaves issued from the project during the week is as follows: Indefinite leaves, 44; seasonal leaves, 95; short term leaves, 33. The total number of indefinite leaves issued to date is 3,774. The present population of the project is 12,509.



Eight men received telegrams informing them that their Orders to Report for Active Duty will be effective on June 7, 1944. The tentative date for the next pre-induction physical and induction has been set for June 24, 1944. We have had 147 names submitted to us for processing.

The Selective Service report to date is as follows: Number of names submitted to us from the Arizona State Selective Service Headquarters for induction processing, 948; 612 were on the project; 336 had left the project. Number notified to report for preliminary physical examinations to date, 529. Number notified to report for pre-induction physical examinations (DSS Forms 215), 407. Number who had refused to report for pre-induction physical examinations, 13. Number notified to report for induction, 92. Number notified to report for active duty, 19; 11 were on the project; 8 had left the project.

The number of leaves issued from the project during the week is as follows: Indefinite leaves, 51; seasonal leaves, 45; short term leaves, 40. The total number of indefinite leaves issued to date, 3849, not including 112 former Arizona residents who had left the project. The present population of the project is 12,264.

Mr. Robert Dolins left the project Tuesday afternoon after a helpful visit to Poston. We feel inspired through his help and expect our counseling program and general relocation program to be benefited by his visit.

Mr. R. L. Wilmot, War Manpower Commission representative, arrived at the project to spend a few days completing arrangements for the cannery contracts.





He was assigned to Unit III to replace Miss Myrtle Leslie who is returning at the end of the month to Rochester, New York.

Following is the Selective Service report to date: 1,022 names submitted to us from Arizona State Selective Service Headquarters for induction processing, 664 on project, 351 have left project; 601 given preliminary examination; 76 Enlisted Reserve Corp; 13 refused preinduction physical; 17 refused induction; and 37 left the project on active duty.

During this week we had the largest number of departures of the year. There were 230 relocating. 110 indefinite leaves, 83 seasonal leaves, and 37 short term leaves. Of the 110 indefinite leaves, 16 left for the Armed Forces, 9 employment, 52 community invitations, and 33 joined families. There were also 7 transferees and 1 death. There were 78 admitted to project.


Miss Myrtle Leslie, Relocation Interviewer assigned to Unit III, completed her detail and left the project for Rochester, New York. She was a valuable addition to our staff and accomplished a great amount of work, particularly in initiating the new counseling program.

June was our best month for permanent relocation. During the month we issued 374 short term leaves, 262 seasonal leaves, and 402 indefinite leaves. During the week, nearly \$15,000 worth of obligations were made for those who wish to relocate in July before the appropriation for the new fiscal year would be granted.

On Wednesday morning, June 28, 181 individuals were called for pre-induction physical examinations and inductions at Phoenix, Arizona. Breakfast was served at 5:00 a.m. in messhall block 46, and 14 trucks delivered the individuals to the train. Sixteen failed to report for induction and 5 refused to be inducted at Phoenix.

Following is the Selective Service report to date: 1,061 names submitted to us from Arizona State Selective Service Headquarters for induction processing, 691 on project, 370 relocated, 13 refused pre-induction physical, 38 refused induction, and 133 on the Enlisted Reserve Corps.


Seabrook Farms
