General crime condition indicates that we have had a minimum amount of law and regulation violations during the month.

No trouble has been known to have its origin due to segregation.

One arrest was made for violation of project regulations and one was made for contraband.

One case of either attempt suicide or simulated suicide attempt was investigated.

Twenty three persons were investigated due to a report that rocks had been thrown at a freight train. While reprimands were given, the boys were not referred to any judge, or judicial body, for prosecution.

One evacee was placed in jail at Joplin, Ark., by officers at that city, on suspicion. F. B. I. Agent, Mr. Vernon Ward, was asked to investigate the case to determine whether the evacee should be prosecuted on any charge or released. Subject released.

Wilton C. Robinson, Internal Security Officer, resigned.

One evacuation was added to staff - Mr. Carroll E. Pollard. Two more evacuees are being considered for appointment as Internal Security Officers, and steps are being taken to replace Miss Ruth Jean White, secretary, who resigned. Every effort is being made to recruit a staff up to the strength authorized.

During the month, two appointed personnel officers, Mr. Al H. Reed and Mr. O. D. Walters were added to the staff.

Perhaps the greatest difficulty at this Project has been that we could not obtain enough evacuee police officers, but since the expatriates have been removed to Tule Lake, we think there is a change of attitude towards our work. One man who formerly worked for us came back to us the day the last Tule Lake train left, and we have recruited three officers who were formerly officers at Tule Lake.

A juvenile gave us considerable trouble by stealing from the mails and forging a money order and a check stolen. This boy has been sentenced to the Boys Training School at Washington, D. C.

There is a slight increase in juvenile delinquency but the difficult part of the problem is that we have no institution to take care of a juvenile convicted of any offense other than Federal laws. Institutions for boys of juvenile age in this State are crowded and cannot take any boys from the Center.

There is considerable less tension since segregation and both the personnel and evacuees remark about it.

Mr. J. B. Cook, Chief, was assigned November 6, 1943 to Tule Lake on an emergency assignment. P. R. Cain was appointed Acting Chief during the absence of Mr. Cook.

The complete re-organization of the Internal Security Section is now in process. Heretofore all members of this department who were not on duty at the Internal Security office were known as Block Monitors. In the re-organization all men working under this department are police officers. Lieutenants and sergeants have been appointed among the evacuee personnel and the attitude of the entire force indicates that an efficient organization will soon be functioning.

One short wave radio was found operating in the Center. This case still in process of investigation. Speeding case and window peeping case closed.

Trouble between Block Manager and residents of Block still in process of investigation.

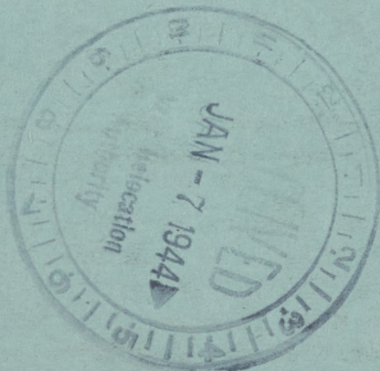
