#### Call to Order

The 1968 Pre-Primary Convention of the California Labor Council on Political Education was called to order at 10:15 a.m. in the Imperial Ballroom, Hilton Hotel, San Francisco, California, by Albin J. Gruhn, President.

President Gruhn then led the delegates in the pledge of allegiance to the flag.

#### Invocation

President Gruhn introduced Father Bernard Brennan, Assistant Pastor, St. Mary's Cathedral, San Francisco, California, who presented the following invocation:

"Almighty God, we thank You for seeing another day in Your service. Realizing our utter nothingness, we ask that You assist us in helping to promote honest and upright government in these United States of which we are grateful and proud to be citizens.

"We pray that You will keep ever before our minds the needs and aspirations of our fellow citizens, especially those of the working classes to whom we owe so much in the development of our great nation.

"May we always be imbued with the spirit of brotherhood, not weighing a man's worth on the basis of race, creed or nationality but, rather, on his honesty and willingness to work for his fellow man.

"Let our heart's desire be the finding of common ground rather than the building of hatred, divisiveness and mistrust. Let us never forget the words of Your noble servant and our immortal President, John Fitzgerald Kennedy: 'Here on earth God's work must truly be our own.'

"Amen."

#### Welcome to Delegates and Visitors

President Gruhn briefly welcomed delegates and visitors at this time.

#### Tribute to Martin Luther King, Jr.

President Gruhn, at the request of Secretary-Treasurer Thos. L. Pitts, in which he joined, asked that all delegates and visitors to the Convention stand for two minutes of silence in tribute to the memory of the late Reverend Martin Luther King, Jr. — "a great American, one who devoted his life to the struggle for freedom, equality and justice for all Americans."

Here followed two minutes of silence in tribute to Martin Luther King, Jr.

#### Opening Address

Albin J. Gruhn

President Gruhn then addressed the Convention as follows:

"No one needs to be reminded of the

fact that this year's elections are crucial ones. You have heard this said before. While it was true then, it is doubly true now.

"We are gathered here today to begin a monumental task. At the onset we know that to be successful in this task will require unparalleled work, unflinching commitments, united efforts and the courage of our convictions.

"We also know that the stakes are high. Come November there will be either an upsurge in liberal forces which will make possible progress of labor's legislative program or a retreat back into the stale and reactionary policies of the conservative forces.

"The issues are complex, but the results of our efforts are easily predictable. Progressive legislation will continue to increase or it will wither and die. And the conservatives will be out in force trying various devices to destroy our labor movement.

"If you want to verify these obvious conclusions, just take a look at what happened in Sacramento since the 1966 elections as an example.

"Organized labor believes that today's problems must be met and solved with ideas that are as vital and as useful as the day itself. We patently reject the belief held by some that forward to yesterday solves anything.

"All of you will be called upon to make sacrifices in terms of your own personal time. This is the stuff of democracy. It is also the single most important ingredient which created this great labor movement of which you and I are proud to be a part.

"Make no mistake. The opposition will sacrifice their time and money. They will do everything they can to place their men in office. But I am confident that our efforts will carry the day if we are diligent. Why? Because we speak for the many, for the disfranchised, while our opponents speak for and through the selfish and narrow-minded. They will attempt, as they have in the past, to misinform and misguide, to clutter and to confuse the issues, to play upon the darker side of men's souls. Our task is to make sure that the people of this state and this nation do not rob themselves of a bountiful future because they were misinformed and we did not do our job.

"You have heard it before and I say it again: all that is necessary for ignorance and grief to triumph is for good men to remain silent. Organized labor on the national, state and local levels must speak out on the issues of this year's elections again and again and again in the days ahead.

"Will those opposed to the labor movement and all it stands for repeal Section 14(b) of the Taft-Hartley Act? Will they ask to cure the diseases of poverty and discrimination which engulf this nation? Will they ease the crisis of our cities? Do they believe that our social security system should be improved?

"We know the answers to these questions already, but do we know them well enough to act upon that knowledge? We are gathered here today to answer that question.

"I could go on and list point by point what is at stake. I believe this is unnecessary. We all know what is at stake and what our opposition stands for. We have heard their cliches and felt the sting of their past policies. We know their answers to the burning questions of our time are the answers of the outmoded and the never-was. We also know that they are powerful and clever, vigorous and growing, and would like nothing better than to erase the history of this labor movement.

"We have our work cut out. The opposition thinks that they are riding high. They think that they have turned the corner. Let us show them how much we care about our convictions. Let us renew today as we have in the past our commitment to pursue the progressive and the humane, to dispel the reactionary and shortsighted. And remember, we must be united through solidarity, sacrifice and sweat in order to help to build a better America for our membership, their families, their children particularly, and all Americans.

"In conclusion I would like to take this opportunity to call your special attention to the Report of Secretary-Treasurer Tom Pitts. You received this report when you presented your credentials to the Credentials Committee. The important message and information contained in Secretary-Treasurer Pitts' report clearly points out the adverse impact of the conservative victory in the 1966 general elections.

"It also points out that in this election year 1968 all California workers have their backs to the wall. These are the hard, cold facts whether we like them or not. It is therefore imperative that every union member in the state roll up his sleeves, go to work, do the same job we did in 1958. With the help of Almighty God we will win in California in 1968. And thus we will also help to bring about a victory in the country as a whole, which will assure continued progress of organized labor's legislative program for a better America for all its citizens regardless of race, creed or occupation.

"Thank you very much."

## **Report of Committee on Credentials**

**G. J. Conway, Chairman**

President Gruhn called on Chairman G. J. Conway of the Committee on Credentials for his report.

Chairman Conway reported that the committee had examined the credentials of delegates listed in the Preliminary Roll of Delegates and found them in order. He also read additions to this list. On his motion, the preliminary report of the Committee on Credentials was accepted. (See Completed Roll of Delegates.)

## **Report of Committee on Rules and Order of Business**

**Max J. Osslo, Chairman**

At the request of President Gruhn, Max J. Osslo, Chairman of the Committee on Rules and Order of Business, submitted for consideration the following rules:

**1. Roberts Rules of Order.** The convention shall be governed by Roberts Rules of Order on all matters not provided by the Constitution or specified in these rules.

**2. Rules—Adoption of Standing Rules.** The adoption of the standing rules shall require an affirmative vote of a majority of the duly qualified delegates to the convention, present and voting. When once adopted, such standing rules shall remain in effect, unless suspended or amended as provided in these rules.

**3. Amendment of Standing Rules.** No standing rule of the convention shall be amended except by an affirmative vote of a majority of the duly qualified dele-

gates to the convention, present and voting. No such amendment shall be considered until it shall have been referred to and reported by the Committee on Rules.

**4. Convening the Convention.** The convention shall convene at 10:00 a.m.

**5. Resolutions Defined.** Whenever the word "resolution" is used in these rules, it shall include constitutional amendments.

**6. Committee Reports.** All committees shall report on all resolutions submitted to them. Whenever there is majority and minority division on any committee, both the majority and minority shall be entitled to report to the convention. The discussion and vote of concurrence or non-concurrence shall be first on the minority report.

**7. Committee Quorum.** A majority of any committee shall constitute a quorum for the transaction of its business. At least a majority of all members present and voting shall be required to adopt a recommendation on a resolution.

**8. Passage of Resolutions and Committee Reports by Convention.** (a) A majority of the delegates present and voting shall be required to act on a committee report or a resolution, except a constitutional amendment, which shall require a two-thirds vote of the delegates present and voting. (b) No motion or resolution shall be finally acted upon until an opportunity to speak has been given the delegate making or introducing same, if he so desires.

**9. Roll Call Vote.** At the request of seventy-five (75) delegates present and voting, any motion shall be voted on by roll call per capita vote of the delegates. When a roll call has been ordered no adjournment shall take place until the result has been announced.

**10. Precedence of Motions During Debate.** When a question is under debate or before the convention, no motions shall be received but the following, which shall take precedence in the order named:

First—To adjourn;

Second—To recess to a time certain;

Third—For the previous question;

Fourth—To set as a special order of business;

Fifth—To postpone to a stated time;

Sixth—To postpone indefinitely;

Seventh—To refer to, or re-refer to committee;

Eighth—To divide or amend;

Ninth—To lay on the table.

11. **Motions in Writing.** Upon the request of the Chairman, a motion shall be reduced to writing and shall be read to the convention by the Chairman before the same is acted upon.

12. **Contents of Motions.** No motion, whether oral or written, shall be adopted until the same shall be seconded and distinctly stated to the convention by the Chairman.

13. **Motion to Reconsider.** A motion to reconsider shall not be entertained unless made by a delegate who voted with the prevailing side; such motion shall require a two-thirds vote to carry.

14. **Motion to Table.** A motion to lay on the table shall be put without debate.

15. **Recognition and Decorum of Delegates.**

(a) Delegates when arising to speak shall respectfully address the Chair and announce their full name and the identity of the organization which they represent.

(b) In the event two or more delegates arise to speak at the same time, the Chair shall decide which delegate is entitled to the floor.

(c) No delegate shall interrupt any other delegate who is speaking, except for the purpose of raising a point of order or appealing from a ruling of the Chair.

(d) Any delegate may appeal from a decision of the Chairman without waiting for recognition by the Chairman, even though another delegate has the floor. No appeal is in order when another is pending, or when other business has been transacted by the convention prior to the appeal being taken.

(e) Any delegate who is called to order while speaking shall, at the request of the Chair, be seated while the point of order is decided, after which, if in order, the delegate shall be permitted to proceed. The same shall apply while an appeal from the Chair is being decided.

(f) No delegate shall speak more than once on the same subject until all who desire to speak shall have had an opportunity to do so; nor more than twice on the same subject without permission by a majority vote of the delegates pres-

ent and voting; nor longer than five minutes at a time without permission by a majority vote of the delegates present and voting.

(g) Any delegate may rise to explain a matter personal to himself, and shall forthwith be recognized by the Chairman, but shall not discuss a question in such explanation. Such matters of personal privilege yield only to a motion to recess or adjournment.

16. **Voting Not to be Interrupted.** When once begun, voting shall not be interrupted. No delegate shall be allowed to change his vote, or have his vote recorded after the vote is announced.

17. **Attendance of Delegates.** Each delegate shall report to the Sergeant-at-Arms at the beginning of the session and shall sign the card presented to him; except, if unavoidably absent, he shall have the privilege of reporting to the Secretary.

### Committee Report Adopted

On motion of Chairman Osslo, the report of the Committee on Rules and Order of Business was accepted, and the committee discharged with thanks.

## **Absence of Secretary-Treasurer Pitts**

At this time, President Gruhn reported as follows:

"At this time I wish to report to you from our Executive Secretary-Treasurer Tom Pitts, who recently underwent surgery for his hip and therefore regrets that he is unable to be with us today at this Convention. He wishes to express his best wishes to all of you. He is coming along fine. And I know all of his friends will be happy to know of this fact.

"Tommy has requested one of our Vice Presidents, a long time Vice President of this federation, to take on some of the work that is normally done by him in this Convention in connection with the report of the Executive Council to this Convention.

"At this time I call on Vice President Tom Small."

Vice President Small then responded:

"I want to say that I am fully cognizant of the fact that I have a big pair of shoes to fill and it is no intention of mine to try to fill them. I shall do the best I can."

## **REPORT OF THE EXECUTIVE COUNCIL AND ENDORSEMENTS BY THE CONVENTION**

**Thomas A. Small, Vice President  
District No. 8**

Vice President, District No. 8, Thomas A. Small then read as follows:

**"Report and Recommendations of the  
Executive Council to the**

**Pre-Primary Convention of the  
CALIFORNIA LABOR COUNCIL  
ON POLITICAL EDUCATION**

**San Francisco, April 10, 1968**

"The Executive Council of the California Labor Council on Political Education, together with the duly appointed Advisory Committee, met in the San Francisco Hilton Hotel, Tuesday, April 9, 1968, to interview candidates for the office of U.S. Senate in the primary elections of June 4.

"Following this, the Advisory Committee made its recommendations to the Executive Council.

"The Executive Council then met in separate session and made the following recommendations to the convention.

## **United States President and Vice President**

"Article XI of the COPE Constitution provides in Section 1 that the Executive Council shall have the exclusive right to recommend to this convention endorsement of candidates for the offices of United States President and United States Vice President.

"In the past California Labor COPE has uniformly followed the policy of endorsing candidates for these offices only after specific candidates have been selected and are contesting for election at the general election and not at the pre-primary stage.

"The Executive Council sees no reason to change this policy at this time.

"The Executive Council, accordingly, recommends no endorsement for the offices of United States President and Vice President at this time."

On motion of Chairman Small, the recommendation was adopted.

## **United States Senate**

The Executive Council recommended:

Democratic: **Open**

Republican: **Thomas H. Kuchel.**

Chairman Small moved adoption of the recommendation, and the motion was seconded.

Art Carter, Central Labor Council, Contra Costa County, spoke in opposition to the "Open" recommendation for the Democratic party, having been instructed by his Central Labor Council COPE to present the name of William S. Bennett for endorsement.

Vice President Max Osslo spoke in support of the Executive Council recommendation, as did Vice President Small, who explained that an "Open" endorsements meant that it was open for anyone to make his own choice, or for any local COPE to make its own choice. Vice President Small also mentioned that Mr. Bennett had been scheduled to appear before the interview Committee, after accepting a time allotted to him, and did not appear.

The motion to accept the Executive Council's recommendation for United States Senate was passed by the Convention.

## Further Endorsements

Vice President Small continued:

"The Executive Council of the California Labor Council on Political Education met in the San Francisco Hilton Hotel, San Francisco, Tuesday, April 9, 1968, to consider local COPE recommendations for election to the United States Congress, State Senate, and State Assembly.

"The following recommendations are accordingly submitted by the Executive Council for district offices."

## Endorsement Procedure

President Gruhn then suggested the procedure to be followed for the remaining endorsements. The endorsement list would be read by Vice President Small. If there were a question about any recommendation, the delegate objecting should speak up to request that that endorsement be set aside, to be taken up individually after the other endorsements were acted upon. There being no objection, this procedure was subsequently followed.

Vice President Small called the attention of the delegates to the following:

"You will notice on the 'Open' endorsements, that some of them are followed by an asterisk, which means 'No recommendation received from the COPE involved'."

Vice President Small then presented the following endorsement recommendations of the Executive Council:

Upon request, the recommendations for Districts 16 and 18 were set aside temporarily.

On motion of Vice President Small, the Council's recommendations for all Congressional Districts except 16 and 18 were adopted.

## DISTRICT NO. 16

Vice President Small then moved that the recommendation for District 16, for B. F. Sisk, Democrat, be approved.

W. T. O'Rear, Central Labor Council, Fresno, spoke in support of the motion.

Bill Drohan, I.U.E. No. 1507, San Jose; Dick Groulx, Central Labor Council, Alameda County; C. L. Dellums, Sleeping Car Porters, Oakland; and Russell R. Crowell, Cleaners & Dyers No. 3009, Oakland, spoke in opposition.

Vice President Small stated for clarification that the endorsement originated in the recommendation of the local COPE of Mr. Sisk's district, not in the Executive Council.

The motion to accept the endorsement recommendation was lost.

Albert Erickson, AFL Film Council, Hollywood, then moved that the Convention make an "Open" endorsement for District No. 16. Motion was seconded and carried.

#### DISTRICT NO. 18

Vice President Small then moved that the Executive Council's recommendation to endorse Harlan Hagen, Democrat, for District No. 18, be accepted.

Harry Finks, Culinary Workers No. 561, Sacramento, and Paul Jones, Central Labor Council, Bakersfield; spoke in support of the motion.

Peter Lallas, Waiters & Dairy Lunchmen No. 30, San Francisco, spoke in opposition.

The motion to approve the recommendation of the Executive Council for District No. 18 was passed.

#### Congressional Endorsements Approved as Amended

Vice President Small then moved that the Convention approve this portion of the Executive Council's report and recommendations as amended, as a whole.

The motion carried.

On request, endorsements for Districts No. 1 and No. 9 were temporarily set aside.

Vice President Small moved that, with the exception of Districts No. 1 and No. 9, the recommendation of the Executive Council be adopted.

The motion was seconded and carried.

#### District No. 1

Vice President Small moved that the recommendation for "Open" endorsements for State Senate District No. 1 be approved.

Everett Matzen, Sonoma County COPE, spoke in opposition, explaining that the Sonoma County COPE had met only the day before, having been unable to do so previously because of the size of their district and the number of candidates to be interviewed. At that time they voted to recommend that Randolph Collier be endorsed by the Convention.

Marvin Adair, Lumber and Sawmill Workers Northern Calif. District Council, Redding, a member of the Executive Council, also asked that, under the circumstances, the "Open" recommendation be voted down.

The motion for "Open" endorsement was defeated.

Delegate Matzen then moved the endorsement of Randolph Collier, Democrat, for District No. 1.

Motion was seconded and carried.

#### District No. 9

Vice President Small then moved that the Executive Council's recommendation for "Open" endorsement for District No. 9 be approved.

Ed Turner, Marine Cooks & Stewards, San Francisco, spoke in opposition, and said he had been a San Francisco COPE delegate at a lengthy candidate-interviewing session.

For clarification, Vice President Small spoke:

"For the information of the delegates to this Convention I would like to read the following, which is an excerpt from the minutes of the San Francisco Labor Council:

"It was announced to the delegates that the endorsing convention will be held Friday, April 26th at 8:00 p.m. in the auditorium of the Labor Temple and

that the Executive Board of the Committee on Political Education will meet starting on Thursday, April 25th at 10:00 a.m. for the purpose of interviewing candidates.'

"And no recommendation was received from the San Francisco Labor Council or COPE."

Vice President Paul Jones, Laborers No. 304, Oakland, further explained the procedures of the Executive Council:

"As a Vice President and one who sits on the Executive Board I would like to explain some of the things that the Board is up against.

"First, we take the recommendations of the county COPEs and we work from there. It takes a two-thirds' majority of the Board to overthrow a county COPE. This means that in our Board it takes twenty-five votes.

"We feel that the county COPEs have the authority on the Senate and on the legislature to make the recommendations. They are the people who live in the district; they are the people that have to work with this guy. So we go along pretty well with the county COPEs. If we took the position of overriding them, the first thing you know, they would disintegrate, because there would be no reason for them to have a county COPE because the Executive Board of the State Fed. would be overruling them.

"In the position of San Francisco, you have the legislature and you have the Senate. These people are going to have a meeting and they will come up with their recommendations later. And if you fellows will take note, in the stuff that you were given you will see that there is always a wrap-up motion made on this floor that gives the Executive Board and the county COPEs a chance to change their minds. That's where it is "Open." With the county COPEs and the Executive Board we can endorse different people.

"In the City and County of San Francisco we know that we have a lot of labor friends in both the legislature and the Senate. It was a little bit tough for us to put this "Open," but we feel that, the county COPE having not acted, we should not take away their thunder, and should give them a chance to do what they thought was right.

"So, therefore, if we go along with the Executive Board's report in a wrap-up motion, you will find that San Francisco

will have a chance to take care of their own business and be supported by the Executive Council.

"Therefore I am for the recommendation of the Executive Board and hope that everyone will vote for it."

Gerald L. Pickle, Electrical Workers No. 6, San Francisco; Dan Jackson, Teachers No. 61, San Francisco; and Jackie Walsh, Waitresses No. 48, San Francisco, spoke in support of the motion to accept the Executive Council's "Open" endorsement.

The motion carried.

Vice President Small then moved adoption of this portion, as amended, as a whole.

The motion carried.

### State Assembly

Vice President Small read the Executive Council recommendations for California State Assembly:

#### District

Smith, Marin County COPE, spoke in opposition, all indicating that the involved COPEs and Councils had met late and agreed on their desired endorsement of Frank Belotti (R).

The motion to accept the Executive Council recommendation of "Open" endorsement was lost.

Delegate Matzen then moved that the Convention endorse Frank Belotti (R), for District No. 2. Delegate Smith spoke in support.

The motion carried.

## District No. 10

Vice President Small moved adoption of the endorsement recommendation of the Executive Council for District No. 10, of William S. Dickinson (D); "No endorsement" for Republican; and "No endorsement" for AIP.

Art Carter, Contra Costa County Central Labor Council, Martinez, spoke in support.

William Nelligan, Communications Workers, San Francisco, spoke in opposition.

The motion carried.

## District No. 26

Vice President Small moved adoption of the Executive Council's endorsement recommendation for District No. 26, of Marshall Mayer (D), and Carl A. Britschgi (R).

Jerry Goldberg, Los Angeles Newspaper Guild, who had requested the delay on this vote, said he no longer had any opposition to the endorsement.

The motion to accept the recommendation was passed.

## District No. 29

Vice President Small moved acceptance of the endorsement for Horace Mas-

sey (D), for District No. 29.

There being no objection, the motion carried.

### **District No. 33**

Vice President Small moved adoption of the recommendation of "No endorsement" for District No. 33.

There being no discussion, the motion passed.

### **Adoption of Assembly Recommendations**

On motion of Vice President Small the Assembly recommendations of the Executive Council were adopted as amended.

### **Entire Report Adopted As Amended**

On Vice President Small's motion, the Convention then adopted, as amended, the Executive Council's report as a whole.

### **Final Authorization Motions**

On motion of Vice President Small the Convention then adopted the following authorization, that "wherever and whenever an office is left 'Open' on the action of this Convention, the Secretary-Treasurer, subject to the approval of the Executive Council, shall be given full power to act and to make endorsements after consultation with the local COPEs, if any, where they exist."

Vice President Small then moved that "the Executive Council be authorized to withdraw the endorsement of any candidate should his actions be detrimental to the labor movement."

Richard G. Houdek, Newspaper Guild No. 69, Los Angeles, rose to urge that any group making or withdrawing endorsements consider the candidate's stand on AB 426, the anti-strikebreaker bill.

Thomas W. Mathew, Building & Construction Trades Council of Orange County, spoke in opposition to the motion.

The motion carried.

### **Memphis Strikers**

Emerson Street, Central Labor Council, Santa Clara County, moved that the Convention go on record in support of the Memphis (garbage) strikers and of send-

ing a wire to the Mayor of Memphis, Tennessee, urging him to settle with the strikers.

President Gruhn ruled the motion out of order, as it did not relate to the subject matter of the Convention.

Victor J. Lazzaro, Retail Clerks No. 428, San Jose; and Leonard Levy, Amalgamated Clothing Workers, Los Angeles; objected to the ruling.

President Gruhn then read to the Convention, in support of his ruling, Section 3 of Article XII, D, of the Constitution, Rules and Order of Business of the California Labor Council on Political Education, as follows:

"Nothing which properly can be the subject matter for action by a convention of the California Labor Federation, AFL-CIO may be included within any resolution or proposed constitutional amendment submitted to a convention of the California Labor COPE, nor made the subject matter of discussion or motion from the floor of the convention."

Russell Crowell, Cleaners & Dye Workers No. 3009, Oakland, rose to challenge the ruling of the chair.

With Vice President Dias presiding, President Gruhn re-read the section of the Constitution upon which his ruling was based.

Delegate Crowell stated his position.

Vice President Dias called for a Convention vote on upholding the decision of the chair.

The President's ruling was upheld by the Convention.

Harry Bloch, Clothing Workers, wished to pursue the matter, but was ruled out of order.

C. L. Dellums, Sleeping Car Porters, Oakland, then moved that the Convention request the Executive Council to ask the California Labor Federation to take emergency action on behalf of the Memphis strikers and notify the City of Memphis of its feeling on the matter.

The motion, duly seconded, was carried.

### **Report of Committee on Constitution**

**Wilbur Fillippini, Chairman**

President Gruhn then called on the Committee on Constitution, whose Chairman, Wilbur Fillippini, reported that the

committee had met, but there had been no resolutions submitted to it, so there was no business to present to the Convention.

On the Chairman's motion, this report was accepted.

# REPORT OF SECRETARY-TREASURER

To the 1968 Pre-Primary Convention of the California Labor Council on Political Education:

## GREETINGS!

In the year and a half since the wind up of the 1966 general election campaign, the period covered by this report, the impact of conservative victories in that off-year election have become painfully clear.

In California the impact of conservative gains in 1966 was made all the more drastic by their capture of the corner office in Sacramento. Look at the results:

- A billion dollar tax hike.
- Appointment of an employer as state labor commissioner who is intent on discouraging the submission of wage claims by victimized workers.
- Revival of the compulsory open shop fight.
- Gubernatorial appointments that stack certain state agencies.
- A legislative stalemate on needed improvements in the state's social insurance programs to modernize the programs themselves and bring benefit levels in line with increases in wage levels and the cost of living.
- Emasculation of the Office of Consumer Counsel.
- Assaults on those elements in our population least able to defend themselves, represented by the slashes in funds for the mentally ill, crippled children, the aged and the blind.
- And, among other things, an insistent attempt by the Governor himself to narrow higher educational opportunities for our youth by ending California's traditional tuition-free policy, a move that boils down to an added tax on trade unionists and other citizens with college-bound sons and daughters.

While by no means exhaustive, this is representative of what happens when the function and emphasis of government is shifted from meeting the needs of the people to meeting the needs of the business community at the expense of the peoples' needs.

Now let's face it. The record of the past 18 months serves as a forewarning of the giant backward steps that the conservative forces in this state might effect

if they gain control of both houses of the legislature next November.

As trade unionists, I am sure we are all acutely aware—perhaps more so than any other organized group in the nation—that the character, quality and quantity of legislative accomplishments are directly related to the quality of the legislators we help elect.

We know too that special interest groups can and do muster vast monetary resources to attempt to erode, blunt or thwart successes that progressive forces score at the polls.

In recognition of this, the California Labor Council on Political Education has been engaged, as the body of this report will attest, in a two-pronged program to strengthen organized labor's political arm: First, by assisting in the activation of energetic COPE units at every level—local union, county, district and regional—functioning on a year-round basis; and, second, by informing local union members, their officers and central body officials of the operational details of COPE's program.

But before delving into these and other issues in detail, let's understand that this election year all California workers have their backs to the wall.

A conservative takeover of the legislature would give major and perhaps effective impetus to the compulsory open shop drive already afoot in California. And the newly apportioned Congressional districts represent in some cases an opportunity for conservatives to further weaken the chances for passage of progressive legislation at the national level.

This must not be allowed to happen.

Despite the general disarray of liberal forces, California Labor COPE pitched in vigorously and energetically in support of COPE-endorsed candidates. And there is substantial evidence that it contributed significantly to minimizing liberal losses.

For example, Alameda County COPE, recognizing the reality of the challenge facing Rep. Jeffrey Cohelan, called on State COPE for a special mailer in Cohelan's behalf in the primary. The mailer went to all registered voters in the 7th Congressional District. Cohelan won by less than 7,000 votes. Without the mailer, there is ample reason to believe the 7th Congressional District seat could have been lost to a conservative in the general election.

Special efforts were made in the campaigns of some races around the state.

In preparation for the general election of 1966, California Labor COPE produced the following publications and put them into the hands of voters throughout the state:

- More than 1.6 million general election endorsement pamphlets carrying labor's recommendations for statewide as well as district offices. These pamphlets were printed and distributed in 16 variations to accommodate major areas of the state and to facilitate the identification of district office endorsements by union members and their families.

- Two 8-page tabloids spelling out the issues involved in the election and containing a county-by-county breakdown of COPE's recommendations were produced and published by California Labor COPE and mailed 30 days apart to 1,300,000 AFL-CIO union members throughout the state.

- Special tabloid mailers were also published and distributed by California Labor COPE in a number of marginal Congressional, State Senatorial and Assembly Districts.

- 500,000 copies of Applications for Absentee Ballots were distributed to local and county COPE's.

- Poll cards—handy, pocket-sized 3 x 5 cards—containing COPE recommendations for statewide, Congressional, State Senate and Assembly District contests as well as its recommendations on state propositions and local COPE recommendations on local issues were developed for each of the 30-odd COPE jurisdictions in the state and distributed to local central bodies for distribution.

- To assist editors of local, national and international union publications with their pre-general election editions, California Labor COPE developed both a clip sheet spelling out the issues in stories, cartoons, pictures and line drawings. It also published and distributed a special two-page magazine article titled "California at the Crossroads—the '66 Election Battle." The latter was designed primarily for international union and district council publications that come out in magazine form.

- A cartoon service was provided for the labor press and a special supplement in the California AFL-CIO News was devoted to campaign issues for 10 weeks prior to the general election.

As in the past, California Labor COPE

also helped coordinate major registration and get-out-the-vote campaigns by local COPE organizations throughout the state.

On an overall basis, despite the strong conservative tide both in California and throughout the nation, 92 of the 152 California Labor COPE endorsed candidates won election, a victory margin of 61 percent.

In congressional district races, COPE candidates won 21 of 37 seats in which endorsements were made, a victory margin of 62 percent. Three incumbent Democrats were defeated, reducing the Democratic margin in California's congressional delegation from 24-14 to 21-17. Democratic Reps. Harlan Hagan, Ronald Brooks Cameron and Ken Dyal of the 18th, 25th and 33rd congressional districts, respectively, were replaced by Reps. Robert B. Mathias, Charles E. Wiggins and Jerry L. Pettis.

In the State Senate, which the Democrats had controlled by a 25-14 margin with one vacancy before the election, the Republicans picked up five seats to slice that margin to 21-19. Due to reapportionment, all 40 seats in the State Senate were at stake and COPE endorsements were made in 36 races. Of these, 20 COPE-endorsed candidates won, a margin of 56 percent.

In the Assembly the Democrats' margin dropped from 48-31 with one vacancy to 42-38.

California Labor COPE made 69 endorsements in the 80 State Assembly contests, winning in 46 districts for a victory margin of 67 percent.

During the pre-primary campaign period immediately ahead, local COPE officers should bear constantly in mind the aim of building and maintaining a functioning year-round organization. Such an organization can prove invaluable in the brief period of time generally available for mounting special election campaigns.

The need for a vigorous effort at the local level to expand COPE dollar drives was reflected in the boasts of the virulently anti-labor John Birch Society immediately after the 1966 election.

Writing in his December 1966 bulletin to his members, the society's autocratic leader, retired candymaker Robert Welch, said that the "sharp change in the California political climate during the last very few years was due in large part to the untiring educational work of thousands of members of the John Birch Society."

While the society claims that it took no part or position in the campaign, Welch disclosed that the society "had chosen California as a state in which to concentrate practically from the beginning" and said that "as a rule about 15 percent of the total field staff we could afford, and hence at least 15 percent of our total membership, has been in California."

Since estimates of the society's 1966 income ranged between \$12 and \$26 million, application of the 15 percent factor to the society's financial resources means that the Birchers plunked somewhere between \$1.8 million and \$3.9 million into their propagandizing efforts in California during 1966.

Since Welch and a number of his followers have appeared both in California and throughout the nation on right wing radio and TV interview programs repeatedly during 1967 and earlier this year, it is doubtful that reports that the J.B.S. is losing strength amounts to much more than wishful thinking.

It is clear, however, that the Society is anti-worker, anti-union and anti-labor. It

has repeatedly propagandized against the broad social goals of the AFL-CIO, against repeal of Section 14b of the Taft-Hartley Act and actively promoted such extremist ideas as dismantling the United Nations, abolishing the progressive federal income tax and impeaching Chief Justice Earl Warren.

Articles suggesting the J.B.S. is just a conservative group are simply misleading.

It was several years ago now that Welch made his spurious charge that former President Eisenhower was a "conscious agent of the Communist conspiracy." But just last year Welch claimed that the United States is "60 to 80 percent Communist controlled," a charge that is as outrageous and insidious as it is untrue since it fans the flames of disension in our nation at a time when we need unity most.

Moreover, the Birch Society, which openly admits it has adopted Communist infiltration techniques to achieve its goals, is only one of a host of similar extremist groups on both the right and left sides of the political spectrum that have proliferated in recent years largely by feeding on ill-founded rumors.

Every trade unionist, indeed every California worker, has a vital stake in protecting his community, his state and nation from this insidious assault. It is therefore essential that we redouble our COPE dollar drives at the local level during the forthcoming campaign.

In recognition of the mounting threat the conservative coalition poses to California workers, your secretary-treasurer directed Assistant State COPE Director Fred C. Smith to organize a series of California Labor COPE workshops early this year to assure a running start on the forthcoming campaigns.

The chief function of the workshops was to assure a thorough understanding at the county level of the manner in which data processing is being implemented to improve the labor movement's political efforts. However, the workshops also included a general discussion of pre-primary endorsement procedures and a step-by-step discussion of the essentials necessary to develop an effective, fully implemented voter registration program.

While they were designed primarily for local union and central body officers, they were open to all interested trade unionists.

Early in 1967, a new approach to the data processing problem was initiated

with the decision to seek the membership lists directly from international unions rather than attempting to collect them on a county-by-county basis from each of the local unions involved.

The success of this new approach is reflected in the fact that well in excess of half a million names of California AFL-CIO trade unionists are now stored in the computer ready to assist local COPEs in their registration, education and get-out-the-vote efforts not only in primary and general elections but also in municipal or school district elections where issues vital to trade unionists and their children are often at stake.

In 1967 National COPE departed from its previous pattern of holding area conferences every year. Instead it decided to hold the area conferences in 1968 and in future even-numbered years when federal elections are held, but to hold a broader type conference during the off years.

Accordingly, a two-day COPE meeting was held at the Sheraton-Palace Hotel in San Francisco on April 15-16 immediately following the April 14 meeting of State and City Central Body Officers.

Union officials from the following states participated: California, Oregon, Washington, Idaho, Wyoming, Utah, Colorado, Arizona, New Mexico, Alaska, Hawaii, Montana and Nevada.

In workshop sessions, the participants explored ways of building strong political relationships between state and local central bodies; improving techniques and tools to communicate with both new members and younger members; and developing new organizations to reach union members living in the suburbs.

The participants also discussed the problems and potentialities of the COPE data processing program.

On Sunday, March 10, 1968, California Labor COPE participated in National COPE's four-state area COPE conference at the Jack Tar Hotel in San Francisco. At this conference National AFL-CIO COPE Director Alexander E. Barkan warned that the revival of the GOP-Dixiecrat coalition that resulted from conservative successes in 1966 has led to the introduction of bills in Congress that are aimed "at the American worker's jugular vein."

Citing such measures as HR 333 which would destroy industry-wide bargaining by clamping anti-trust laws on unions, and S 1353 that would abolish the Na-

tional Labor Relations Board and replace it with a so-called "Labor Court" which, if dominated by conservative jurists, could shackle or muzzle valid union efforts for years, Barkan said every trade unionist must understand the threat that such legislation poses to him.

Other anti-labor measures already pending in Congress that could stand a good chance of passage if the conservatives pick up another 20 or 25 congressional seats include:

- **S 1744** which would outlaw multi-union bargaining by a group of unions with the same employer, a measure that would render unions practically helpless in the face of huge corporations that manufacture or provide services in many diverse fields.

- **S 79** to impose compulsory arbitration, thereby stripping workers of their right to strike and encouraging employers to refuse to bargain in good faith.

- **S 1880** and **HR 11233** which are aimed at barring National COPE or any other international union from collecting voluntary contributions from union members to support endorsed candidates for the U. S. House and Senate.

- **S 22** to prohibit card checks and other informal methods of determining whether a union is a choice of a majority of employees in a bargaining unit. Such a measure would make many representational elections both costlier and unnecessarily more time consuming.

It is the hope of National COPE, Barkan said, "that every union will get out its own literature to spell out the meaning of the anti-labor legislation currently pending in Congress in terms of what it would mean to their own membership from the standpoint of their contract if a conservative President and a conservative Congress is elected."

As an example, he pointed out that General Electric workers got the best contract they ever had through multi-union collective bargaining but that the Thurmond Bill (S 1744) would outlaw such an approach.

## ELECTION CODE CHANGES

Among the more significant changes effected in the state's Election Code dur-

ing the 1967 legislative session were the following:

**AB 190** permits a hospitalized voter to apply for and return an absent voter ballot no later than the closing of the polls and deletes the requirement that the date of admittance of voter be included in statement of official of hospital, sanatorium or nursing home.

**AB 596** excludes firemen who serve as deputy registrars from Section 201 of the Election Code which requires officers or employees of a local agency who become deputy voter registrars to turn over their compensation to the local agency.

**AB 870**—permits naturalized citizens to prove naturalization by sworn statement of the date and place of their naturalization rather than by certificate of naturalization or certificate of registration in county of last residence in the state.

**AB 893** provides that any county in which tabulating equipment is used to produce the indices of registration, the indices shall be furnished to persons, committees and agencies as provided in the article by street addresses in numerical order but that such indices may be maintained in alphabetical order. It further stipulates, however, that indices posted at the polling place and furnished to others shall be by street addresses in numerical order.

**SB 187** establishes uniform voting hours by requiring all polls to open at 7 a.m. of the day of any election, including any primary election, and to be kept open until 8 p.m. of the same day when all polls shall close.

**SB 1137** provides that in those counties having data processing cards or magnetic tape, copies of cards or tapes of the complete registration for the June primary, general election and registration after the non-voter purge shall be supplied to the Secretary of State. The Secretary of State to make these tape files available to any person for election or governmental purposes, under conditions prescribed by the Secretary of State.

## FEDERAL AND STATE ISSUES GUIDES

To assist all county, district, and regional COPE organizations in the interviewing process, California Labor COPE developed extensive Issues Guides designed to provide some inkling of each candidate's views on social and economic

policy matters critical to the well-being of California workers.

## **OTHER SERVICES TO LOCAL COPEs**

To help keep local and district COPEs abreast of changes in the Election Code and fluctuations in registrations in the various Congressional, State Senate and Assembly Districts with which they're concerned, California Labor COPE has also made a point of acquiring state publications such as the various reports on voter registration and the election calendar and distributing these to all COPE jurisdictions throughout the state.

It has also, of course, continued to service local COPE requests for research and information and, as in the past, maintained a library of films available to

COPE units throughout the state. It might be mentioned here that 10 copies of the most recent national COPE film, a 15-minute Filmograph, titled "1968—Labor's Year of Challenge," which depicts the issues critical to workers in the current campaign are currently available from California Labor COPE's San Francisco office. It is hoped that these films will enjoy extensive use during the forthcoming campaign.

In conclusion it should be emphasized that both as citizens and trade unionists we share not just the problems of our state and nation but the responsibility to help solve them. Time has taught us repeatedly that we can do this best through unity.

We have examined the statement of cash receipts and disbursements of the CALIFORNIA LABOR COUNCIL ON POLITICAL EDUCATION for the two-year period ended January 31, 1968. Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

Cash receipts as recorded were found to have been deposited regularly in the bank. Disbursements were evidenced by paid canceled checks on file which we compared with the cashbook entries as to payees and amounts, and scrutinized as to signatures and endorsements. Disbursements were either supported by voucher or approved for payment by the Secretary-Treasurer.

The commercial account with Bank of America N.T. & S.A. and savings accounts on deposit were reconciled with statements and passbooks on file for the period under review. The balances on deposit in these accounts at January 31, 1968 were confirmed by correspondence with the depositaries.
