The 1973 session of the State Legislature was a great legislative year for working men and women in California.

Increased social insurance benefits enacted this year, coupled with those of two years ago, add up to the largest advance in the sixty-year history of the state's programs. Other measures, too, sharply improved the interests of working men and women.

In all, the year's achievements are fresh evidence that labor's legislative program speaks, not only for the interests of union members, but for the general welfare of all Californians.

Labor-sponsored legislation enacted in 1973 by the State Legislature and signed into law by Governor Ronald Reagan is expected to add at least \$117,000,000 a year to the benefits already being paid nearly a million jobless, injured, or ill workers.

More millions of California workers, in unions and out, will benefit, too, from the measurably broadened protection afforded them by the labor-initiated improvements in the state's social insurance programs.

*In all, the social insurance improvements enacted in the past two years are expected to put an additional quarter of a billion dollars a year into the hands of California workers who are unemployed, injured, or ill.*

No past Legislature has passed, nor has any previous governor signed, legislation of such scope.

This year's record is further brightened by the enactment of several labor-supported measures representing fresh advances in social and economic responsibility. Not the least of these was an act (AB 478)—Brown) extending the authority of the State Industrial Welfare Commission to establish standards of hours and working conditions for men. The California Labor Federation succeeded in winning extension of the state minimum wage to men during the 1972 legislative session.

In all, fourteen major measures proposed by the California Labor Federation were written into law. Six others were vetoed; six were defeated in legislative committees. When the Legislature returned in January, 1974 for the second half of its two-year session, it faced thirteen Federation-proposed bills still enmeshed in the legislative process.

Credit for this year's achievements, as for those of the past, go first of all to the 1,600,000 sponsors of the Federation's legislative program—the 1,600,000 members of the AFL-CIO in California. They supported the political education activities that played a major role in electing Democratic

majorities in both houses of the Legislature. Their support opened the way for liberal leadership in both houses who recognized the merit of labor's program and the value of our backing. Their support, too, makes possible the Federation's part in spearheading and coordinating labor's legislative activities.

Labor's successes this year, as always, owe much to the cooperation and support of the officers and members of local unions, of the state's city and county central bodies, and to international union regional organizations and their representatives. They responded effectively to the Federation's legislative "alerts" and provided sturdy "hometown" support for its on-the-spot efforts.

A majority of the members of the Legislature have demonstrated their understanding and support of labor's program. And, though organized labor has many grave differences with Governor Ronald Reagan, we acknowledge his recognition of the merits of labor's proposals for improving the state's social insurance programs. Particular thanks for the success of the program are also due Assembly Speaker Bob Moretti and Senate President pro tem James R. Mills.

# Enacted

In 1973, labor's legislative efforts produced these results:

## **I. Workmen's Compensation—Weekly Benefit Maximum—Temporary Disability**

Weekly maximum increased from \$105 to \$119.

Effective date of new benefit April 1, 1974.

*The new maximum represents an increase of 36 percent from the 1971 maximum of \$87.50.*

**2. Workmen's Compensation—Weekly Benefit Maximum—Permanent Disability**

Weekly maximum increased from \$70 to \$119.

Effective date of new benefit April 1, 1974.

*The new maximum represents an increase of 126.6 percent from the 1971 maximum of \$52.50.*

**3. Workmen's Compensation—Death Benefit—Widow Only**

Total payment increased from \$25,000 to \$40,000.

Effective date of new benefit January 1, 1974.

*The new benefit represents an increase of 100 percent from the 1971 amount of \$20,000.*

**4. Workmen's Compensation — Death Benefit — Widow with Dependents**

Total payment increased from \$28,000 to \$45,000.

Effective date of new benefit January 1, 1974.

*The new benefit represents an increase of 95.6 percent above the 1971 level of \$23,000.*

**5. Workmen's Compensation Benefit—Waiting Period**

The waiting period for workmen's compensation disability benefit payments is cut from seven (7) to three (3) days.

*Effective April 1, 1974, payment starts on fourth day.*

**6. Workmen's Compensation Benefit—Retroactive Waiting Period**

The retroactive waiting period is reduced from twenty-eight (28) days to twenty-one (21) days.

Effective date of new benefit April 1, 1974.

*Payments will be made retroactive to the first day if the employee was unemployed due to disability for 21 days.*

## **7. Unemployment Insurance—Maximum Weekly Benefits**

Weekly maximum increased from \$75 to \$90 a week.

Effective date of new benefit January 6, 1974.

*The new maximum benefit represents an increase of 38.4 percent from the 1971 maximum of \$65.*

## **8. Unemployment Insurance—Eligibility—Substandard Employment Referral**

An unemployed worker shall not lose eligibility for unemployment insurance because of his refusal to accept employment with an employer who does not meet minimum standards of licensing, provide UI and W/C coverage, or if it would interrupt the worker's rehabilitation program.

Effective date January 1, 1974.

## **9. Unemployment Disability Insurance—Weekly Benefit Maximum**

Weekly maximum increased from \$105 to \$119 for disabilities occurring after effective date.

Effective date of new benefit April 1, 1974.

*The new maximum represents an increase of 36 percent from the 1971 maximum of \$87.00.*

## **10. Unemployment Disability Insurance—Pregnancy Benefits**

Disability benefits will be paid if a doctor certifies that the pregnancy involved abnormal complications or disabling conditions.

Effective January 1, 1974, benefits are payable for up to 26 weeks.

## **11. Unemployment Disability Insurance—Wage Credits**

A freeze on wage credits for disability benefits to protect injured or disabled workers.

Effective date January 1, 1974.

## **12. Unemployment Disability Insurance—Eligibility— Seamen**

Unemployment disability benefits shall not be reduced by payments received under maritime doctrine of maintenance and cure.

Effective date of new benefit was June 12, 1973.

## **13. Extension of IWC's Hours and Conditions Authority to Men**

Industrial Welfare Commission authorized to establish hours and working conditions for men as well as for women and minors.

Effective date of IWC orders, March 1, 1974.

## **14. Revision of Law on Tip Credits**

Prohibits employer from taking or receiving tips or from requiring employee to credit such tips against wages unless, per IWC rules, the employee regularly receives more than \$20 per month in tips in which case the employer may credit a maximum of 25 cents per hour against the minimum wage if such action is specified by public notice.

*Employer no longer allowed to take all tip money.*

# **Vetoed**

These measures were vetoed by Governor Ronald Reagan:

- Extension of unemployment insurance to farm workers.
- Extension of workmen's compensation to newsvendors and liberalization of coverage for domestic workers and gardeners.



- Free choice of physician for workers injured on the job.
- Collective bargaining rights for teachers.
- Repeal of Stull Act provisions regarding teacher evaluation.
- Requirement that firms advertising as doing business in Spanish must provide customers contracts in Spanish as well as in English.

# Pending

The following labor-backed proposals are in process. Further action is expected after the Legislature returns in January:

- Prohibiting professional strikebreakers (SB 273—Roberti. In Senate.)
- Prohibition of injunctions solely on evidence supplied by one party. (AB 401—Boatwright. In Assembly Labor Relations Committee.)
- Collective bargaining and agent selection for public employees. (AB 485—McCarthy. In Assembly Labor Relations Committee. AB 1243—Moretti, guaranteeing public employees the right to organize and bargain collectively, passed the Assembly 42-30 and has been referred to Senate Public Employment and Retirement Committee.)
- Including tips as wages for computing unemployment and disability insurance. (AB 736—Ralph. Passed by Assembly 52-16. Recommended do pass by Senate Industrial Relations Committee and referred to Senate Finance Committee.)
- Increasing exemption for casual earnings for unemployment insurance purposes from \$12 to \$25 a week. (AB 738—Ralph. Passed Assembly 67-1. Senate Industrial Relations Committee recommended do pass and bill referred to

Senate Finance Committee.)

- Providing dependency benefits under unemployment insurance. (AB 739—Ralph. In Assembly Finance and Insurance Committee; subject matter referred to Assembly Rules Committee.)

- Restricting contracting-out industrial homework. (AB 755—Montoya. In Assembly Labor Relations Committee.)

- Requiring rehabilitation in workmen's compensation cases. (AB 760—Brown. Passed Assembly 69-0. Recommended do pass by Senate Industrial Relations Committee and referred to Senate Finance Committee.)

- Requiring preparation of economic impact report when environmental impact report required. (AB 938—Warren. Passed Assembly 56-14. Recommended do pass by Senate Local Government Committee and referred to Senate Finance Committee.)

- Creating a State Planning Council comprised of labor, business, public members. (AB 2214—McCarthy. Held for interim study in Assembly Planning and Land Use Committee.)

- Providing state collective bargaining statute for certain workers not covered by National Labor Relations Act. (AB 2107 — Berman. In Assembly Labor Relations Committee.)

- Repealing requirement for advance voter approval for public housing (ACA 40—Brown).

# Defeated

The following measures were defeated by committee action; committee votes are recorded starting on pages 12 and 19.

- Requiring representation on the Unemployment In-

Insurance Appeals Board. (AB 737—Ralph. Defeated in Senate Industrial Relations Committee.)

- Preventing disqualification for unemployment insurance benefit if employment fee is charged. (AB 741—Ralph. Defeated in Assembly Ways and Means Committee.)

- Requiring labor representation on Workmen's Compensation Appeals Board. (AB 761—Brown. Passed Assembly 56-14. Defeated in Senate Judiciary Committee.)

- Banning employer use of lie detector tests. (AB 830—Warren. Passed Assembly 43-15. Defeated in Senate Judiciary Committee.)

- Creating a state Ombudsman. (SB 130—Mills. Recommended do pass by Senate Governmental Organization Committee; defeated in Senate Finance Committee.)

- Requiring prevailing rates to be paid for public printing by state government. (AB 849—McAlister. Passed Assembly 52-10. Defeated in Senate Governmental Organization Committee.)

# Shelved

The following measures are being held in committee without recommendation, in effect shelving or sidetracking the bill for the current session. While it may be technically possible to revive these measures, it seems unlikely.

- Establishing a state Fair Labor Standards Act (AB 571—Alatorre).

- Prohibits tuition at the University of California and the state university and colleges (ACA 47—Meade).

- Provides class-action law suits (SB 571—Beilenson).

- Providing for mandatory employer wage and fringe benefit deposits (SB 740—Marks).

20. AB 810—Deddeh. Freezes wage credits for disability benefits in order to protect injured or disabled worker. Passed, re-referred to Finance 4-0, August 30.
