INTRODUCTION

This compilation has been prepared as a working paper for use in the group discussion on collection development for labor materials. It is neither a comprehensive nor a polished product, but is intended to provide a sampling of the types of specialized selection/acquisition aids and sources of information that have been found useful in developing labor collections. It is focused on the acquisition of materials that are not regularly listed in the standard bibliographical tools, so scant attention is given to sources listing only regular trade books. No selection criteria are included in this paper, since these will vary widely, depending upon the size and type of library; size of staff, budget and space allocated to the labor collection; the clientele to be served, etc.

Greatest emphasis is given to aids for the selection/acquisition of materials about the labor movement, labor history, union activities and publications. Bibliographical tools for selection of publications on industrial relations, the collective bargaining process, etc., are not specifically covered, although many of the references cited are useful aids for developing collections in these related subject areas. The general and standard bibliographical tools and selection aids which librarians use regularly are not, for the most part, included in this bibliography unless they have special sections on labor publications or features of special value. Also excluded are catalogs and selection/acquisition aids for documents (except ILO) and for audio-visual materials. It should be kept in mind, however, that all these can be of use in selection of labor materials. Since few libraries develop extensive foreign labor collections, the emphasis has been placed on materials relating to the U.S. and on English language materials.

SOURCES USEFUL FOR SELECTION/ACQUISITION OF CURRENT PUBLICATIONS

The general sources cited in the first part of this section have useful sections on labor and industrial relations. There are, of course, other general sources which the selector should keep in mind, such as the widely used American Book Publishing Record, which lists new books by the Dewey Classification scheme. The 330's section and the history numbers for the geographic areas of interest are likely to include new works of interest. Earlier editions of the works cited here are good selection aids for older materials as well, if no suitable bibliographies are available.

Three of the titles listed below use the American Economic Association classification scheme. Most material related to labor is classed in Section 800, with cross references to other sections where needed.

Economic Books: Current Selections. A Publication of the Department of Economics and the University Libraries of the University of Pittsburgh. Quarterly. Augustus M. Kelley, Pub., 305 Allwood Road, Clifton, N.J. 07012.

Began March 1974. Endeavors to annotate all books appearing in English in the subject area of Economics. Classified arrangement according to the American Economic Association scheme with cross references to secondary classifications. Each book is assigned a letter code, according to the type of teaching or research library for which most appropriate.

International Bibliography of Economics. London, Tavistock Publications; Chicago, Aldine Pub. Co. Annual.

Vol. 21, 1972 published in 1974. Classified subject arrangement with alphabetical author and subject indexes. Section G2, "Labor Problems." Includes books as well as periodical articles and many foreign language references.

Irregular Serials and Annuals: An International Directory. 3d ed., 1974/75. New York, R.R. Bowker, 1974. 989 p.

Section on Labor and Industrial Relations is 9 pages, 3 columns to a page, and includes a sub-section on Labor Unions. It lists a number of government documents, university series, both U.S. and foreign.

Standard Periodical Directory. 4th ed. New York, Oxbridge Publishing Co., inc., 1973. xv, 1916 p.

Section 009 "Labor," is 13 pages long, and Section 009A "Labor Union," is 15 pages long. Lists regularly issued union publications and a number of directories. Limited to the United States.

Ulrich's International Periodicals Directory. 15th ed., 1973/74. New York, Bowker, 1973. xi, 2706 p.

Has 13 page section "Labor and Industrial Relations" which includes titles of labor council papers, followed by a 14 page list of "Labor Union" publications. Gives addresses, prices, etc. Includes foreign publications. Useful for periodical selection.

The three indexes cited below are suggested as general sources of information for new pamphlet material. Although the first and third titles are primarily periodical indexes, both list new books and pamphlets. The first two titles are available in many libraries.

Work Related Abstracts. Monthly: loose-leaf.

Information Coordinators, inc., 1435-37 Randolph Street, Detroit, Mich. 48226.

Includes some books and pamphlets, although primarily a periodical index. Brief annotations. Entries classified under 20 broad categories, with a detailed cumulative subject index. 1 volume per year.

Labor Services

The three companies listed below publish many useful loose-leaf labor and industrial relations services, and weekly reports on specialized labor, labor law, and industrial relations topics. Although these services are not primary sources for information on new publications, they cite some relevant materials very promptly and should not be overlooked as current selection tools if any are received in the library. All are quite expensive.

Bureau of National Affairs, inc., 1231 25th Street, N.W., Washington, D.C. 20037.

Publishes several very useful loose-leaf services on labor and industrial relations, arbitration, etc.; the Daily Labor Report; plus a number of specialized weekly reports such as Construction Labor Report, Government Employee Relations Report, White Collar Report, Union Labor Report. Also publishes books.

Commerce Clearing House, inc., 4025 West Peterson Ave., Chicago, Ill., 60646.

Publishes several loose-leaf labor services, including one on labor arbitration awards. Most emphasize the legal aspects. Also publishes books.

Prentice-Hall, inc., Englewood Cliffs, N.J. 07632.

Publishes several labor and industrial relations loose-leaf services, but not as many as BNA. Also publishes books.

Book Reviews and Book Notes

The periodicals listed in this section regularly review books or contain annotated listings, and many also mention new publications received and contain publishers' advertisements for new books. These are particularly recommended as selection aids for this field, although other journals in the social sciences and history occasionally review books on labor topics and some labor union publications contain an occasional review. Only English language journals are included in this list, but some of them review and/or list foreign language publications. A number of foreign journals listed in the "Labor and Industrial Relations" section of Ulrich contain book reviews. Large libraries with substantial collections of international and foreign labor materials may find some of these worth scanning for selection purposes. Back issues of the periodicals recommended as current selection aids are, of course, useful for selection of older materials.

Most issues include an annotated list of new pamphlets about labor and topics of interest to labor, some published by unions and some by other organizations. Some issues list new books and films.

Signed book reviews 2-3 pages long in addition to a list of books received. Also contains a chronicle of industrial relations in the United Kingdom.

Annotated listing of new and forthcoming International Labour Office publications.

Industrial and Labor Relations Review. Quarterly.
New York State School of Industrial and Labor Relations, Ives Hall, Cornell University, Ithaca, N.Y. 14850.

Each issue has extensive section of signed book reviews, each 1-2 pages long, and a 10-30 page list of "Recent Publications" which is arranged by broad subject. The list includes books, pamphlets, documents and periodical articles on the following topics: labor-management relations, labor economics, labor conditions and problems, labor organizations, social insurance and employee welfare, personnel and human relations. Includes publications on foreign labor and in foreign languages.

A section "Research Notes" contains information, listed by institution, on current research projects in universities, institutes and other research organizations, and government agencies.

Has signed book reviews, usually 1 page or less, and a short list of "Books Received."

Bibliography section has 3 parts: "ILO Publications"; "Book Notes" with half page reviews of new books; and "Books Received" with 1-2 paragraph annotations. Good source for foreign publications.

Journal of Economic Literature. Quarterly.
American Economic Association, 1313 - 21st Ave., South, Nashville, Tenn. 37212.

Contains an extensive section of signed book reviews, an "Annotated Listing of New Books," a "Subject Index of Articles in Current Periodicals," and "Selected Abstracts" [of articles]. All are arranged by the American Economic Association numerical classification scheme. Labor is in section 800.

Journal of Industrial Relations. 3/year.
Industrial Relations Society, c/o Faculty of Economics, University of Sydney, N.S.W. 2006, Australia.

Has signed book reviews, each 1-2 pages long, a section of brief book notes, and a list of books received. Also contains news of the 8 industrial relations societies in Australia.

Has signed book reviews, 2-3 pages in length. Most issues contain "Labor Historians Newsnotes" which includes a section "Archives and Library News," which reports on recently acquired labor history and archival collections.

Brief signed reviews in this British "Magazine of Left Unity." Back cover has list of books received.

Has a few signed book reviews in some issues. A list of selected publications gives source and price if not available from the Department of Labor or U.S. G.P.O.

Signed book reviews are 2-3 pages in length. Each issue has also a several page list of "Publications Received" which includes books, documents, pamphlets, periodical articles in a single subject arrangement. Some foreign publications included. Several monthly news sections can be useful in alerting librarians to important events.

A 4-8 page publication. In most issues a "Current Literature" section provides a selective annotated listing of recent books, pamphlets, articles and documents on public employer-employee relations.

Society for the Study of Labour History. Bulletin. Semi-annual.

Has signed book reviews plus short notices of newly received books. Spring issue contains an annual bibliography. Works in progress are listed.

Acquisitions Lists

Acquisitions lists issued by special libraries or library departments that collect labor materials are very useful sources for information on many types of recent publications. Although most of them include books and documents, they are especially valuable for their listings of a variety of pamphlet and paper bound materials; studies, reprints, etc., from universities and other research organizations; and union publications. Some include a number of foreign publications. Selectors who are developing retrospective collections may find the back issues useful. Most of the acquisitions lists are free, but some limit distribution to specialized libraries. The list below is not comprehensive, but it includes lists from several of the well known special collections.

Includes books, pamphlets, documents and periodical articles on a broad range of subjects. More valuable than the usual acquisition list. Has especially good coverage of foreign and international publications. Cumulative subject indexes add to its usefulness as a source of information for earlier works. Usually available only on subscription.

GENERAL BIBLIOGRAPHIES AND OTHER SOURCES USEFUL FOR SELECTION/ACQUISITION OF OLDER WORKS (U.S.)

The most significant of the older works on labor and unionism in the U.S. are included in one or more of the bibliographies listed below. There are, of course, others. Slobodek's bibliography of California labor history is cited as an example of the regional bibliographies which are available for some states and areas. In addition, the bibliographies and other citations in books and articles about labor and industrial relations are useful sources for titles.

Lovett, Robert W. American Economic and Business History Information Sources. Detroit, Gale Research Co., 1971. 323 p. (Management Information Guide no. 23).

Chapter 4, "Labor History": pp. 185-207.

Lists histories by period and region. Special topics considered separately include Unions, Population, Immigration, the Blacks and Slavery, and Wages.

McBrearty, James C. American Labor History and Comparative Labor Movements: A Selected Bibliography. Tucson, Ariz.; University of Arizona Press [c1973]. ix, 262 p.

List is classified by chronological periods and topical subjects for the American labor history section, and by country designation for the comparative labor movements sections. Books and articles are listed in separate sections. Fictional works are listed alphabetically by author in a special section. There is a single alphabetical author index to the volume.

McCoy, Ralph E., comp. History of Labor and Unionism in the United States: A Selected Bibliography. Champaign, Institute of Labor and Industrial Relations, University of Illinois, 1953. iii, 88 p. mimeo. (Bibliographical Contributions no. 2).

Includes books and selected pamphlets but no documents or periodical articles. Items are listed in a single alphabetical arrangement under author entry. There is a detailed subject index.

Neufeld, Maurice F. A Representative Bibliography of American Labor History. Ithaca, N.Y. [New York State School of Industrial and Labor Relations], Cornell University, 1964. ix, 146 p. (Bibliography Series no. 6).

A classified bibliography, with items arranged by author entry within each classification, and an over-all alphabetical index covering the authors, agencies, organizations, and institutions cited under each classification. Includes a wide variety of types of materials: "books ranging in nature from popular to technical, scholarly monographs, theses, novels, plays, biographies, autobiographies, state and federal legislative investigations, governmental reports, union documents, management publications, and articles from both learned journals and magazines of mass circulation."

Rose, Fred Duane, comp. American Labor in Journals of History: A Bibliography. Champaign, Institute of Labor and Industrial Relations, University of Illinois, 1962. iv, 87 p. mimeo. (Bibliographical Contributions no. 7).

Articles are listed chronologically under the journal titles, which are arranged alphabetically. There is a subject index and a picture index, but no author index.

Skotnes, Andor and Julia Williams Skotnes, comp. American Working-Class History in Historical Journals, 1961-1972: A Bibliography. New Brunswick, N.J., Labor Education Center, Institute of Management and Labor Relations, Rutgers University, September 1974. [4] 75 p. multilithed.

This bibliography is a successor to that compiled by Fred Duane Rose in 1962. Articles are listed chronologically under the journal titles, which are arranged alphabetically. There are three alphabetical indexes: author, subject and photo.

Slobodek, Mitchell. A Selective Bibliography of California Labor History. Los Angeles, Institute of Industrial Relations, University of California [c1964]. x, 265 p.

Subject arrangement, with an author-title index.
Example of a regional bibliography.

Stroud, Gene S. and Gilbert E. Donahue, comp. Labor History in the United States: A General Bibliography. Urbana, Institute of Labor and Industrial Relations, University of Illinois, 1961. 167 p. (Bibliographical Contributions no. 6).

A selective bibliography of books, pamphlets, government documents and a few journal articles all listed in a single alphabetical arrangement under author entry. There is a detailed subject index. This bibliography does not completely supersede the 1953 bibliography compiled by Ralph E. McCoy.

Seven annual bibliographies of periodical articles on American labor history have been published in issues of Labor History. These serve as a guide to articles which include citations to historical works on the subject of the article. Bibliographies of 1970 and 1971 articles were not published.

Reprint Editions and Microform Collections

LABOR UNION PUBLICATIONS (U.S.): AIDS FOR SELECTION/ACQUISITION

Since labor union and employee association publications usually have to be requested/ordered from the union or other organization publishing them, directories with names and addresses are important tools. Some directories give titles of the labor union papers in addition to other information. Lists and directories of union periodicals and labor press serials are also useful. Older editions of current directories and lists may be used to identify older titles. The list in this section includes also several sources for information about older union publications and location of files of them.

The AFL-CIO and many of the larger unions with research and/or education departments issue excellent studies in addition to brief statements of positions on current issues, and publications and aids designed for use of the membership. The AFL-CIO and some of its departments issue lists of their publications, as do some of the individual unions. New union publications as well as other publications on labor subjects are sometimes mentioned in union papers. The more important union publications are also listed in some of the general sources for information about publications on labor listed in Sections I and II. The "Recent Publications" section in Industrial and Labor Relations Review and the acquisition lists from industrial relations and labor libraries are excellent sources. Many of the union papers and other publications are free, but an increasing number of unions are now charging libraries regular subscription rates for their papers due to the increased mailing costs.

Since a large percentage of the union publications are not listed in the regular trade bibliographies and general selection tools, specialized sources of information must be used by those developing sizeable labor collections in order to learn what is being published, and by whom. Some unions will place libraries on their mailing lists to receive their papers and perhaps other publications as well, when requested to do so. However, individual requests for specific non-serial publications are usually necessary. University industrial relations librarians report that personal contacts by members of the institute staffs have proved an excellent way of obtaining union publications, especially those of local unions. Personal contact is sometimes the only way to obtain local publications. Information about publications of the national unions and employee organizations is more available than about state and local union publications. For many areas there are no directories of local unions, and in some states there is no comprehensive state directory, so that even a listing of unions and addresses is sometimes difficult to locate.

Identifying independent unions with members in a single company (or just a few) is particularly difficult, and may depend upon personnel knowledge. There are occasional lists of such unions. For example, the U.S. LMSA Register of Reporting Labor Organizations, 1971, which is cited at the end of this subsection, has as the last section under each state a listing by city of "Unaffiliated Labor

Organizations," which includes some one-company unions. Some such unions may be included in state or local lists of unions, or there may be regional lists of independent unions. Or, a professional organization may compile a list of unions representing employees in that profession or occupation. The National Society of Professional Engineers publishes such a list every few years (cited below). Practices vary, and lists are apt to be incomplete.

Union Directories

In addition to the general information sources listed in the first section of this bibliography, and the few specific sources listed in this section, the availability and usefulness of some of the following sources for identifying unions in one's geographical area may be investigated.

State directories of labor unions and labor councils. In some states such directories are published by the state labor or industrial relations department, by the state labor federation, or occasionally by a university labor or industrial relations center. Some directories include the titles of labor union papers.

State labor federation convention proceedings. If there is no state directory of labor unions, there may be a list of affiliated unions in the convention proceedings; or from a roll of delegates a partial list of unions can be compiled.

Local union directories. Some local or regional labor councils publish such directories.

Labor papers published by union councils usually carry meeting notices and news notes of activities of affiliated locals. A partial listing of labor unions may be compiled from this source.

Local directories of businesses and organizations sometimes include a listing of labor unions.

Telephone book. The classified section sometimes has a partial listing of union offices under "Labor Organization," or a similar heading.

Includes address, telephone number, and name of President and/or Secretary-Treasurer. Does not give titles of union papers.

International Labor Directory and Handbook, 1955. Ed. by Jack Schuyler. New York, Praeger [c1955]. xix, 1043 p.
1950 edition published under title: International Labor Directory.

Introductory section, "Survey of World Labor" consists of articles on labor's status as of 1955. The Directory forms major part of volume and lists unions in every part of the world, related organizations and individuals concerned with the labor movement. Basic arrangement of the Directory is by country. For the U.S., in addition to the national unions, the state and/or regional councils are listed as are many locals, with officers' names and addresses. Old but useful for identification of earlier unions and locals.

Example of a state directory.

Example of a specialized list. Includes independent and single-company unions.

Rutgers University. Institute of Management and Labor Relations. Directory of Labor Unions in New Jersey. [New Brunswick] May 1971. vi, 92 p.

Example of a state directory.

San Francisco Labor Council (AFL-CIO). Directory. Annual. 3068 - 16th Street, San Francisco 94103.

Example of a directory of local unions.

List of Departmental Councils, Trade Councils and Local Unions affiliated with the San Francisco Labor Council. Gives address, telephone number, name of one officer, date of meeting.

U.S. Bureau of Labor Statistics. Directory of National Unions and Employee Associations, 1973. Washington, U.S.G.P.O., 1974. vi, 156 p. loose-leaf.

Published biennially. This is first edition in loose-leaf format, and will be updated by periodic supplements. Best directory of U.S. unions and associations. Part II provides listings of the federations of national unions and employee associations and their departments and councils; the AFL-CIO state labor organizations; and listings of the national unions and employee associations. Information for an individual organization includes address, names of principal officers, title of its publication, frequency of conventions and date of next one, membership, and number of local unions. Other sections in the Directory outline the structure of the labor movement, developments in organized labor for the biennium, statistics on union membership, etc.

U.S. Labor Management Services Administration. Office of Labor-Management and Welfare Pension Reports. Register of Reporting Labor Organizations, 1971. Washington, U.S.G.P.O., 1971. xiv, 293 p.

Earlier editions published 1960, 1964, 1968.

Useful for listing of local unions if other sources with more complete information are not available. For each state, lists Local unions under the key word of the parent labor organization, but gives only the Local number and name of city of the Local headquarters. The last section under each state is a listing by city of "Unaffiliated Labor Organizations."

Public Employee Organization Directories

The few specific titles listed in this subsection are examples of specialized directories of public employee organizations and unions.

Earlier edition, 1963.

Compiled and published in cooperation with the Pacific Regional Office, U.S. Bureau of Labor Statistics. First section contains a brief survey and analysis of membership in independent state and local public employee associations in California. Second section, p. 19-24, has a listing of such associations, but gives name only.

U.S. Civil Service Commission. Office of Labor-Management Relations. Union Recognition in the Federal Government: Statistical Report and Listing by Agency. Washington, U.S.G.P.O. Published annually in November.

Source for names of unions that are the recognized representatives of federal employees. Includes both AFL-CIO affiliates and independent unions.

U.S. Labor-Management Services Administration. Division of Public Employee Labor Relations. A Directory of Public Employee Organizations: A Guide to the Major Organizations Representing State and Local Public Employees. Rev. ed. Washington, U.S.G.P.O., 1974. 61 p. (Public Sector Labor Relations Information Exchange)

Provides for each, name and address; name of major officer; information on jurisdiction and organizational structure, publications, convention dates, number of members and locals.

U.S. Labor-Management Services Administration. Office of Labor-Management Policy Development. State Civil Service Employee Associations: An LMSA Staff Study, by Jerry Lelchook. Washington, U.S.C.P.O., 1974. 89 p.

Appendices A-C: Listings of State Associations, p. 86-89.

These listed directories may be updated or supplemented for specific geographical areas or occupations by using a variety of sources. The AFL-CEO Public Employee Department, established by 24 unions on November 6, 1974, should prove to be a source of information about public sector union publications. The first issue of its irregularly published paper is dated January 15, 1975. As with unions in other occupations, information about publications issued by the national and international unions and large state employee organizations is more readily available than about publications of the local unions and independent employee organizations in the public sector. Some of these issue papers and other publications for their membership. If such material is to be included in the labor collection, the usefulness of some of the following sources for published or unpublished directories, or for identifying organizations in one's geographical area may be investigated, in addition to using the general sources suggested at the beginning of this Section III.

Public Employee Relations Boards or Commissions that have been established in some states to supervise public employee collective bargaining may publish directories of unions and other employee organizations that have won representation rights, or be able to furnish the information. Information may be collected and published by a university industrial relations institute. The CPER staff of the Institute of Industrial Relations, University of California, Berkeley, has compiled a list [unpublished] of the 12 major organizations representing California public sector employees. Names of these and other organizations with smaller or localized membership may be gleaned from news articles in its quarterly periodical, CPER: California Public Employee Relations. Names of New Jersey public employee organizations and information about collective bargaining agreements may be compiled from issues of the New Jersey Public Employer-Employee Relations, published occasionally by the Institute of Management and Labor Relations, Rutgers University. The weekly Government Employee Relations Report, and its Reference Manual, published by the Bureau of National Affairs, Inc., includes mention and news of many unions and employee organizations active in the public sector on the local as well as a national level. Other sources of information that may be available for specific geographical areas include study commission reports on collective bargaining in the public sector, sections in books and articles about public employee unionism in a specific area, articles in papers of the parent international union, or other labor press, general newspaper accounts of activities.

Labor Papers, Proceedings, Constitutions

The specific references listed in this subsection are examples of special listings of labor papers, constitutions, and convention proceedings, or of aids useful for selection/acquisition of current titles and for identification of older titles. Lists of state and/or local publications may be available for one's own geographical area. The acquisitions lists cited in the first section of this working paper and the "Recent Publications" section in issues of Industrial and Labor Relations Review often list convention proceedings when published or acquired. For intensive collecting, the directories and other sources of information mentioned in the preceding subsections will be useful.

Lists union papers under name of city. Gives title of publication, editor's name, address, telephone number, frequency of publication, paper size, circulation.

International Labor Press Association (AFL-CIO/CLC). ILPA Directory of Member Publications. Loose-leaf, with periodic supplements.
815 - 16th Street, N.W., Washington, D.C. 20006.

1st-7th ed., 1959-1969 were not loose-leaf. Has separate sections for: AFL-CIO and CLC publications; AFL-CIO National and International Publications, listed alphabetically by key word in union name; State and Local Publications (U.S.), listed alphabetically by state and city; Canadian Labour Publications, listed alphabetically by city and province; Regional and Industrial Associations. Gives title of each publication, address and telephone number, sometimes editor's name, frequency and circulation.

U.S. Department of Labor. Library. American Trade Union Journals and Labor Papers Currently Received by the U.S. Department of Labor Library, June 1971. Washington, 1971. 37 p.

Lists journals and papers of the national federations; international, national and other trade unions; state labor organizations; papers of labor councils and local unions. Gives title of paper, name of union publisher, address and frequency.

The U.S. Department of Labor Library has microfilmed part of its collection of union papers and has 1,360 reels of film. The microfilm is not, however, available at the present time for interlibrary loan, nor may prints of the films be purchased.

U.S. Bureau of Labor Statistics. Conventions... National and International Unions, State Labor Federations, Professional Associations, State Employee Associations. Annual (mid-year). Washington, D.C. 20212.

Lists conventions by month to be held. Gives name of union or other organization, place convention to be held, and date. This list and the reports of the convention published in the union paper alert the librarian to the impending publication of proceedings.

The U.S.B.L.S. Directory of National Unions... also lists dates of future conventions, but being published less frequently may be less accurate and up to date.

Committee of University Industrial Relations Librarians. Preliminary Union List of American Trade Union Constitutions and Proceedings. [East Lansing] Library, School of Labor and Industrial Relations, Michigan State University, April 1965. 168 p. mimeo.

Lists holdings of federations, national and international unions in 17 libraries. Local and regional organizations are not included. No bibliographic information is given. (List was never edited for publication in a final edition.)

Naas, Bernard G. and Carmelita S. Sakr, comp. American Labor Union Periodicals: A Guide to their Location. Ithaca, N.Y. [New York State School of Industrial and Labor Relations] Cornell University [c1956]. xv, 175 p.

Published for the Committee of University Industrial Relations Librarians. Lists over 1,700 labor union periodicals published in the U.S. and Canada, and provides basic bibliographic information about each and a record of the holdings of the 19 cooperating libraries. Included are periodicals and papers of federations, national and international unions and their locals, and regional organizations.

Reynolds, Lloyd G. and Charles C. Killingsworth. Trade Union Publications: The Official Journals, Convention Proceedings, and Constitutions of International Unions and Federations, 1850-1941. Baltimore, Johns Hopkins Press, 1944-45. 3 v.

Vol. 1 provides an excellent source of information on publications of about 225 American unions and national federations. Unions are listed under broad industry groups. Information given includes name changes of the union, dates of publication for proceedings, constitutions and journals, journal title variations. There is an alphabetic index by key word of the union name. Vol. 2-3 comprise a subject index to the proceedings and journals of a selected group of 50 unions.

Collective Bargaining Agreements

Collective bargaining agreements are usually obtained from the union or employer party to the agreement. One may obtain from a large national union a set of its agreements with several companies. Likewise, one may obtain from an employer a set of agreements it has with several unions, if more than one union has representation rights. If an employers' association negotiates for a group of member companies, it may be the best source. Texts of a few important or pattern setting agreements are printed in some of the labor services, such as BNA's Collective Bargaining Negotiations and Contracts, and Government Employee Relations Report. The Bureau of National Affairs, Inc., has a file of selected agreements, and copies may be purchased from them. Texts of selected significant California public employee agreements or "memorandum of understanding" are reproduced in issues of CPER.

Relatively few organizations seem to maintain mailing lists for agreements, so it is useful to know when new agreements have been signed, or when negotiations are scheduled. The union and employer papers often provide information about negotiations in progress, and agreements that have been ratified, and some are reported in the various loose-leaf labor services or reports, such as BNA's Daily Labor Report, Government Employee Relations Report, etc. Some key agreements are reported in the regular press, and this may be the best source for information on local agreements. The New York State Department of Labor publishes a monthly report, Collective Bargaining Settlements in New York State, and similar reports are published in some other states. Examples of other sources to aid in acquisition of collective bargaining agreements are listed below.

CPER: California Public Employee Relations. Quarterly.

Institute of Industrial Relations, University of California, Berkeley, CA 94720.

"A periodical of employee relations in the public sector." Includes news of negotiations in progress and agreements ratified, plus full texts of selected agreements. It is also an excellent source for information on unions representing and organizing public sector employees in California.

California. Department of Industrial Relations. Division of Labor Statistics and Research. Wage Settlements: California Union Agreements. Annual. 455 Golden Gate Ave., San Francisco 94102.

Has separate tabulations for new agreements and deferred wage increases. Gives names of employer and union, geographic area covered, amount of general wage increase, effective date or date agreement signed. This is example of a state listing.

Collective Bargaining Negotiations and Contracts. Washington, D.C., Bureau of National Affairs, Inc. 2 v. loose-leaf.

Kept up to date with bi-weekly inserts. Vol. 1, Section 19, "Current Contract Settlements" is an excellent source for this information. Section 18 includes a list of "Major Contract Expirations in 1975." This is followed by a more complete "Calendar of Wage Negotiations" by month of contract expiration or wage reopening. The bi-weekly "What's New in Collective Bargaining Negotiations and Contracts" has brief notes about recently negotiated agreements that are of special interest.

Hawaii. University. Industrial Relations Center. Duration of Collective Bargaining Agreements in Hawaii. Annual. Honolulu.

Provides calendar of Hawaiian agreements scheduled for expiration or wage reopening during the coming year. Example of a state listing.

Monthly Labor Review. Monthly. U.S. Bureau of Labor Statistics, Washington, D.C. 20210 (Order from U.S. G.P.O., Washington, D.C. 20402)

The section "Developments in Industrial Relations" contains news notes about recently ratified significant agreements. The section "Major Agreements Expiring Next Month" provides information on upcoming negotiations.

U.S. Bureau of Labor Statistics. Current Wage Developments. Monthly. Washington, D.C. 20210 (Order from U.S.G.P.O., Washington, D.C. 20402)

Good source for information on agreements negotiated and ratified. Includes each month a list of "Major Agreements Expiring in..." [month after date of issue]. List includes agreements covering 1,000 workers or more in all industries. Gives name of employer and address, industry, union, and number of workers.

U.S. Bureau of Labor Statistics. Pacific Regional Office. Collective Bargaining Calendar for the Pacific Region... Annual. 450 Golden Gate Ave., Room 10462, San Francisco, CA 94102.

Published annually in the Spring. Listed by month agreement expires. Gives name of company or association, union, location, approximate number of workers and industry.

IV

RESEARCH ORGANIZATIONS AS SOURCES FOR PUBLICATIONS ON LABOR AND RELATED SUBJECTS

Many useful publications on labor and a variety of related subjects are issued by industrial relations institutes/centers, labor education centers, business and economic institutes and similar research organizations. The books emanating from the research programs are very often listed in the standard bibliographic sources, but the greatest volume of publications are short paperbound monographs, reprints, conference proceedings, working papers, etc., which are not regularly listed. Many of these publications are free or relatively inexpensive. Some publications are listed in the specialized sources included in this bibliography. However, most such organizations issue publications lists and will place libraries and individuals on the mailing list to receive the lists. Some organizations send publications to a selected mailing list. Several sources for names and addresses of research organizations are listed below.

Association for University Business and Economic Research. Bibliography of Publications of University Bureaus of Business and Economic Research. Annual.

Business Research Division, University of Colorado, Boulder, Colo. 80302.

Vol. 18 (pub. 1974) lists 1973 publications.

A reference document for publications of University Business Research Bureaus which may not appear in traditional sources. Publications are listed by institute of origin as well as by subject. Since 1969 the subject index has followed the American Economic Association classification scheme. Labor is found in section 800.

Gale Research Company. Encyclopedia of Associations. 9th ed. Vol. 1, National Organizations of the U.s. Detroit, Gale Research Co. [c1975]. 1413 p.

Section 15, "Labor Unions, Associations, & Federations." First part lists "Labor Associations and Federations," and second, "Labor Unions." List is arranged alphabetically by key word. It is not the best source for a list of U.S. labor unions, but useful since it includes some international labor confederations and some non-union organizations, such as: Institute of Collective Bargaining and Group Relations; National Institute of Labor Education; Citizens for Farm Labor; Jewish Labor Committee, etc.

Herman, Georgianna, ed. **Personnel and Industrial Relations Colleges: An ASPA Directory [of] Schools, Centers, Professional Programs, Faculties and Courses at Colleges and Universities in the United States and Canada...** Berea, Ohio, American Society for Personnel Administration, June 1974. ix, 334 p.

Includes: "Directory of Organized Research Centers, Schools, Institutes specializing in areas closely related to personnel management and industrial relations"[and a geographic index thereto] (p. 319-330); and "Directory of Academic Libraries specializing in areas closely related to personnel management and industrial relations" (p. 331-333).

International Labour Office. **Directory of Labour Relations Institutes.** Geneva, 1973. v, 248 p.

Lists, by geographical region, organizations in Africa; Asia including Australia and New Zealand; Middle East; U.S. and Canada; and Western Europe, plus two international institutes. Not quite as complete for the U.S. as the Sokkar list. In addition to address, gives for each name of director (if available) and brief information about nature and aims, administrative structure, size of staff, facilities, and activities.

Research Centers Directory: **A Guide to University Related and Other Non-Profit Organizations...** 5th ed. Ed. by Archie M. Palmer. Detroit, Gale Research Co. [c1975]. (Over 1200 p.)

Kept up to date by periodic supplements.

Classified arrangement under broad subjects, "Labor and Industrial Relations" being one. Has an institutional index and an alphabetic index of research centers.

Sokkar, Jo Ann and Mabel Webb, comp. **Information Regarding Industrial Relations Sections in Colleges and Universities in North America.** Prepared and distributed for the Committee of University Industrial Relations Librarians. Ann Arbor, Industrial Relations Library, University of Michigan, April 1972. 4 p. proc.

Gives addresses, telephone numbers and names of directors and librarians.

U.S. Library of Congress. National Referral Center for Science and Technology. **A Directory of Information Resources in the United States: Social Sciences.** Washington, D.C., U.S.G.P.O., 1973.

Entries are arranged alphabetically and numbered sequentially. The subject index is keyed to these numbers with cross references. Each entry gives name of organization, address, areas of interest, holdings and lists publications as well as information services provided.

University and College Labor Education Association. **Directory of Member Institutions and Professional Staff.** Annual. C/o Federal City College, 1424 K Street, N.W., Washington, D.C. 20005.

Listing, by state, of centers specializing in labor education programs with names of staff. Some are same as the research institutes, but the list includes additional organizations, or the specialized labor education divisions of the research institutes.

FOREIGN AND INTERNATIONAL LABOR PUBLICATIONS

Since few U.S. libraries develop extensive collections of works on foreign labor or of foreign foreign labor union publications, the compilers have not included herein a listing of specialized bibliographies on foreign labor, of labor union directories published in individual countries, or of foreign bibliographical tools and foreign language journals containing book reviews. These aids would be needed, of course, in order to collect foreign labor materials extensively, or to collect intensively for a specific geographic area.

For librarians interested in acquiring a little material on foreign and international labor, the aids listed in this bibliography should be useful. Selected foreign publications and/or publications about foreign labor, and publications by and about foreign unions and international labor organizations are listed or reviewed in many of the general sources listed in Section I. All the foreign journals and International Labour Office publications mentioned there, plus the International Bibliography of Economics, Industrial and Labor Relations Review, and Monthly Labor Review are recommended sources. Some of the acquisitions lists are also useful sources, especially those from the New York State School of Industrial and Labor Relations and the U.S. Department of Labor Library. Major books are listed in the standard foreign trade bibliographies.

Specialized bibliographies and the bibliographies and other citations in books and articles are useful sources for titles of older works. McBrearty's bibliography, which is listed in Section II, GENERAL BIBLIOGRAPHIES, includes some references on foreign labor. A few general sources for information about foreign labor publications are listed below.

International Congress Calendar, 1975. 15th edition. Brussels, Union of Inter-

Directories listing foreign labor unions and international confederations, etc., and providing some information about their activities, are useful selection aids, since publications may be solicited from the issuing organizations. Comprehensive recent directories that list individual unions throughout the world, such as the series published by the U.S. Office/Bureau of International Labor Affairs in the 1950's and 1960's were not located during the compilation of the present bibliography. However, a few recent more selective listings are cited in this section, including two general directories of international organizations. Some of the entries give titles of the serial publications issued by the organizations. Although some of these directories do not list the individual national unions in each country, the names and addresses of these may be requested from the appropriate regional office of the international organization, or the associated trade secretariats or international trade union federations. Some of these bodies may publish directories of affiliated unions in the various countries.

The national labor union federations and ministries and departments of labor sometimes publish lists of the labor unions in the country, or may be able to furnish information about them. Yearbooks and directories of various types for countries and regions may also include lists of unions.

Provides good listing of international federations and foreign unions as of the date published. Old but useful for identification of earlier unions.
