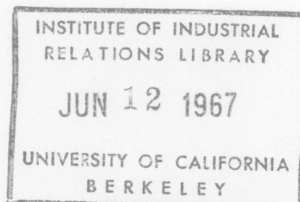

NEWS BRIEF

ON SPEAKER

FOR JUNE

The Honorable Ralph H. Nutter is Judge Presiding, Writs and Receivers of the Superior Court in Los Angeles. Judge Nutter, a graduate of the Harvard Law School, was an attorney for the National Labor Relations Board from 1948 to 1951, when he entered private practice. He served on the bench at the Municipal Court from 1956 to 1961, when he joined the Superior Court.



PAST
PROGRAMS

John B. Flanagan was a staff member of the U.S. Senate Select Committee on Improper Activities in the Labor Management Field (McClellan Committee). The hearings of that committee resulted in the passage of the Labor-Management Reporting and Disclosure Act. He is, therefore, intimately familiar with the seven titles of the Act and the legislative debate which followed its passage. His office now administers both the Labor-Management Reporting and Disclosure Act and the Welfare-Pension Plans Disclosure Act as amended.

Mr. Flanagan discussed the various kinds of reporting that these Acts require. For example, union members now have the legal right to receive copies of all financial statements, as well as a copy (or access to one) of the collective bargaining agreement under which they work. Every union must file copies of its constitution and by-laws with the Secretary of Labor, which must clearly set forth election procedures for officers and delegates to conventions consistent with the Act's provisions. He explained that the Secretary is required to investigate election complaints under the following conditions:

- (1) complaints must be presented in writing;
- (2) the complainant must have exhausted all internal remedies under his union's constitution and by-laws;
- (3) the complainant must have taken these steps within established time limits.

Annual financial reports and financial details of welfare and pension funds must also be filed with the Secretary of Labor in duplicate. One copy of the financial report is then filed in the area office of the BLMR where the union is located and is thus available for inspection to any member of the public upon request. Copies of welfare and pension reports, on the other hand, are available only in Silver Springs, Maryland.
