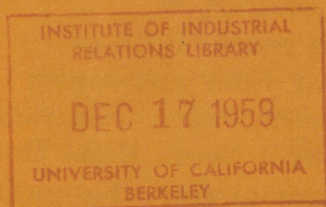

The National Right To Work Committee is a non-profit organization—a coalition of employees and employers—dedicated to the elimination of compulsory union membership in the United States.



The Committee is supported by wage-earners and businessmen, educators and clergymen, Americans in every field of endeavor.



The Taft-Hartley Act allows each state to decide whether its working people shall be protected from compulsory union membership. Nineteen States have passed Right To Work laws guaranteeing this protection. Preservation of these laws and extension to every worker of this protection against compulsory unionism, is the sole objective of this Committee.

THE PROGRAM

Information and Education

We Americans believe in individual freedom. We believe that unionism, like all our other associations, should be voluntary. However, after being besieged for years by the professional unionists' lavishly-financed campaign of distortion about this principle, many persons have become confused.

Given accurate and adequate information, the vast majority of this nation's people will support the Right To Work principle.

It is the function and the aim of the National Right To Work Committee to provide this information through every channel of communication—newspapers, radio, television, libraries, publications, debate and speech materials. This organization will press on, to the limit of its resources, until every thinking American understands the meaning and importance of voluntary unionism.

Protection from Federal Preemption

Section 14(b) of the Taft-Hartley Act guarantees the powers of States to enforce Right to Work laws. This section is under constant attack by legislators who are subservient to the wealthy political machines con-

trolled by union bosses. Right now, these forces are mapping an all-out attack on Section 14(b) in the 1961 Congress. Only a well-informed and alert public can forestall this assault on States' rights and personal freedom. This Committee's information program is geared to win that crucial battle.

Assistance to State and Local Citizen Groups Working for

Voluntary Unionism

Staff members of the Committee are working continually with State and local groups on the most effective methods of informing the public about Right To Work. The Committee sponsors workshops and clinics, provides a constant exchange of information, and furnishes prototype educational materials to assist all interested groups in presenting more clearly the facts on Right To Work.

Enforcement of Right to Work

The Committee helps Americans protect their right to work. Within the limits of its resources, the Committee program includes positive assistance to persons whose livelihood is threatened or destroyed by the tyranny of compulsory unionism.

The National Right To Work Committee was founded in January 1955, by a group of Union members and small businessmen who recognized the need for Right To Work leadership from the national level.

The President is William T. Harrison, a 20-year member of the Brotherhood of Railway Clerks, who was expelled from his union in 1951 for opposing compulsory unionism. The Executive Vice President is Reed Larson, who directed the successful fight for Right To Work in Kansas from 1954 through 1958.

These men direct a staff, augmented by volunteer assistance of many individuals and organizations, in a comprehensive program dedicated to voluntary unionism.

The Committee's financial support comes entirely from voluntary memberships.

Every penny is devoted to winning and protecting the Right To Work for all Americans. Every dollar helps to hasten victory in this crucial battle.

Individual freedom is still worth fighting for! The fight can be won and freedom can be preserved.
