TELLS OF JOHNSON'S CALIFORNIA FOES

San Francisco Editor Declares Half of State's Delegates Are Hostile.

CALLS CANDIDATE UNFIT

Lacks Personal Qualities Needed by a President, Declares Arthur Holman.

Half of California's twenty-six delegates to the Republican National Convention are really hostile to Senator Hiram W. Johnson, despite the fact that they were elected on the Johnson ticket, according to Arthur Holman, editor of the San Francisco Argonaut, who is stopping at the Hotel Belmont. Mr. Holman said yesterday in an interview that these delegates, among whom the best known in the East is William H. Crocker, Republican National Committeeman, would stick by their agreement to vote for Senator Johnson on the early ballots but could not be switched by him to any other candidate.

Mr. Holman said it was not true that Senator Johnson had the support of the conservatives and business interests in California, an impression that the Johnson campaign managers have been trying to create. He declared that Senator Johnson's personal qualities were not such as to fit him for the Presidency and said that no one in California, not even Senator Johnson's most ardent supporters, expected him to be nominated.

Doubts Wood's Nomination.

Mr. Holman who has been making a political observation trip preparatory to attending the two national conventions, said he did not expect the nomination of General Leonard Wood by the Republicans, both because he did not believe a military candidate could be nominated and because, rightly or wrongly, there was a strong public impression that large sums of money had been expended to further his candidacy. He said he did not look for the nomination of any of the leading Republican candidates who have been engaged in the competitive campaign.

"I believe that the 'horse sense' of both parties will come to a realization that the ordinary consideration of the availability of a candidate is of less importance than the greater consideration of fitness," Mr. Holman said. "If I had the authority to name the candidates of both parties I would name John W. Davis of West Virginia for the Democratic nomination and Nicholas Murray Butler of New York for the Republican. "In either case, you would have a man of knowledge, power, character and eminent qualifications."

Mr. Holman said he did not believe any man could be elected by a party who

...had opposed the peace as a whole. He stated that he believed that the country wanted the treaty adopted with reservations, safeguarding American interests, but recognizing our obligations.

Tells of California "Unity" Deal.

The Republican Party in California, Mr. Holman stated, was still divided into two factions, just as it was in 1916, with Senator Johnson in control of the dominant faction. He explained that a "unity" agreement was brought about last Fall by Will H. Hays, Chairman of the Republican National Committee, as a result of which half of the California delegation to the National Convention was made up of men opposed to Senator Johnson, but who agreed to work with him in this campaign in the interest of harmony.

"This was before the entrance of Herbert Hoover into the California primaries," Mr. Holman continued. "The result was that the Johnson ticket contained twelve or thirteen men committed to Senator Johnson but really opposed to him. They stuck to their agreement, but, if it had not been made, would have supported Mr. Hoover, not because they were for the latter but because they were against Senator Johnson."

"Senator Johnson's name is anathema to the conservative people of California. It is not true that he is supported by the business element; he has very strong support from the popular element."

Mr. Holman said that Senator Johnson came into the Governorship of California as a reformer and professing to hate political organizations. "He immediately organized the most thorough-going and remorseless political machine the State ever had seen," he continued. "He doubled the patronage by the multiplication of commissions. He doubled taxation. This enormously augmented scheme of the State's official activity

gave him the political backing to establish his machine."

Analyzes Johnson Character.

Mr. Holman said that, despite the attempts of the Johnson managers to make it appear that Senator Johnson had the backing of the business interests of California, he knew of only two important business men in the State who were his sincere supporters. Mr. Holman then sketched the following analysis of Senator Johnson's character from his viewpoint:

"Senator Johnson is a man of considerable power. He has a good education, both generally and professionally. For twenty-five years he was a criminal lawyer. He has an instinct for hatred and a talent for unctiousness."

"He is perpetually indignant. He has a heavy mind, which works best under the influence of anger. His method is to get into a rage and denounce somebody or something."

"His instincts and capabilities are destructive. He has had no business experience and no professional experience relating much to business. No man who knows him can imagine Senator Johnson considering any great public question in a calm, judicial frame of mind. His usual mood is anger. Yet he has a charming personal side."

"He has not the first requirement for the Presidential office, as measured by the traditional standards of experience, mentality and personal dignity. Out of his many supporters in California nobody seriously expects that he will get the nomination."

Mr. Holman said Senator Johnson might possibly keep all the twenty-six votes of California as long as he remained a candidate. "But half of them are not 'last ditchers,'" he added. "They are pledged to vote for Senator Johnson, but he has not got them to trade."
