## TRANSMITS AND DELIVERS THE WITHIN TELEGRAM SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

To guard against mistakes or delays, the sender of a telegram should order it REPEATED: that is, telegraphed back to the originating office for comparison. For this, one-half the un-repeated telegram rate is charged in addition. 1. 

My dear Boys:

As you know, I have had no time to write, and I have been talking to you occasionally through telegrams. Tuesday last the primary was in Illinois. I returned that day here. Immediately upon my return, I had to go into the Senate on the immigration bill, and I have been in constant attendance since. Physically, I am about gone. When I say to you that I have been through the most terrible and heart breaking experience of my career, you'll know how mentally I feel. I am not going into detail with you, because I feel like a soldier who, forced against his will, into situations that were awful, never likes afterwards to speak of them. I do not mean to say, of course, that I was forced into a candidacy against my will. That is all nonsense. I should have foreseen what would happen. I did not. I have paid the penalty, and my dear boys, I tried to pay the price, and to one of my temperament and pride, it has been terrible, without whining. I am the author of my own ills, and the lack of judgment and vision have been my own. I have taken my beating standing up, and I will take it standing up for the next three weeks. I am, Of course, more concerned about and more affected about California than any other place.

The telegrams of the last few days show me conclusively what will happen there, and I don't see my way clear to do anything except just bide the end. The idea that I come out to California and alter what seems ordained I think wholly erroneous. As the days go on things will get worse instead of better. New Jersey, next Tuesday, and Ohio the following Tuesday will accentuate the situation instead of modifying it. There may be just one good thing in it all. I will be kicked out of politics, and after time has healed the hurt, it will probably be the best thing that could have happened to me. I am not without friends in different states, and unknown people who have an abiding confidence in me, and who in the recent disasters, have followed me with a loyalty that is touching; but no man in position of power has dared go with me, save in the one instance of Peter Norbeck of South Dakota. Money is king of politics again, as it probably has not been during our generation, and of course, it looks askance at me. The ramifications of this money power extend to the very villages, and, of course, the national administration through its post offices and its patronage, reaches everywhere.

I wired you both last night my view of what ought to be done in California. I am not clear that this is the best thing to do. Flint wants me to withdraw and publish a statement that under existing circumstances, California should send a Coolidge delegation. I will not make any such statement, and I am inclined to think that withdrawal with my name still printed on the ballot would be even worse than accepting the defeat that is certain to come. However, by the time this reached you, I presume we'll have come



to a consensus of opinion what to do in California, and I will follow that, although I will not, in this hour of defeat, cheapen myself by asking a Coolidge delegation, nor do anything else than frankly state the case to our people and go to my execution.

I go tomorrow night to New Jersey because there is a little group in northern New Jersey, who, without money, and against great obstacles, have tried to carry on a fight, and wish a last expiring gasp there. Our Ohio friends want me to come into Ohio next week. I shall probably do so in some sort of fashion. May 6th will see the end of it all, and then, with a repudiation by California, I can begin my recovery physically, and in a brief period, too, I think become reconciled.

My dear Jack:

I returned from Ohio Saturday afternoon somewhat the worse for wear. Yesterday and today I have remained at home in the yard, recuperating. What a pleasure it has been! The quiet and the peacefulness have been balm to me. The spirit is strong within me, stronger than ever in the days of hope, but I'm so tired and fagged, so ragged physically that like a wounded animal, I long only for seclusion and rest. Tomorrow I expect to go about my usual duties. I'm utterly indifferent to future results and resigned to anything. Last night I sent an address, I fear a poor one because of depleted vitality and stagnant mentality, to California, and a wire to you to look it over and correct or amend it. Its only purpose is to state to our people my view of the California contest, and let them do then what they will. Of course, I assume they will be no different from people elsewhere; the same influences, the like

psychology will control in California as in other states. I don't want you to think that because I recognize results and realize what an egregious ass I've been, that I'm broken or disheartened. Already I'm thinking of the future only and my course during the four years remaining here to me, and I'm clear as to what I shall do, and what I shall do. However, enough of politics for the moment.

Mother handed me today for the first time your letter about the recent assessment of the River Gardens Farms Co. It's not fair or just this burden should again be put on you. You have been more than generous to us in this matter; and in some fashion you should be repaid or secured. If you will not take an assignment of Mother's stock, at least let this be the acknowledgment of our indebtedness to you. In addition, I have in my safe deposit box, key of which you have, a bill for \$1000. and there are coupons undoubtedly

upon our Liberty bonds amounting to a few hundred dollars. Please take this \$1000. and the interest coupons as a very small part of reimbursement. I want you to do this, and will feel better if you do. It is your right. I know it's unnecessary to thank you for your generosity. You know we both do.

It is my expectation to stay here until after the convention. I never want to see another railroad train and it sickens me to think of a long journey. However, after the convention, I shall come out to California with the old fighting spirit and go after the State Administration and big business that seems to control government. Mother vows she will not come; but I'm hoping when the time draws near her view will change.

Love to the boys. Lots to yourself, with my heartfelt thanks.
