Dear Mr. Cooley:

Following our telephone conversation of this morning I am enclosing a fotostat copy of the letter of the Under Secretary of the Interior dated Aug. 6, 1945, which gives a good outline of the terror that reigned at the Tule Lake Center.

The letter of Mr. Fortas admits that the duress accounted for 80% of the renunciations obtained at the Tule Lake Center and for a higher percentage of renunciations as a matter of fact inasmuch as it recites "over 80 percent".

I believe you and your office will find the letter interesting on the issues involved in the test cases - and I believe the courts also will find it interesting reading.


Dear Mr. Collins:

Dear Mr. Cooley:

In re: Goya, Nobuko; Itaya, Sachiko Grace;
Kanegawa, Hisaye; Katsura, Kimi;
Kuroye, Sadako; Nishi, Shizuko;
Otsuka, Yoshi; Shirai, Mary;
Uyeda, Sachiko, all single persons.

The above-mentioned renunciants detained at Crystal City are single, unattached girls. Apparently they are the only single girls still detained aside from those who are detained along with their family members at Crystal City.

Detention works a greater hardship upon these single girls than upon any other internees and is more likely to produce psychological deterioration in their cases than in others. I would be grateful were you to give special consideration to their immediate release so that they can be restored to normal civilian life. It does not seem possible to me that the Department would view their continued and prolonged internment as either necessary or desirable.

Dear Mr. Collins:

I have your letter of recent date concerning the matter of release or parole of the renunciants at Crystal City, Texas, pending disposition of the litigation affecting these persons.

It will not be possible to consider parole, except in cases of extreme emergencies. The question of release must be considered on the basis of the individual record. As you are probably aware, several renunciants, both male and female, have been released in the past few weeks, after a reconsideration of their individual cases.
