Dear Wayne:

I have for the last two days ~~been~~ tried to find the address of Toraichi Kono, but without any success. I called the Rafu Shimpō, but he is not listed there as a subscriber. The editor there stated that Kono dropped by for a visit but did not tell where he resided. It is probable that he is staying somewhere in Hollywood with his Caucasian friend. I checked with Sasaki and few other issei in town, but they do not know his whereabouts.

However, I feel that we should have something in his file pertaining to the address of his son, who is attending UCLA. So please ask Chiyo to check the file in this regard.

Another thing is Sasaki stated he applied for his first paper, but the naturalization officer here has not as yet received his entry record from the San Francisco office. Therefore in order to hasten matter he wanted you to call the Immigration officer and have his record transferred to Los Angeles office. His full name is Masami Sasaki. The date of entry was sometimes in 1906.

Meanwhile I shall try to contact some other source as to the whereabouts of Kono. Could you tell me if there is any other Seabrook alien released on parole now giving their forwarding address in Los Angeles? If we could find some we may be able to track him down. to some

Gentlemen:

Confirming statements made to you via telephone this morning please be informed that any Nisei who, under duress, renounced his U.S. nationality at the Tule Lake Center or any other WRA Center during the war who makes written request to me to be included in the mass suits I brought to cancel the renunciations of some 2,700 similar renunciants and to restore their U.S. citizenship will be included in said suits as a party plaintiff.

An interlocutory judgment has been granted restoring citizenship to those already in the suits and that judgment will become final in 90 days from April 29, 1948. The decision will cover any and all persons who are added as parties plaintiff within that time.

In order to be included in said cases the following information is necessary, viz., (1) the full name, (2) present address, (3) date of birth, (4) place of birth, (5) place where he or she renounced and (5) whether or not he or she received a letter from the Attorney General approving the renunciation.

Gentlemen:

The JACL's history is one of repeated and continuous betrayals of the best interests of the Nisei and Issei. It favored the evacuation from the West Coast and failed to protest against it. A number of its officers and members maliciously pointed the finger of suspicion at certain aliens and citizens and wrongfully accused them of being dangerous to this country. As a result a number of aliens were imprisoned for years in alien enemy camps and citizens were denied leave clearance and were imprisoned in WRA centers.

The JACL refused to protest against the detention of these innocent persons in the Tule Lake and other Centers. Through Saburo Kido the JACL refused to help Tetsujiro Nakamura and Masami Sasaki in their efforts to prevent Nisei from renouncing their citizenship at the Tule Lake Center. Neither the JACL nor its stupid newspaper, the Pacific Citizen, has ever said a good word for the renunciants or the aliens.

The JACL's attorney Al Wirin testified before the Dickstein congressional committee that all the renunciants should be deported to Japan. He and J. B. Tietz took a gross advantage of the Peruvian-Japanese group at Santa Fe and tried to do the same thing to the similar group at Crystal City. He connived to interfere with and jeopardize the suits I brought to liberate the interned renunciants and to cancel their renunciations. He and his group, with the connivance of Roger Baldwin of the New York American Civil Liberties Union, deliberately and willfully tried to shift the blame for the renunciations from the government to the members of the Hoshi Dan, Seinen Dan and Joshi Dan and thereby to prevent the members of those organizations from being restored to citizenship in my cases.

Wirin and his group brought unnecessary immigration suits in Salt Lake City months after I had obtained an agreement from the Justice and Immigration Departments postponing the deportation of immigration law violators until my immigration cases were determined by the Supreme Court. He and Baldwin of the New York Civil Liberties Union steadily have been opposed to the interests of the renunciants, the aliens held in detention as though they were dangerous to our security, the Peruvian-Japanese and those aliens

who entered the country unlawfully or lost their status by reason of the war and were ordered deported. Officers of the JACL followed the same line. The Pacific Citizen, an organ of the JACL, published articles attacking the renunciants and the cases I brought to cancel renunciations.

In consequence, I have absolutely no use whatever for the leaders of the JACL, Al Wirin and his group, Roger Baldwin and the New York American Civil Liberties Union, for each of whom I have the utmost contempt, all and each of whom I charge with having betrayed the interests of the Nisei and Issei in this country. Some of the said groups and persons still are trying to exploit the Nisei and Issei for personal profit and to get cheap publicity for themselves.

I am aware of the activities of a Los Angeles group which has been and now is endeavoring to stir up cases and litigation in renunciation cases. If any attorney or attorneys in Los Angeles either directly or indirectly solicit renunciation cases they violate the law and the canons of ethics by which attorneys are bound.

In my opinion the filing of other cases by renunciants might do injury to the mass suits in which I have already been successful. Wirin's suits, which arose in the questionable manner with which you are familiar, were designed to blame the Hoshi Dan, Seinen Dan and Joshi Dan and thereby injure the rights of the 2,700 who are protected in my mass suits. In my opinion any renunciant who knows of the past and present activities of the JACL, Al Wirin and his crowd, and Roger Baldwin and his ilk would have nothing to do with any of them.

As I heretofore informed you, in order to protect the renunciants from being exploited by racketeers, I am still accepting the requests of renunciants to be joined in my suits which already have been won. The judgment is interlocutory and will become final in 90 days from April 29, 1948, that is to say, on July 29, 1948. That judgment will cover and protect any and all persons now in the suits and also all those whose names are added thereto within that time. I will accept the names of any renunciants who request me to add their names to the suits. In order to be included in the cases the following information must be supplied to me, viz., (1) the name of the renunciant, (2) his or her present address, (3) place of birth and (5) place where he or she renounced. However, I will not accept any requests from the JACL or any of its officers, Al Wirin, Saburo Kido, Frank Chuman, Fred Okrand, J. B. Tietz, Arthur Garfield Hays, Osmond K. Fraenkel, or anyone connected with their offices, or from Roger Baldwin or anyone connected with the New York Civil Liberties Union because of their questionable activities, sordid purposes and steady betrayal of the rights of the Nisei and Issei.

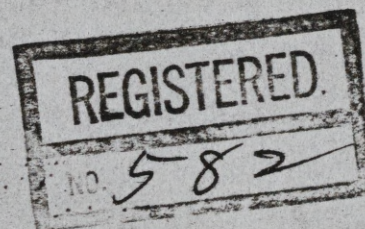

Dear Wayne:

Last night Harry Akhida called the meeting of the Inlelake Defense Committee, and then approval was received on the matter of collecting additional fund for the Inlelake case. The committee decided to give Mr. Saraki and myself full responsibility to collect the fund. I have explained roughly the relationship of Mr. Kono to Mr. Saraki, and an understanding has been found in concerting all available resources to finish this drive for funds.

I requested that the committee members pitch in on their available times, & they have readily accepted such term.

I have made arrangements to open an office at Saraki's hotel on the 3rd floor, as some central point is necessary in communicating with all the remittance. It will be just for a very brief time so I felt it desirable to open such an office.

The committee members sought to use the Japanese papers to get all the addresses of the original Inlelacs, as most of them have never informed you of their change of addresses.

By way of information - through reliable sources -
found out that Lavine received only \$20,000 for the
defense of Kawakita. Kawakita's property in California
was under A. PC Vesting order as his son was in Japan.
Thus his son returned to have it released. Lavine is to
handle this case providing he turn in a verdict
of acquittal for his client. In the end it usually
ends up to the same story - that they do not have
a great deal of funds available for the defense of
their children.

I shall keep you informed of the progress on the
drive for this fund.


This will acknowledge receipt your letter of 24th.

This is just to let you know that the Hiraoka family hope that you and yours spent a nice Christmas and that the New Year finds you in good health and happiness.


I didn't intend to talk shop, but that always creeps in somehow. After recording all those papers for the Kitaharas I forwarded them the bill for the costs, but there has been no answer yet. They are slow in getting around to paying but I feel that they will send the money to us.

There is a matter which I want you to keep to yourself as confidential matter, Wayne. I heard from a friend of the Kitaharas that a divison of the moneys and properties has been made, without changing of the titles to the properties.
