
This will acknowledge receipt your letter dated January 11th with enclosure of copies of notices for Immigration hearing.



Dear Sir:

On April 12, 1949, a final judgment was entered in the Tule Lake mass renunciation suit cancelling your renunciation, declaring you to be a native-born U.S. citizen ever since your birth and prohibiting the defendants Attorney General, the Secretary of State and his consular agents and other defendants from depriving you or any other plaintiff of your rights, liberties, privileges and immunities of U.S. citizens of the U.S. unless and until that judgment is reversed by a higher court.

This court ruling applies to all the plaintiffs in the suit, whether resident in the U.S. or in Japan. However, the State Department is presently flouting the court order in depriving you of your rights, liberties, privileges and immunities of U.S. citizenship.

The case is presently being appealed by the government in the Circuit Court of Appeals, and judgment in this proceeding will not be forthcoming until the early part of next year. Upon a favorable decision, it will be impossible for the State Department to ignore the court.

On January 21, 1949, the Tule Lake Defense Committee in Los Angeles, California, mailed to each of you a letter asking that you make contacts with your friends or relatives in the U.S. to remit a retainer in the sum of \$100. To this date, we are informed that very few persons were able to find contacts in the U.S.

In as much as the proceeding has already consumed a great deal of time and money; with a further likelihood of it being a costly undertaking; we ask each of the plaintiffs to sign a note which is enclosed herewith. The note is for the sum of \$300 for those who have not made any contributions to date, and for those making any contribution the sum deducted from this figure. This note may be payable upon your return to the U.S.; or upon your being restored the privilege of returning to the U.S. We also ask that you write the address where we may contact you in the U.S. on the bottom of the note.

We appreciate your attending to this matter at your earliest convenience, and returning the signed note in care of Mr. Sam Iseri, Northwest Airlines, 138 Marunouchi Bldg., Tokyo, Japan.

Dear Tex and Toraichi:

Last week I sent you copies of the briefs in the renunciation cases, both equity and habeas corpus. Like copies were sent to the committeemen in the United States and in Japan.

For your information, the Circuit Court will not be able to hear oral arguments in the cases until the first week of May, 1950.

I am writing Iseri and I think also I shall write each renunciant in Japan telling him or her what steps would be the best to pursue. It may be wise to flood the consuls in Japan with applications for passports. It is my belief that the Attorney General will alter his policy about the time the case is argued and even more so by the time the cases are decided by the Ninth Circuit Court of Appeals. It is my belief that the consuls will permit the vast majority of them to obtain passports before the cases are actually decided.

Dear Wayne:

This will acknowledge receipt your letter of March 21st. We also received the briefs, which you mailed last week. If there are any extra copies I would appreciate your mailing another copy.

In your letter you informed me that the argument will not take place before the first week of May, 1950.

In reference to this point I think it advisable as you have mentioned in your letter to mail each individual renunciants in Japan a personal letter from yourself. I feel this is a necessity as this will be a reversal of our former policy. Iseri told me that he was having great difficulty in getting any informations across to the renunciants. Also when they ever do come back to the U.S. they will not think it was on account of our efforts, but the reversal of policy by the benevolent Consuls in Japan.

Also I would like you to give me a press release to inform the renunciants in U.S. through the Japanese newspaper. I would like you to give me a resume on what each renunciant should or should not do in the purchases of real property, and applications for passport to visit Japan. I have been receiving numerous inquiries on this point, and I told them to wait until March, 1950.

I think these thing must be done, as Wirin is misleading quite a group of renunciants in U.S. and Japan. Through his hit or miss tactics he was able to maintain a reasonable amount of success in some of the cases and people are beginning to doubt our word. Last week Wirin won the case of the Nakanishi woman in the local Federal District Court. She is still a plaintiff in our case.

Sometime last month I sent Iseri \$100 on two separate instance to take care of correspondence in regards to the notes. This I feel is essential as they must be informed that litigation is a costly thing.



## Plans trip to aid strandeers

Attorney Henry J. Tsurutani will leave for Tokyo on April 24, representing the legal offices of A. L. Wirin in strandeer cases, it was announced today.

While in Japan, Tsurutani will take testimony from Nisei plaintiffs who wish to return to the United States. He will also gather materials pertaining to the Conscription Laws of Japan and the complete data on the Nipponese general election of April, 1946.

The testimony will be used in cases pending in U.S. Federal courts where plaintiffs are seeking restoration of their birthrights.

He will also learn the status of many Japanese Americans who were forced to work for the Nipponese government during the war as instructors.

Wirin indicated that such information would be of value to strandeers who are seeking an early return for their hearings.

Arline Martin, assistant U.S. attorney at Los Angeles, will also leave for Japan at the same time. She will represent the government in the taking of testimony.

Tsurutani was in the Orient in 1945 and 1946, serving with the U.S. Strategic Bombing Survey. He is a contributing columnist for the Rafu Shimpo English Section.




