


Dear Wayne:

Dear Mr. Collins:

I finally reached the Kaneda Airport on the evening of May 31st, and Kono was present to greet me. I am now quartered at the Kokusai Kanko Hotel, which is located in the center of Marunouchi. I was amazed by the progress of the Japanese people in 8 years, and I find that the general atmosphere is prosperous. However, this may not be so in the rural area.

I had a conference with Mr. Adachi, and he is shipping away on most of the Shandor cases as it is unprofitable for him. He has no connection in the states where he could obtain the payment from the relatives of the Shandor. He appears to be a nice person, and may be of some benefit to us. He was not well versed on the current administrative policies, and I believe we are in a much better position tomorrow. I shall visit the 2 consulates here in Tokyo and Yokohama. I shall leave with Kono on the 4th to Kobe, and finally to Hiroshima.

Printing of questionnaires is as possible in Hiroshima, so we shall proceed to get down to work promptly.

Dear Mr. Collins:

During our brief stay in Tokyo, we visited the American Consulate at Tokyo and Yokohama. Mr. Patterson is in charge of the notarial section at Tokyo, and he assured me full cooperation in having the affidavits certified without any charge. Also he informed me that it was not necessary to make appointments.

I received a same form of response at Yokohama and met Mr. Dur, who was acting on behalf of the Consul.

However, Kobe appeared to be quite disorganized, and it was at this consulate the renunciants were having the most trouble. After conferring with various officials, I finally met vice consul Miss Stott, and she assured me full cooperation. However, she requested that not more than 20 people come to their office every day. For this reason it might be necessary to arrange some form of control from Hiroshima through the committeeman to limit the number of renunciants going to Kobe.

Kono and I arrived last evening to Hiroshima City, and presently holding our temporary quarter at this New Hiroshima Hotel. Kono's old friend is the Mayor of this city, and he has been most helpful in lending his cooperation. The city has permitted us the use of the Peace Hall this Sunday morning at 10:00 Am, and I will gather approximately 300 to 400 people into that hall. Immediately after the meeting I shall have Kono appoint some committeeman in this area and take individual appointments for interviews.

The questionnaire are now in the printer and should be ready by this time.

Although I met Mr. Adachi in Tokyo, he did not impress me very much in the matter of setting the koseki and voting cases aside. Mr. Watanabe, whom is the Mayor of Hiroshima is also an attorney. He claims that it is necessary to get an understanding by the office of the District Attorney and the courts that such a suit will not be contested. This prearrangement must be made or the District Attorney's office will contest each and every one of the koseki registration. Mr. Watanabe will introduce me to a reputable Japanese lawyer, and I shall make further inquiry as to the procedures in the Japanese courts.

I have received the carbon copy of the letter forwarded to the committee. I have not received the rough draft of question related to strandeers, and I shall thank you to mail them in care of this hotel.



Dear Mr. Yego:

A renunciant who has recovered his U.S. citizenship can execute the affidavits required by the Japanese Government on the form that it supplies. The reason for this is that since a judgment of the U.S. District Court has cancelled his renunciation of U.S. citizenship and has declared his renunciation to be void from its inception, such a person never did lose his U.S. citizenship and never validly has renounced the same.

However, if a renunciant wishes to explain the matter in greater detail, he can state that he renounced his U.S. citizenship at Tule Lake in 1945 but the said renunciation was cancelled and that he was declared to be a U.S. citizen by judgment of that court.

Dear Wayne:

After I had a phone conversation with you on the 6th, I had several talks with Kono and Mr. Seki. They are of the opinion that the majority of the renunciants will be able to find some mean of passages to the United States. Seki roughly gives a conservative estimate that onehalf of the renunciants could return.

I find that there are two or three possibilities which the renunciants could find a way to get their passages to the United States.

1/ The first is the possibility where the renunciants themselves have sufficient yen fund to purchase their own tickets.

2/ The second is to find some relatives in the United States that will forward them the tickets.

3/ The third possibilities lies in getting some guarantor in the United States that would sign an agreement with the American President Lines. By this method the President Lines will furnish an instalment plan for the payment of the tickets. This could be accomplished in 6 month or a year.

4/ The fourth alternative is to organize something like a credit union in Japan. This is the "tannomoshi". This is the method whereby the substantial majority of the Issei came across. The renunciants themselves could organize such association among themselves, and it requires two guarantor to withdraw such fund. They will be responsible for the advancement, and such fund be payable to the group that should be in the United States. They must pay a nominal interest for the duration of the loan.

If this plan were workable, many of the renunciants in the rural district could find some mean of obtaining passages.

I think that this is a workable plan. As they will police themselves, and by this method we could keep a direct contract through such an association as to the whereabouts of the renunciants and their duty to pay their cost, fees, and expenses.

After talking with you, I now realize who this Mitsuda is. He was in my block at block 30. He was the only Hoshi dan member in our block, and he could not be trusted. It is true that he has nothing in which to furnish you with various fabrication, but I will discount appreciatively what he has to say. As he might be one of those that does not give a damn about the rest of the renunciants that are stranded in Japan. He is probably out for his own self, and it took considerable pain for him to come to your office.


I mulled over this prob~~lem~~ during the weekend, and I find that the renunciants in Japan must do something constructively for th~~the~~ir own good. I feel that this is something like the period of organization of the committee at the Tule Lake Center.

This is the reason why I think the "tannomoshi" plan is workable. Even if we could find some source of fund in the Japanese community that will be willing to advance, say \$200,000 for the 500 renunciant's boatfare--this will not be appreciated at all. It would be better that they solved this problem among themselves in Japan. For this reason I would feel that some constructive plan could be furnished to the committee members in Japan, and they be responsible for their own problem as far as passages are concerned.

It must also be recognized from this angle. If there were some 200 ~~xxx~~ potential renunciants that are willing to come at present, and if our trip merely had an effect of ~~xxxxxxxx~~ bringing to this country an additional 5 renunciants, the trip will have paid itself. I do not care to go if there is no benefit arising to you, and this is the similiar view expressed by Kono. For this reason it is vital and necessary that all factors be hashed out as much as possible before we leave for Japan.

If you wish that I leave here and have some furthur conferences, I will be glad to come to San Francisco.




