Dear Mr. Cozzens:

This is in response to your letter of January 18th.

Since the Army still maintains exclusive orders as to certain Japanese aliens and even as to certain American citizens of Japanese ancestry it seems to me that California peace officers are within their rights in asking persons of obvious Japanese birth or ancestry to produce identification. The possession of identification papers by such persons at all times would serve as a protection to them and I see no reason why they should object to producing such papers any more than a man obviously under the age of forty-five should object to producing his draft card.
