
Dear Mr. Allen:

Dear Dr. Mays:

I talked with Charles Silberman about his Fortune article. I had to call several times before I was able to speak with him. Hence the delay.

Silberman said that the article was adapted from Chapter 4 of his book, Crisis in Black and White. All of the questions you asked were related, as it turned out, to references drawn from two books: Stanley Elkins, Slavery: A Problem in American Institutional and Intellectual Life; and Frank Tannenbaum, Slave and Citizen: The Negro in the Americas. The references to Jews in Nazi Germany and references to the Justinian Code are drawn from Elkins. All of the other references you mentioned are drawn from the Tannenbaum book. Silberman could not refer me to specific pages in these books as his note have become disarrayed. Both books, however, are available in Vintage paperback editions.

Please advise as to whether you would want to read these books in their entirety or should I extract the relevant information from them. If you would like copies of the books and they are not on sale in Atlanta, I could purchase them here.

I received the last two checks you sent. Total time involved in the Silberman research: 45 minutes.

Dear Mr. Allen:

I am sending you a Xeroxed copy of an article, Chattel Law and the Negro, by Charles E. Silberman, which appeared in FORTUNE magazine in 1964. Here are the things that I would like for you to do:

1. Silberman quotes Stanley Elkins of the University of Chicago. I would like for you to trace this article or book by Elkins and give a synopsis of what he says about the Jews in the Nazi concentration camps. I would like to know the exact reference so that if I quote from Elkins I can give the exact source.
2. See what you can find about slavery in the Spanish and Portuguese colonies. I would like to be able to quote from an original source rather than from Silberman. The point he makes there is that slavery was considered a misfortune and not as a permanent thing as American slavery was designed to be.
3. Check the Justinian Code and see what you find on slavery. The Romans, as Silberman says, considered slavery as a normal condition of man, the result of accident and misfortune. I would like to have a specific reference for this. See if you can find that quotation from Seneca where he says: "A slave can be just, brave, magnanimous."
4. Silberman says, on Page 5 of the article, that South American law gave slaves the right to acquire and hold property and to buy their freedom. Trace that. Silberman quotes Professor Frank Tannebaum. See if you can find that quotation.
5. See if you can find an article on the Catholic Church and slavery. I take it that the Catholic Church recognized marriage among the slaves and therefore they could not be separated as was the case in Protestant America.
6. On Page 6, Silberman speaks of Catholic Portugal and Spain regarding slavery as a natural condition of man. See what you can find on that.

I believe you said that anything further that I wanted you to do in New York should get to you before May.


Dear Mr. Allen:

Dear Dr. Mays:

Enclosed are Xeroxed copies of the material you requested from the publication Outlook. The copies cost \$3.50 (receipt attached) and about an hour of my time was spent in obtaining them.

While getting these copies I made an important discovery. Some weeks ago when I telephoned the N.Y. Public Library I was informed that the library had no means of duplicating material recorded on microfilm. Hence the necessity for taping and transcribing. But yesterday I learned that I was misinformed and that microfilms can be enlarged and copied on paper. The process will cost about \$2.50 per page, but this is much cheaper than our present method. I have already taped some more material and it's now being typed up, but in the future I will employ the duplicating process.

Many thanks for writing a letter of recommendation, and also for the checks which you sent.
