Comment: "There are no local ordinances restricting Oriental people in any way, for the very good reason that Chinese and Japanese have not been allowed to live in Humboldt County- with two exceptions\* for many years.

About 65 years ago, a white man was killed in Eureka, during a tong war. The Chinese were driven out of the County and never permitted to return, the only exceptions being a Chinese cook at the Gold Bluff mine and a cook on the Thomas Bair ranch in the mountains.

About 25 years ago, some Japanese came to Eureka and over

opened a store. A few nights later, their place was dynamited and they were forced to leave hurriedly.

This was rather rough treatment, but it has been sufficient to keep these people out of Humboldt County, so we have no evacuation or re-settlement problems to worry about at this time.

The impression you may get, that Humboldt County is peopled by tough lot of savages, is not born out by the fact that oriental people have come through the county as tourists without being molested or mistreated in any way, but are not wanted as permanent residents."
