"I had hoped to reach you by telephone or have a personal chat with you relative to one or two questions concerning the proposed return of Japanese to the Pacific Coast military areas during the war. Not having been able to reach you, I am setting them out briefly herein.

1) Many people have reported seeing a considerable number of Japanese here already. It would seem that the best check on this would be for your committee to have a record of every Japanese now permitted in this area, and a requirement that a report come to you in the future on each individual permitted to return.

2) Most of the people I have contacted are under the impression that the Japanese who have been in the armed forces are permitted to return to this area only when in

Uniform. On the other hand, I have had from one individual the positive statement that those in the service w en given honorable discharge and thus returned to civilian life, are permitted to return ~~xxx~~ here.

3) I h<sup>a</sup>ve heard the statement made that conscientious objectors have been~~x~~ \* released from other camps and sent to War Relocation Centers as teachers. This would seem to be a very dangerous influence.

### RESOLUTION URGING RETENTION OF JAPANESE IN RELOCATION CENTERS

WHEREAS, b reason of the presnt war between the United States and Japan, all persons of Japaese ancestry have been removed from the area of the Paific C oast and placed in relocation centers distant therefrom, and

WHEREAS, there has been evidenced in the press movement in the United States to release certain of said persons of Japanese ancestry from the sad relocation centers, and

WHEREAS, ~~and~~ many such persons of Japanese ancestry resided in the Pajaro Viley and near Watsonville, Calif, and by reason of which fact the citizens of this locality have had occa sion to deal with and understand the characteristics and nature of such persons;

NOW THEREFORE BE IT RESOLVED, that all persons of Japanese ancestry be retained in relocation centers for the duration of the said war and that none be released during the duration except upon approval of and under the supervision and control of the military authorities of the United States, and only then if such release is ~~deemed~~ deemed to be in the furtherance of our war effort.

This resolution adopted the 25th day of May, 1943, by the Board of Directors of the Chamber of Commerce of the Pajara Valley, at Watsonville, California.
