to Mr. Simons Transportation division:

According~~to~~ to the list of property submitted by the above evacuees
a considerable volume of goods was involved of over \$1,000 in
value. According to the present tenants of the building (1430-32
Geary) the premises had been vacant for over a ~~year~~ month before
they took possession. All property stored ~~was~~ by the Japanese

and remaining in the building when the present tenants took over had been segregated and left in a corner of the basement. This property consisted of a miscellany of broken, damaged and discarded articles of little or no value. All of the cartons and boxes which were found had been opened and the contents thoroughly ransacked for anything of value. The store room in which the ~~xxx~~ articles were presumably left by the evacuee had been converted into living quarters for the negro tenants and there were no Japanese articles found in this room. It was claimed by the ~~xxxxx~~ tenants that the property had been thoroughly ransacked before they took possession.

Memo to Ray Best, from Hatch, Sept. 4, 1944: "We have been informed ~~that~~ by Mr. J. S. Servis that certain items of equipment left by Mr. Eto in his custody had been sold without authorization by Mr. G. Davis. Mr. Davis had borrowed one cultivator, one marker, one single horse plow, and one leveler belonging to Mr. Eto from Mr. Servis with the understanding that it would be returned within a specified period. At the end of the period Mr. Servis requested of Davis that the equipment be returned. He at that time discovered that Davis had sold these items together with other items of equipment which he actually owned, to two Filipinos, Matt Tablet, and Bennie Recoma. These men had bought the equipment in good faith thinking it belonged to Davis and they are naturally reluctant to give it up without being recompensed by Davis. However, since Davis left the county, presumably having gone to Honolulu, it appears almost impossible that he can be reached. The Filipino boys were informed that they purchased stolen goods and that they therefore do not hold valid title to them. It is our opinion that they are expecting these items to be taken from them. They are operating a farm in the immediate vicinity of Mr. Servis's property and Mr. Servis will be glad to help any authorized persons to contact these people.

Letter from Mrs. R.C. Rose to Mr. Eto: "Some Negro people bought the place you were on & have torn all the back part & front porch off & rebuilt. They seem very nice. Oh yes, did you leave a pump & motor at the big well? If you did its gone I believe. "

Letter from Mrs. R. C. Rose to Mr. Hatch, Oct 5, 1944: "Mr. Davis was arrested and admitted he had sold property that did not belong to him. I do not know what they did with him, but Mr. Rowan phoned me that Mr. Davis raised the money and paid the Filipino and that they wanted to buy or rent the equipment and asked me to write Arthur Eto and see if he would sell or rent it."
