### **Sacramento Area Physicians for Social Responsibility**

Edward Rudin was a founding member in 1980 of Sacramento Area Physicians for Social Responsibility (SAPSR), along with Drs. Neil Flynn, Ray Adelman, Richard Reinertson, Robert Meagher, Bill Kohl, Fred Pratt and others. He served as its president from 1985 to 1987 and again in 1992-93. As a board member, he gave speeches to community groups and arranged programs for the community to convey the message of the dangers of nuclear arms buildup and the health consequences of nuclear war.

In 1985 he accompanied his wife, Sacramento Mayor Anne Rudin, to peace conferences in Hiroshima and Nagasaki, representing SAPSR.

In 1990 he was given National PSR's prestigious Broad Street Pump Award "for outstanding contributions to the effort to prevent the last epidemic".

PSR is the local affiliate of International Physicians for the Prevention of Nuclear War (IPPNW) which was awarded the Nobel peace Prize for 1985.
