

Container List for the KQED “The Castro” videotapes, 1996 (#2000-63)

Scope and Content of Collection

This collection contains 40 one inch reels from KQED’s documentary on the Castro neighborhood in San Francisco. Reels contain interviews with longtime Castro residents and more recent (including LGBTQ) residents, such as members of Eureka Valley Alumni Association, Dorr Jones, Phyllis Lyon and Del Martin, Cleve Jones, Phyllis Burke, Allan Berube, Marga Gomez, Brian Freeman, and Felicia Park-Rogers. Reels are arranged chronologically by bump reel number, which was originally assigned by the collection creators (KQED, Inc.) prior to donation. Transcripts of many of the interviews are available in collection administrative files in the GLBTHS archives.
