Scope and Content: The Sharkey Collection is an extensive collection of personal correspondence, political and legal documents, newspapers, and ephemera concerning State Senator William R. Sharkey and family, including his son William Sharkey Jr. and grandson William Sharkey III, their spouses, in-laws and other relatives. The collection ranges from 1865 to the 1990s. After publishing newspapers in Plumas County and then the *Contra Costa Gazette* in Martinez, Sharkey Sr. was elected to the California State Senate serving the 9th district in 1916, and was appointed chairman of the California Rivers and Harbors Commission by Governor Hiram Johnson. He continued to run his growing newspaper business while he served in politics. When Sharkey died in 1948 his son William Sharkey Jr. took over as publisher of the *Contra Costa Gazette*. Prior to that, Sharkey Jr. had served in the Navy and also worked for the state Department of Motor Vehicles and California Highway Patrol. He is credited with developing the state's first motor vehicle code. The bulk of the Sharkey Collection consists of personal correspondence between Sharkey Jr. and his fiancée (later wife) Dorothy Jessen, family photographs, and a large collection of newspapers featuring front-page articles about noteworthy events of the 19th and 20th centuries including the assassinations of Presidents Lincoln, Garfield, McKinley and Kennedy. The collection also contains information on Sharkey Jr.'s military service, his enrollment at Stanford University, his work at the Department of Motor Vehicles, and some information on the activities of his son William Sharkey III. Other materials include greeting cards, audiotapes, and photographs of the Sharkey family, their friends, and colleagues. Sharkey Jr. died in 1997. The collection was donated by the family in 2010-2011.

Examiner* (September 13, 1901) covering the assassination of President McKinley, and a fragment of the *New York Herald* (April 15, 1865) covering the assassination of President Lincoln.

Newspapers covering the wedding of Dorothy Jessen to Sharkey Jr.; issues of the *Sierra Valley Leader* from 1895 and the *Martinez Daily Standard* from 1915; and a *Martinez Daily Standard* article about the re-election of State Senator Will Sharkey from August 27, 1924, among others.

Various newspapers, many of which are deteriorating and must be handled carefully. They include the *San Francisco Chronicle* of November 12, 1936 covering the opening of the San Francisco-Oakland Bay Bridge, the *San Francisco Examiner* of June 6, 1944 covering the landing of the U.S. invasion at Normandy, and various military newspapers covering World War II.

Newspapers including the *Contra Costa Gazette* of May 11, 1943 covering Japan's threat to bomb the United States, the *San Francisco Examiner* of February 21, 1962 covering astronaut John Glenn's landing back on earth, and the *Contra Costa Morning News Gazette* of February 8, 1964 covering the Beatles' arrival in New York.
