

## INTRODUCTION TO COMPLETE ARTICLES FILE

- 1) Please note that there is one sense in which the Complete Articles File (CAF) is not in fact complete--namely, that this file does not contain photocopies of essay manuscripts in the Library of Congress's South Pacific Ethnographic/Margaret Mead archive, which contains the bulk of Bateson's pre-1946 material. This omission was the decision of the literary executor.
- 2) The CAF contains everything in the Published Articles File (PAF), plus unpublished articles, successive drafts (when they have survived), materials used in the writing of the article (in a few cases), and copies of published reprintings and excerpts.
- 3) The researcher who wishes solely to examine the final form of a published Bateson article is encouraged to use the Published Articles File (PAF) so as to spare irreplaceable manuscripts unnecessary handling.
- 4) The researcher should be aware that Bateson had strong views on the distinction between the spoken and written word and the responsibilities attending each. His position, as several of the letters and tape recordings testify, was that what was written carried and should carry more weight (and accordingly demanded greater care on his part), while that which he said in lectures, talks, and discussions was and should be spontaneous and not subject to transcription unless edited by himself (a task he disliked unless he regarded the particular tape recording as in some sense valuable). The researcher should thus take all unedited transcriptions in the CAF with several grains of salt, especially since none of them are GB's transcription and most of them are patently inaccurate, as the gaps and question marks testify. By the same token, the tape recordings in the archive should be heard with a particular ear, bearing in mind the point enumerated above.
- 5) The researcher is reminded that there is an appendix to this Guide/Catalog which attempts to list all of GB's writings chronologically by date of actual writing.
- 6) Red dates at the top of the first page of some draft manuscripts are dates of typing, put there by his secretary. Encircled numbers at the top of the cover or first page of some articles are numbers which were used in assembling GB's articles for possible inclusion in Steps to an Ecology of Mind.
