MASTER AGREEMENT

PREAMBLE

It is hereby agreed that existing collective agreements between the Railways and the Organizations signatory hereto, as specified in Appendix A to this agreement, are amended to conform with the following provisions of this agreement except that these provisions shall not apply to positions which are located on Canadian National lines in the United States and which come within the scope of the aforementioned collective agreements.

ARTICLE I — WAGE INCREASES

1. All hourly, daily and monthly basic rates of pay for employees covered by this agreement will be increased by these amounts:

- (i) one per cent effective March 1, 1962, calculated on the basic rates of pay in force at December 31, 1961;
- (ii) a further one percent effective October 1, 1962, calculated on the basic rates of pay in force at December 31, 1961.

2. All hourly, daily and monthly basic rates of pay will be increased as follows:

(a) Hourly rates:

- (i) effective January 1, 1963, add two cents to the hourly basic rates of pay;
- (ii) effective July 1, 1963, add a further two cents to the hourly basic rates of pay.

(b) Daily rates:

- (i) effective January 1, 1963, add 16 cents to the daily basic rates of pay;
- (ii) effective July 1, 1963, add a further 16 cents to the daily basic rates of pay.

(c) Monthly rates:

Monthly rates shall be increased on January 1, 1963, and on July 1, 1963, in the following amounts in accordance with the basic monthly hours shown:

Part-time employees covered by wage agreement who are paid various amounts through the medium of the payroll for services performed each month will have such amounts increased:

- (i) effective January 1, 1963, by that proportion of \$3.39 per month or \$3.48 per month, as the case may be, that the number of hours worked each month bears to 169- $\frac{1}{3}$ or 174 respectively, and

- (ii) effective July 1, 1963, by that proportion of \$3.39 or \$3.48 per month, as the case may be, that the number of hours worked each month bears to 169- $\frac{1}{3}$ or 174 respectively.

COVERAGE

Employees who were in the service of the Railways signatory hereto on April 20, 1962, or who were employed subsequent thereto, shall, providing they have not been dismissed from the service or left the service of their own accord prior to November 2, 1962, be entitled to any amount of increased compensation that may be due them for time worked subsequent to February 28, 1962.

ARTICLE II — JOB SECURITY

1. The objectives of the job security program may be broadly stated as follows:

- (i) To mitigate hardships suffered by long service employees when their jobs are eliminated.
- (ii) To enable long service employees who are being replaced and who need to be re-trained to qualify for new jobs available with the same employer and to enjoy a means of support while so engaged.
- (iii) The revision and adaptation of seniority and other rules in order to facilitate reasonable mobility of workers, to the intent that long service employees shall have a preferential right to other jobs which they are capable of performing.

2. Each Railway Company will establish a fund into which it will put, on a monthly basis, commencing with the month of January, 1963, one cent per hour in respect of which payment has been made in accordance with one of the collective agreements specified in Appendix "A" to this Agreement to each of the employees covered by any collective agreement to which such Railway is a party.

3. Each fund for which provision is made by paragraph 2 of this Article II shall be established and administered in accordance with a supplementary agreement between the particular Railway Company and the Negotiating Committee representing the Associated Non-Operating Unions, which Agreement shall be negotiated in the manner provided by this Article II and shall provide for which one or more of the following purposes, that is to say:

- (i) Severance pay to employees laid off permanently;
- (ii) supplementary unemployment benefits to employees laid off subject to recall;
- (iii) re-training programs;
- (iv) re-allocation of employees;
- (v) such other related purposes as may be agreed upon,

the fund shall be expended and the terms and conditions applicable thereto.

4. In order to facilitate reasonable mobility of workers to the intent that long service employees shall have a preferential right to other positions which they are capable of performing, seniority and other rules applicable to positions covered by the individual collective agreements specified in Appendix "A" to this Master Agreement shall be revised and adapted with due despatch and to the satisfaction of the Special Committee referred to in paragraph 6 of this Article II, provided, however, that such revision and adaptation shall not require transfer of employees to positions in respect of which another union represents the employees, unless otherwise mutually agreed. No expenditures shall be made from the fund on a particular railway until the revision and adaptation of seniority and other rules have been fully completed with all unions on that railway.

5. Immediately following the signing of this Master Agreement, each Railway Company and each Union signatory hereto will establish Seniority Committees for the purpose of revising and adapting seniority and related rules as outlined in paragraph 4 hereof. Such committees will report progress from time to time to the Special Committee for which provision is made in paragraph 6 below.

6. To determine the terms of the supplementary agreements, for which provision is made in paragraph 3 of this Article II, a Special Committee consisting of not more than eight members nominated by the Railway Companies and not more than eight members nominated by the Negotiating Committee representing the Associated Non-Operating Unions shall be established and shall meet within thirty days after the signing of this Master Agreement. Except as provided herein, the Special Committee shall have the power to determine its own rules and regulations for procedure to enable it to carry out the intent of this Article II.

7. The representatives of the parties on the Seniority Committees and the Special Committee shall be officers of the parties and either party shall have the right to nominate substitutes who shall also be officers of the parties hereto for any of its representatives on any of the said committees.

8. If the Special Committee established under paragraph 6 of this Article II has not been able to reach agreement upon the terms of the supplementary agreements by July 1, 1963, or if the parties at some earlier time agree that they cannot reach agreement thereon, the matter shall forthwith thereafter, upon the application of either party, that is, the Railway Companies or the Negotiating Committee representing the Associated Non-Operating Unions, be submitted to a Board of Arbitration for final and binding determination. A single Arbitrator may be appointed, if agreed upon, and failing such agreement, each of the parties shall within eight days appoint a person to serve upon the Board and the two nominees shall within eight days select a person to be the third member and Chairman thereof. Failing such selection by the nominees within eight days as aforesaid, the Chairman shall be appointed by the Minister of Labour for Canada on the application of either nominee. In the event of any vacancy on the Board occurring by reason of death, incapacity or resignation, or for any other reason, such vacancy shall be filled in the same manner as is provided herein for the establishment of the Board in the first instance. A statement of the matter to be determined at the hearing shall be submitted by both parties, either jointly or separately, to each member of the Board or to the single Arbitrator as the case may be, within such period as the Chairman or the single Arbitrator may allow. The award of the single Arbitrator or of a majority of the Board, as the case may be, shall be the award of the

Board. If there is no majority decision, the decision of the Chairman shall be the decision of the Board. The expenses of the Arbitration shall be paid as follows: The Negotiating Committee representing the Associated Non-Operating Unions shall pay the fees and expenses of the member chosen by it; the Railway Companies shall pay the fees and expenses of the member chosen by them; the fees and expenses of the Chairman and all expenses incurred by the Board shall be divided equally between the Railway Companies and the Negotiating Committee representing the Associated Non-Operating Unions. Each party shall bear the expense of the preparation and presentation of its case.

9. Any dispute between a railway company and a union signatory hereto which arises out of the revision and adaptation of seniority and other rules, and which is not resolved to the satisfaction of the Special Committee as provided for by paragraph 6 of this Article II, may at the request of either party to the dispute be submitted to arbitration in accordance with the procedure set forth in paragraph 8 of this Article II, except that such request may be made at any time either before or after July 1, 1963.

10. For the purpose of this Article II the Canadian Pacific Railway Company, the Quebec Central Railway Company, the Dominion Atlantic Railway Company, the Esquimalt and Nanaimo Railway, the Grand River Railway Company, Lake Erie and Northern Railway Company, the New Brunswick Cold Storage Company, the Canadian Pacific Express Company and the Eastern Public Livestock Market shall be deemed to be a single Company.

11. Notwithstanding the provisions of paragraph 2 of this Article II, it is agreed that arrangements other than those provided therein may be determined by the Special Committee in respect of the Northern Alberta Railways Company, the Toronto Terminals Railway Company, the Public Markets Limited and the Shawinigan Falls Terminal Railway Company.

ARTICLE III — GENERAL

1. This agreement is in full settlement of all requests served on the Railways on or about December 20, 1961, by the Organizations signatory hereto.

2. Each agreement referred to in the Preamble hereto, as revised to conform with this Master Agreement shall remain in effect until December 31, 1963, and thereafter subject to sixty days' notice in writing from either party to the Agreement of its desire to revise, amend or terminate it. Such notice may be served at any time subsequent to October 31, 1963.
