
Dear Mrs. Kingman:

Dear Mrs Kingman:

I am encountering in my two history classes intense and bitter antagonism toward Japanese-Americans which I should like to soften if possible. Unfortunately, I do not have much material which I can present as concrete evidence. Can you help me in this regard?

Do you have a copy or two of the Tolan report which you could give or lend me or should I write to our congressman? (The reason why I haven't done so is that it takes a long time to get a response and I'd like to have it as quickly as possible.)

Also do you have any other of the evidence which you presented last summer at Mills College? I would particularly like to have material on FBI investigations, the Hawaiian situation and anything else which presents the case for the Japanese-American. I'd like to stick mostly to facts as the resentment down here seems to be exceedingly strong.

About 55 families are represented in these classes, and I think the situation warrants the effort.

Also I'd like to ask if you know what is being done with the farms which the Japanese owned? I ask this because a friend of mine coming on the bus from Sacramento to Modesto fell into conversation with a man who said that he was farming 3,000 acres of land mostly "formerly Japanese owned" and that he and his neighbors and help intended to see to it that no Japanese, American or otherwise, would ever be allowed to come back to that land. "We'll shoot any that try it", was his summary of their determination. What I'm wondering is this: From whom did he get the right to farm that land "rent-free" as he said he did.

Dear Miss Abbott:

It is always encouraging to find persons taking an active interest in behalf of our loyal citizens of Japanese ancestry. I am happy to send you the material you asked for, with the exception of the Tolan Report. I have only two sets, one of which is "on loan", the other of which I make constant use. It is an excellent source, however, and I suggest that you go to the trouble of securing one.

My understanding of the Japanese owned farm lands is as follows. As you know, all lands so owned are in the names of persons born in the United States (or Hawaii) only. At the time of evacuation, some land was sold, some leased, some (not much) left idle. So far as I know, there is no land being worked rent free, unless such infrequent disposal was made privately. There was no such general practice.

Of course, legislation is being pressed which would keep all persons of Japanese ancestry out of the entire country as well as California. However, until the United States Constitution is changed, and I find no serious thinking people who expect such a drastic move away from traditional American policy, no such legislation will be enforced.

I am glad that your feeling in the matter is leading you to try to get more factual matter in black and white. We are fortunate in having the material on hand, and will be glad to send you additional material as it comes to our office.

Dear Sir:—

I enclose your statement which I received from Mrs. Kugman before she left for the East. I am an elementary teacher here— and know several splendid young Japanese American people. One is in special Military Intelligence training at Camp Savage. It is these youngsters in whom I am interested and whose welfare is my concern. I have visited Manzanar, where the older brother of one of the lads has been J. Chief of Police—now assistant. Am well acquainted with the set-up there.

When Los Angeles District Attorney Hower made his statement before the Senate Committee relative to the murder of such fine young people, I wrote him at once. Have had a prompt reply—full of generalities, but promising action against any such attackers.

I know no one at all, in Santa Ana, who

is even faintly interested in fair play
for these ^{young} people - enough to take any active
interest, I mean. So I shall do my part
in writing comments on such news as appears
in the press - have done so steadily for a year.

I would like about 10 copies of your small
pamphlet - Mrs. Kugman sent me much material.
Since I know printing is expensive and I really
cannot persuade people to read any article of
length - you had better send such to others with
more opportunity.

Will it be possible to get a press notice of
the ^{actual} number of children who will eventually
get to Tule Lake? That is quite important - as the
public considers all residents there males - fully
equipped for sabotage!

Anaheim is supposed to put on a "Public
Educational Meeting" Nov. 2 - I wrote the chair-
man of the committee announcing it - member of
Native Sons + head of Associated Farmers - asking
where it would be. Of course, he never answered -
I shall watch the papers and go anyhow.

The young man at Camp Savage, formerly
of Proton - sent me a mimeographed stenographic

copy of the answers Mr. Head of Poston gave to the witness, Mr. Townsend, of the Dies Committee - It certainly proves what a travesty of justice has been permitted in Los Angeles. I sent the material to Mr. Hoiles, the Editor of our paper here, because we were to have Mr. Dies speak here this Thursday. It has been cancelled, however - Mr. Hoiles is quite outspoken in his belief of individual rights - is very much disliked here - I told him I did not need the material for several weeks - so have had no response for him - but thought he should see it. Assume you have it - and more.

Since the boys I know so well are so very fine and utterly sincere in their liking for this, their country, I thank you - for them - for your interest and cooperation.

Dear Mr. Dudley:

Upon my return from Washington D.C. on Monday of this week, I found your letter in the mail which had accumulated on my desk during my six weeks absence. Your questions are welcomed, as it is our desire that all of our members should not only be acquainted with the objectives and work of the Committee, but that they should feel that their interest is placed in an effective organization.

The program of the Committee is based upon the conviction that the first step in "supporting and defending the rights of law abiding persons of oriental ancestry in the United States and particularly of the Japanese American evacuees" is the dissemination of accurate and authoritative information concerning such persons. As much of the West Coast press is committed to constant attacks upon this minority, and fails to make use of much of the good material which is available, we feel it of great importance that we send out as much as possible of such information as we can gather together.

Each of our members has been provided with quantities of such material, and as our Committee has never considered itself a political pressure group, we rely upon any action being taken by our members to be taken in light of the information we have provided.

The organization of the Committee came about due to the recognition of its members of the relation of any minority to all citizens. The persons for our not having taken officially, any position on the other problems you mention are well expressed in the words of our Chairman, Dr. Arthur C. McEliffert:

" As you know, the originating impulse behind the formation of the original committee and its subsequent revival under its present name grew out of the shock of the treatment accorded Japanese-Americans. Other minority groups have long received unfair treatment and many of the people who came together to form the present committee were members of still other committees working on behalf of other minorities. When the Japanese-descended people, however, became the special and dramatic victims of racial prejudice the formation of a special group seemed justified to help to bring to bear in their behalf our American principles. Most of the people who have joined this particular committee have joined because they understood that we were to focus on the Japanese-Americans, and as our releases indicate our efforts thus far have been concentrated on this otherwise much neglected group.

However, when we formulated our purpose we foresaw that other Oriental people might sometime come within the scope of our concern. We also recognized that attempts to discriminate against one group of minorities tends to undermine the rights of other minorities, as well as of the majority.

Your desire to widen the focus of our purpose therefore is implicit in our original aims. Which additional minority group or other victims of an impaired Bill of Rights the Committee might include now becomes a matter of policy and will need to be decided on the basis of such factors as the effectiveness of other agencies already at work in behalf of other racial minorities, the ability of our organization to expand its concern without sacrificing their momentum and influence gained in behalf of the minority group on which we originally focused, etc."

As far as I know, all of our members have personally interested themselves in these other causes. As a group, however, we feel that our strength should be channelled rather than spread. This does not preclude the possibility of the eventual widening of our horizons when our membership is such that we can maintain a large staff for research and routine.

Once again, may I express my appreciation of your interest. We shall continue to gather and distribute authentic information. You may be sure that we have also made many valuable and telling contacts with persons in and out of government, whose influence may be counted upon to develop and maintain a more truly American attitude in our treatment of this "guinea pig" minority" -- treatment which cannot but reflect upon future attitudes toward all such groups.

This is just a quick note to thank you for sending us all the fresh material on WRA policy that arrived in my mail a few days ago. I am always delighted personally to have more stuff to use for background and I am doubly delighted to have something which indicates that you are still alive and kicking.

You have probably heard from the decision reached at the meeting in New York in the last week in September to cease the work of the Student Relocation Council on March first, 1944. You can imagine how down in the dumps we on the staff are as a result of this decision on the part of our elders and betters. Sam Ishikawa and I have listed the reasons for quitting as follows:

1. The higher ups believe that the students no longer need us so much.
2. They say there isn't enough money either for scholarships or administration.
3. Because of filled quotas, changing curricula, the large number of colleges which have developed cold feet, and because the Army, Navy, and WRA still have not come across with a reasonable ruling on the subject of clearing large universities, there are not enough college openings available.
4. Lack of vitality in the Student Relocation Council's leadership.

Various people have placed emphasis on various ones of these four reasons. The way I feel is that if #4 could somehow or other have been or be solved, #1, 2, & 3 would cease to be issues.

Here's hoping that everything goes well with you and yours throughout the winter.

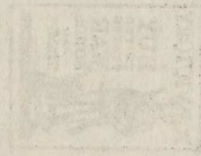

Dear Gale:

It is fine to hear of the vigorous efforts of you and the other members on the Pasadena Committee on Fair Play, such as your plan to distribute literature at the churches on the Sunday when the ministers are to preach on the evacuee issue.

As to use of the folder entitled "United We Stand", I at once discussed it with Mrs. Kingman, and found she agreed with me, to the effect that it was likely to be repugnant to a number of our own Committee and Board members, on account of its somewhat sensational make-up. We recognize that many of the hoi polloi are likely to be appealed to by just such material, and certainly, we should recognize that some one must try to influence them. But obviously, our Committee is not the one to do it if it requires the use of materials that our own members disapprove. It must be left to other agencies and individuals. Our forte is influencing persons of importance, who play a large part in setting the pace for the press, the platform and the official world. Much of our work is therefore done with individuals.

Mrs. Kingman is to consult Dr. McGiffert, as Chairman of the Executive Committee, and he may write to the Pasadena Committee. This is merely my personal opinion. I think Mrs. Thayer is sound in her feeling that she should have the approval of her own Committee and also of the central Executive Committee, although the Executive Committee, as you know, does not wish to block the initiative and zeal of any of the affiliated committees.

Like Mrs. Fleming, I especially like that pointed letter to the American Legion by Pfc Borchers.

I am not writing to Mrs. Thayer, but you may show her this if you wish.
