


HAPPY BIRTHDAY!



## BUY BONDS TO BUY BOMBS TO BOMB BUMS!

At the time of going to press it looks as though the out-of-town divisions are running away with the lead in the Sixth War Loan Drive. Tod Sloan's team in L.A. is well out in front. The only Minute Men who have not turned in pledges in excess of their quotas are attached to the S.F. staff. The local boys will have to look to their laurels or they will be hopelessly outclassed.

Bond purchases actually made, (including the December 15 payroll deductions and cash purchases reported up to December 12) total \$12,062.86, or 92 per cent of our quota.

In the remaining two weeks of the drive special attention should be given to seeing that all of the pledges are carried out, for in the final figures WRA will receive credit only for bonds actually purchased, either through payroll or for cash, regardless of the amounts pledged. Any employees who have entered on duty since Nov. 1 are particularly requested to report to the Minute Man in charge of their respective divisions to participate in the payroll purchase plan as well as to pledge whatever additional amounts they will invest.

WAR DEPARTMENT SPEAKS

California cooperation in the safe and orderly return of Japanese American evacuees is forecast in a letter from Asst. Secy. of War John J. McCloy to Congressman Clarence Lea, chairman of the California congressional delegation.


Writing of individual clearances, the Asst. Secy. of War said: "My attention has also recently been directed to a statement of Gov. Warren of California, that if the military authorities decide that military necessity no longer requires the continued mass exclusion of persons of Japanese descent from the West Coast area, the civilian authorities of California will cooperate on that decision.

"...If the military authorities determine that military considerations no longer require mass exclusion of persons of Japanese ancestry from the West Coast, we have every faith that the people on the West Coast, as have those of other areas in the United States into which persons of Japanese ancestry have been relocated, will show their good citizenship by abiding by the military judgment, and do their utmost to prevent and acts of discrimination against any of those people who may be permitted to return."

## BOND DRIVE OVER TOP

Chairman V. L. Furth announces that while final figures cannot be computed until after the WRAllocator has gone to press it is at least certain that WRA has over-subscribed its quota in the 6th War Loan Drive with the honor of turning in the highest division quota apparently settling on San Francisco Information which collected 357% of its quota. Said Mr. Furth:

"Congratulations are in order to all employees who participated in the bond campaign as well as to the Minute Men who had the responsibility for gathering in the pledges.

"Actual cash purchases together with payroll deductions in full for November and December total \$16,190 which represents 124.1% of our quota of \$13,036. It is expected that purchases still to be made will raise this figure slightly when the final calculations are made.

"Efforts are now being concentrated on increasing participation in the payroll deduction plan. At present WRA stands in 98th position of a total of 111 Federal agencies reporting. Only 68.3% of our employees have authorized payroll deductions for 6.7% of each month's payroll. The Department of Interior had a goal of 100% participation for 15% of payroll but we can qualify for a Treasury Flag if we can obtain 90% participation for 10% of payroll.

"Why not make a New Year's resolution right now to sign a payroll deduction card or increase your present allotment if you are not buying bonds each month amounting to at least 10% of your gross pay?"

## ARMY LIFTS BAN

Two days after the last WRAllocator was off the press the Army rescinded the order of 1942 which banned all persons of Japanese ancestry from the West Coast.

Next day, Dec. 18, the U.S. Supreme Court ruled in the Endo and Korematsu cases that (1) loyal Japanese-Americans cannot now be detained in relocation centers and (2) the original evacuation order, which applied to all persons of Japanese ancestry, was legal on the grounds of military necessity.

The rescinding order, Public Proclamation No. 21, becomes effective midnight tomorrow, or, as the Army puts it, "2400 PWT 2 January 1945."

Immediately following the Army's announcement, Secretary of the Interior Harold L. Ickes, WRA Director Dillon S. Myer and Assistant Director R. B. Cozzens issued statements to the public through press and radio:

Secretary Ickes called on the general public, public and private agencies, state and local officials to aid in making easier the return to normal life of the evacuees cleared for release by the Army.

Director Myer stressed the policies and program to be followed from here on in by WRA in his statement while Assistant Director Cozzens pointed out that relocation efforts to all parts of the country will be speeded up and that individual exclusion will continue under control of the military.

However all stressed that, contrary to the screaming headlines in certain newspapers, the return would be slow and orderly for a variety of reasons.

Orderly processing has already begun at relocation centers with Army men cooperating with WRA project staffs in getting evacuees cleared. Meanwhile, along the West Coast, area and district relocation offices are being set up. with area and relocation supervisors in charge.

In addition, several shifts in personnel have been made to facilitate the work of relocating those eligible.

GRAND CENTRAL STATION

Calif. with offices in L.A.; Raymond Booth, District Relocation Officer who will office at L.A. Already in Seattle as District Relocation Officer is Sheldon Hagen and Fred Ross is due in S.F. to fill a comparable post here.

Other arrivals here are Jean Eyre, new asst. to Mrs. Eades; Geraldine J. Eggsbo (also in Personnel); Mamie Jones, Fiscal; Vera A. Hennrich, Fiscal; Lucille C. Bassett, Office Services.

Departures: Ken Combs, a well-liked Transportation man who becomes sales manager for a lot of olives (V.F. Smith Co.) Also leaving Transportation are Lucille Erdman and Felbert MacKeever while June DesLaurier of the Health Section and Hans Jepsen, senior atty. on Edgar Bernhard's staff say adios, the latter to enter private practice.

DIRECTOR MYER VISITS COAST

WRA Director Dillon S. Myer recently came, saw and conquered more of those who have been shouting loudest in opposition to the return of loyal people of Japanese ancestry to the Pacific Coast.

Starting in Seattle, Mr. Myer spoke in Seattle, Portland, Woodland (Cal.), San Francisco and conferred with various city and state officials in Washington, Oregon and California, including Gov. Earl Warren of California, Mayor Lapham of San Francisco, Mayor Bowron of Los Angeles as well as other municipal officers.

As usual, Mr. Myer pulled no punches in speaking to the various groups, friendly or otherwise.

Those who oppose return of the evacuees to the West Coast can be classified into four groups, Mr. Myer said:

1-Political groups who have been at it for years and who through such opposition feel that they can gain political office.  
2-Misled persons (the largest group) who want to do good but are over-emotional and have been taught to hate.

3-The economic group, who do not care to compete with the Japanese in business.

4-The "red-faced patriots" or "ashamed group" who "have by various means stolen property from the evacuees, sold the equipment on their farms and not paid the debts they owed evacuees."

Most fruitful of the meetings up and down the coast appeared to be the two-day conference in S.F. sponsored by the Pacific Coast Committee on American Principles and Fair Play of which the S.F. News said editorially:

"We cannot commend too highly the wisdom of the conference here at which various phases of the (evacuee) problem are being spelled out and the public is asked to co-operate in working out the plans... Every fair-minded citizen, devoted to the American doctrine of tolerance for minorities, will hope the transfer will be accomplished without shame upon the fair name of California, and will help to that end."

Press coverage of Mr. Myer's talks was nearly completely unbiased and the Fair Play conference was particularly well reported.

MORE ON DIRECTOR MYER'S VISIT

In Woodland, after Mr. Myer had spoken at a service club luncheon meeting at which many Rotarians, Lions and Grange members were in attendance, the Woodland Democrat devoted nearly half its news space to the meeting.

Accompanied by Assistant Director R. B. Cozzens and Information Specialist Pat Frayne, Mr. Myer met with Gov. Warren in Sacramento following the Woodland meeting.

HOW THE WIND IS BLOWING DEPARTMENT

Down in Hollywood, American Legion Post 591, consisting of World War II vets, voted into membership Harley M. Oka. Oka thereby became the first Japanese American to be accepted into a West Coast Legion Post. At the same time Post 591 adopted a strongly-worded resolution condemning racial discrimination and took issue with the Hood River (Ore.) Post for effacing the names of 16 Japanese-American soldiers from its honor roll.

Last Saturday the S.F. News reported return of three Nisei to the Hood River Valley "without so much as the lifting of an eyebrow."

Wearer of more than half a dozen decorations and campaign ribbons, including the Silver Star and Purple Heart, Lt. Miyake was en route home on sick leave.

"I only hope I'll get back into shape fast so that I can get into action in the Pacific," said the quiet-spoken officer.

Lt. Miyake was wounded in the legs and back shortly before his outfit pushed into Rome last Fall.

"I didn't mind so much being wounded," he told Reports Office personnel, "but, doggone it, I always wanted to see Rome and I missed my chance!"

Lt. Miyake was commissioned on the battlefield, something that speaks well for both his ability as a fighter and a leader.

He laughed as he recalled how the boys in his outfit, the famed 100th Infantry Battalion, confused the Nazis and Italians by jabbering over the battalion radio and walkie-talkies in Japanese, Chinese, pidgin English, Portuguese, Hawaiian and snatches of half a dozen other languages.

"It drove the enemy nuts," he grinned. Then the smile dropped from his face and he looked grim.

"There's no prejudice among the men over seas. They know what we're fighting for. But we're not sure that all the people at home do. The Nisei have fought hard and well. But it makes your heart heavy and puts a lump in your throat when you think of the folks at home being pushed around by the bigots while you're over there someplace trying to preserve democracy and fighting fascism and nazism for those bigots---so that they can push your people around."



### JAPANESE LAW QUOTED

From the Portland OREGONIAN comes an interesting letter to the editor.

Harold J. Noble, history professor at the University of Oregon and a former Marine Corps major, discussed Japanese dual citizenship and the people "who prefer to apply Japanese law to him (the Nisei fighting in the U.S. Army) rather than American law."

Dr. Noble quoted the criminal code of Japan, (Article 81) which says that "every person who has joined an enemy power in taking hostile action against the empire shall be condemned to death." Article 89 states "...the provisions of this chapter also apply to acts committed against an allied power in time of war."

The letter concluded that those Nisei "who through no fault of their own were registered with the Japanese consulate during their infancy, and are now fighting

SACRAMENTO, March 24.-A two-day meeting, March 9 and 10, dwarfed all other news in the Sacramento district with its assemblage of administrative staff from San Francisco and field personnel from Fresno, Stockton and Sacramento. Area Supervisor Russell Robinson wielded the gavel and introduced our Assistant Director, R. B. Cozzens, who very ably outlined our program since its inception and brought to all present a better understanding of the necessity for co-ordination of all departments and every employe to accomplish the job of liquidating the centers and relocating the 60,000 evacuees remaining in the various centers within the prescribed time.

Charles Miller, Dep. Asst. Dir. in charge of relocation, presented a vivid picture of the departmental operations and stressed again that our assignment was now the reverse to that of 1942 and that the "return of the evacuees to the normal stream of life" should be foremost in the minds of the entire personnel.

Other speakers and topics were: O. B. Wilt, Transportation; John Lawton, contra-band; Harry Oakley, (censored); Winifred

## KENNY DENOUNCES "TROUBLEMAKERS"

Basic rights of people of Japanese ancestry returning to California must be protected and such protection is a responsibility of all law enforcement agencies in California, State Attorney General Robert W. Kenny told a recent meeting of the state's sheriffs in Sacramento.

Denouncing groups which are "stirring up trouble" with returnees, Mr. Kenny said:

"The protection of their basic rights-- freedom from fear, freedom to earn their living, freedom to live as peaceful citizens---must also be maintained.

"This situation is peculiarly one in which many groups need to cooperate wholeheartedly to assure results. The sheriffs and police chiefs have a direct and immediate part to play; the Department of Justice has a responsibility from a state-wide standpoint; the armed services for action of soldiers and sailors; the WRA for furnishing information which will be helpful in carrying this program through to its ultimate conclusion; district attorneys to prosecute anyone who violates the law; and all of us, as adults and responsible members of our communities, to do whatever we can to see that the attitudes, too, of people are such as to allow the Japanese Americans to live in safety and peace in the areas in which they resettle."

Referring to the world conference scheduled in San Francisco for April 25, Mr. Kenny pointed out that the German and Japanese radios mention the conference in scoffing terms "but our Allies speak of it as a hope for the future without recurring wars."

"American citizenship," he continued, "with its attributes of fearlessness, self-assurance and dignity, means much to the hearts of men who have suffered under the Nazi and Nipponese yokes. We must, therefore, make absolutely certain that nothing interferes with the welcome we extend--that nothing occurs in California to mar the impression on our guests of Democracy in operation."
