

CASE DOCUMENTS

This list contains the final numbering of the documents on Family Organization and disorganization in Tule Lake. In all of these cases, the sources have been rechecked and all the material available to date has been collected. All data which seemed pertinent to me in the Social Welfare Files have been copied and translated, and Individual Record forms for all persons taking major roles have been copied. Field notes have been taken on all cases with which I came in personal contact.

In column III, "cont." means that some difficulty had occurred before the family arrived in Tule Lake; "init." means that the trouble began here. In column six, "K" refers to "Kibei" and "H" refers to Hawaiians. In column VII, "CWD" refers to the files of the Social Welfare Department (formerly called Community Welfare), "26" refers to the individual record forms, and "FN" refers to "field notes."
