The combination of community forces alone will give the Accident Prevention movement strength and effectiveness. Accident Concerns everybody, it concerns the individual and the whole community.

The active participation of you and your department in promoting an atmosphere of Accident Prevention-mindedness among the public will be appreciated.

Ted Haas, Dr. Spicer and myself went over to the Red Cross Opening innaugural services ^{Sat. evening} about eight o'clock at the adobe grounds. There was a large crowd there. There must have been a couple of thousand people present. Trucks were arriving from Camps 1 and 2 bringing people. We first stopped at the sumo where a large and intent crowd was gathered. The crowd seemed to be mostly men and the older men were those most interested. The ring was as I described before, a raised square of earth and within its circle, 8 foot in diameter outlined by a slightly raised line. On each corner was a large post decorated with red and white paper spiraled around it. From post to post ^{were} hung paper decorations. On each of the four posts was a white paper symbol on a stick. In the center of the ring was a mountain of dirt and in the top was stuck one of the paper symbols. On the northeast and southwest poles was hung a bag of salt and on the ground was a pail of water and a dipper. A man whom Mr. Haas knew said that the paper symbols were like Gods, and that the salt in the bags are used to purify the ground and make it clean so that nothing bad will be there. He pointed out the ^{breach} brief cloths that the wrestlers wore, and said that no woman could touch them and if they did they had to be purified. The wrestlers were lined up on the east and west side. An official who wore red and silver (?) baggy bloomers and a black and white striped shirt came up + in a sing-song ^{voice} and made an announcement. He said that sixteen little fellows are going to have some fun. The crowd enjoyed both his announcement and his sing-song. He later announced the east side and the west side. Poston I was represented on the east side and Poston II and III on the west.

Before each contest he came up and facing east announced the name of the Poston I contestant. Turning to the west, he announced the name of the Poston II and III contestant. To begin the contest two of the instructors (with black belts) came up to do the ritual opening dance. They bowed as they entered the ring and one went to the northeast post and one to the southwest post, where they did the ritual stretching and then took handfuls of salt and sprinkled it all over the ring. Then they turned and squatted before the mountain in the center of the ring. Someone took the God symbol from the mountain and put it on a post. The two wrestlers then leveled the mountain, wrestled ritually for a moment and then the contest was ready to begin.

The first two wrestlers were tiny boys of hardly five years of age. The umpire had to instruct them in some of the ritual. They wrestled and the large one won. He was awarded a watermelon and went proudly off the mound. The other little fellow was presented with a watermelon and both he and the watermelon were carried off. The next several boys were boys about nine and ten; he knew somewhat more the ritual. They were awarded pencils. The umpire always handed the winner his prize on a fan and then turned to the loser and gave him his prize. An informant said that they both always received prizes but the winner's was supposed to be a little better. The winner of each pair had to make two wins. After several pairs had fought, they announced a free-for-all. About five boys were on a team and the winner of each pair would immediately take on another contestant from the opposite team. The winner in this free-for-all was he, who threw three of the other team in a row, only he received a prize.

Next came the young men and they had many strenuous bouts which kept the crowd in suspense. Oh's and ah's could be heard among the crowd. ^{In the few for all} A young man had to win three throws in a row, but later they made it five. It was ^{often a} ~~an~~ awful long time before anyone made five throws. The general feeling both between the contestants and the audience was much more tense than in the practice bout earlier in the week. In this deluther one seemed to feel it and be more disappointed than before. Once again there were many around who had not seen sumo before, who did not understand what was going on and many had to ask others what the announcements in Japanese had been. (RBS)

He mentioned that he read that there was something special about this chapter and explained that it is the only chapter of the Red Cross in which all the members belong to one race. (?) He felt that it was very important that this chapter was started here because it could do many important things.

In the afternoon I dropped in at the Red Cross headquarters. The first impression was one of activity, orderliness, and cheerfulness. One of the assistants talked to me for a few minutes and told me a few of their plans. One of the main things they wish to do is to allow people here to communicate with their families in Japan just to say that they are well. She said that it can be arranged but it may take several months. They are also going to hold classes in first-aid and water safety. Some instructors are going to come in from the Red Cross and give classes to train instructors here. She feels that the water safety is important because of the drowning in the river. She reported with pleasure that "another teacher" had come and offered to give classes in first-aid if she were needed. She said things are just getting started but feels that the chapter is going to be very important here.

14 To the General Public:

We would like to formally notify you of a Chapter organization of the American Red Cross of Poston.

Its initiator, Mr. Aijiro Takahashi, has been working on the idea for the past 3 months. It is mainly through his efforts that the organization, which is the first Japanese Chapter, received its full status last week.

The local chapter is endorsed by Mr. Wade Head, Project Director, and the Administration of the Poston Relocation Project.

Our Executive Council is composed of three Administrative representatives, Mr. Ralph M. Gelvin, Associate Director of the Project, Mr. John G. Evans, Manager, and Dr. John M. Powell, Director of Community Activity and Welfare. Outstanding community leaders from the three camps who have been known for their special aptitudes, training, experience and personality in emergencies, have already volunteered their services.

Although our temporary headquarters are presently located in the Block 30 Recreation Hall, offices will be opened in Camps II and III in the very near future.

"The Red Cross has both an official and a moral mandate to relieve human suffering caused by disasters....It has the responsibility to take the leadership in giving necessary relief to those in need."

In accordance with the purpose of the Red Cross, our local Chapter is constantly engaged in working towards the improvement of health, the prevention of disease, and the mitigation of suffering.

The first step we intend to take is to enlist volunteers for the First Aid and Water Safety. Although we have already received quite a few applications for training, we would like to see many more of you turn out, as the help of every individual will be valuable in the case of emergency.

Very shortly, we will have the exact date for training published in the Press Bulletin. The only requirement for applicants is interest in the course.

The local Chapter will appreciate your full cooperation in its future undertakings, and hopes that you will help to make it's success.



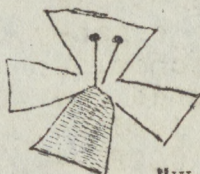

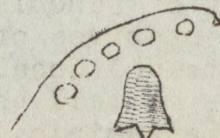

THE NATION-WIDE JUNIOR RED CROSS ENROLLMENT CAMPAIGN



"We believe in service for others, for our country, our community and our school, in good health of mind and body to fit us for greater service, and for better human relations throughout the world. We have joined the American Junior Red Cross to help achieve its aims by working together with members everywhere in our own and other lands."

Thus runs the official pledge of the American Junior Red Cross to which over 14,000,000 members have sworn during the past year. The 1943 membership drive for the largest youth organization is now underway on a nation-wide scale. It is expected that twice that number or, all boys and girls answer this nat'l call for Service by the end of this month.

The American Junior Red Cross in Poston has the full support of the Educational Authorities of the School System because:

- 1) Its aims are purely humanitarian--transcendental of racial, religious and national differences.
- 2) Its usefulness has been well proven by its past 25-year record of successful practice.
- 3) Its suggested activities are easily and profitably adjusted to classroom needs.
- 4) It offers the students opportunities to practice true world-citizenship in action.
- 5) Its membership fee is very small, while its benefits are great.

It is suggested that Postonians exchange these articles with students of schools from which they came from and also, with schools located in other Relocation Centers.

The request, sent in to Scotts Bluff County Chapter in Nebraska was first forwarded to the Red Cross Field Director at Camp Young, Indio, who turned the matter over to the local office.



YOUR MESSAGES TO JAPAN

The Inquiry and Message Service of the local Red Cross has taken down 1200 messages to date for Poston residents of the 3 camps.

Civilian messages and cables are forwarded to American Red Cross National Headquarters in Washington, D. C. from where they are sent on every available passage to the Japanese Red Cross, via International Red Cross in Geneva. The Red Cross setup enables personal communications between civilians in enemy countries with approval of the govts concerned. Inquiries concerning safety or location of civilians or naval personnel outside the continental U. S. are also handled.

At least two cablegrams per week have been coming in steadily from the Japanese Red Cross via Switzerland. Residents are encouraged to make use of this service, offered free of charge.

DEADLINE SET FOR SERVICEMEN'S GREETING CARD

The 15th of December has been set as the deadline date for those who wish to have the Home Service of the Poston Red Cross send Xmas cards to Servicemen. Poston residents with friends or relatives in the U. S. Service are encouraged to immediately bring the latter's addresses to the Red Cross Office, if they have not already done so.

On an official tour accompanied by Mr. B. Gufler, Assistant Chief of Special Divisions of the State Dept, the Spanish Embassy-Representative, Honorable F. de Amat, visited the Colorado River Relocation Center on the 12th for the interests of the subjects of Japan.

Commending the progress and activities of the Poston Red Cross in promoting the welfare of the general public, the above personages reassured Chairman Aijiro Takahashi, and Secretary R. J. Takeda of their full-hearted support and co-operation in the undertakings and success of the local Red Cross.

Messrs. de Amat and Gufler left after an extended 2-days' visit.

NAT'L RED CROSS SENDS XMAS TO SCHOOL CHILDREN

For the creation of a genuine Xmas atmosphere as a Jr. Red Cross Activity by Poston school children, the American Nat'l Red Cross has offered provision of art materials amounting to \$50. A large case of gifts to the Jr. Red Cross in care of Dr. Miles Cary is also on its way.

The air-mail notice was received by Mr. Paul Takeda, Chairman of the local Jr. Red Cross.

HELP PREVENT SCARLET FEVER

The Poston Hospital reports three light cases of Scarlet Fever, between the ages of 8 and 18.

The disease is highly contagious. Let's help prevent its spread by observing Public Health bulletins closely.

EMERGENCY SERVICE

47 cases were handled by the Red Cross Emergency First Aid Station set up at the Police Dept a few hours after outbreak of the Poston trouble on November 18. With trained First Aiders on 24-hour duty, the service was extended over a 7-day period till normal conditions were restored.

CANAL-SWIM. POOL PROTECTION

Full activity plans for increased protection of Postonians, have been mapped by Captain Saburo Uyeda and his hardy Life Guard crew, now under the permanent supervision of the local Red Cross.

Day patrol of the canal, creeks, Colorado River and pool; cleaning of the canal and swimming holes for accumulated rubbish and bottles; and widening and deepening of Pool 45 for greater recreational purposes are among season's schedule.

The public is requested to refrain from contaminating canal and pool waters.

HOSPITAL UNDERTAKES HOME NURSING

Calling on the sick-at-homes and offering of practical-nursing advice will be given immediately by the Hospital-Public Health Depts in their Home Nursing Program.

The responsibility for carrying out the program was turned over to them by the Red Cross in order to avoid duplication of services.

POLICE ACADEMY FIRST AID TRAINING

Tamio Yamada, qualified Red Cross First Aider will instruct the Standard First Aid Course for members of the Poston Police Training Academy starting today.

ACKNOWLEDGEMENT

To Mr. Roy Takahashi and his Art Department Staff, sincere appreciation of the local Red Cross is extended for contributions of tri-colored linoleum blocks and printing of 300 Christmas Greeting cards to Servicemen.



ACCIDENT PREVENTION MEASURES

Fire, Police, Life Guards, Jr. Red Cross and Ag Depts were represented at the Accident Prevention Committee meeting held on the 8th at the R. C. Bldg. With Chmn. Teihiro Watanabe presiding, the group decided on the following safety measures being promptly carried out:

- 1) Traffic warning signs on the highway and intersections.
- 2) First Aid kits to all Mess Halls and Block Manager's offices.
- 3) Life guard patrol during school hours at potentially dangerous water-crossings.
- 4) Student traffic guards at intersections.
- 5) Police regulations against

setting of animal traps dangerous to school children.

- 6) Decreasing fire hazards by stove regulations specifying oil containers, stove railings and regular inspections.
- 7) Extra lights within blocks and on streets at "necessary" spots for accident and delinquency prevention.
- 8) Regulations against substitutes for fuses.
- 9) Youth and public education for accident prevention.

Means for swifter communication with the Fire Dept. and Doctors in emergency cases will be studied by the committee.

J.R.C. ALBUMS GO OUT! R.C. NURSES KEPT BUSY

Twenty-one correspondence albums, made by students of Poston One high school, was received by the San Francisco Pacific Area office for distribution to various high schools in Chicago, Detroit, St. Louis, and other middle eastern states, letter addressed to Paul C. Takeda, chairman of Junior Red Cross disclosed.

Mr. Earl K. Peekham, director of the J.R.C. Pacific Area said:

"Please tell your students of Poston 1 high school that we are very grateful for the gift of one of the

albums. We shall keep it here at the office, for display purpose. The remaining twenty albums are being sent immediately to our National Headquarters where it will be paired with schools in the states you requested. We realize the handicaps and lack of facilities involved in making of the albums, and know that they will be more than appreciated by the recipients.

The letter, dated June 3, concluded that since school year is now about closed, the albums will be sent out at the opening of the semester in September.

The JRC organization of the "outside" high schools will soon prepare their correspondence albums in exchange with Poston.

(Cont'd from Page 1) tified Washington. The Red Cross will return the overcharged balance to sender, after proper word-count is made in Washington. The record-time for an ANSWER from Japan-sent cable was 50 days. It usually takes two months or over.

Detailed information on the ways and means of sending messages, and cables will be given at the Red Cross offices at any time, and those residents who have not yet taken advantage of this R.C. service; are welcome to visit the Red Cross today.

Dr. Eugene Lerner, member of the Sociological Research, donated three dollars to Poston 1 high school Junior Red Cross in commending the splendid work done on the Correspondence Albums, by the students of the organization.

"Under prevailing conditions, the pupils have done a very good job--it is beautifully illustrated, and the contents are highly interesting and well-edited," Dr. Lerner complimented.

FINAL REPORT

Financial reports on the Junior Red Cross Bazaar, and School Exhibits, held during the first part of May is hereby made: Unit 1 high school JRC raised \$35.50; Elementary School had \$110.21. In Poston Two school, net proceeds amounted to \$82.44

Camp three, already reported in the last issue, was \$73.36.

Ward 3 in the General Hospital occupied mostly by the issei elders, is operated, efficiently by some eight Japan-trained Red Cross nurses.

Without a complaint of their hard work--these nurses maintain proper care for the sick; relieve the personnel shortage; offer much of the morale-building spirit for the aged, and chronic cases.

Average patients in that ward number between 20 and 25.

Hospital records released show 136 boys, and 132 girls born in Poston since the opening of this Center, to May 31, 1943

BLOOD BANK

The Army and Navy have asked the American Red Cross to produce 4 million pints of blood during 1943. This is more than 3 times the amount obtained from volunteer donors at Red Cross Centers last year.

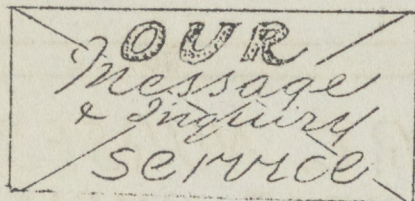

Would you like to send personal messages overseas to Japan, and let your relatives or friends know you and your family are well in Poston camp?

Then send them a message through the Poston Red Cross Message, and Inquiry Service!

Since last October when this department was first introduced, headed by Ray S. Nishioka, the 3 units in Poston have handled to date (June 1) more than 1400 letters, cables---through the International Red Cross. It was further revealed about seventy cables, inquiries and messages were received by the local chapter from Japan Red Cross.

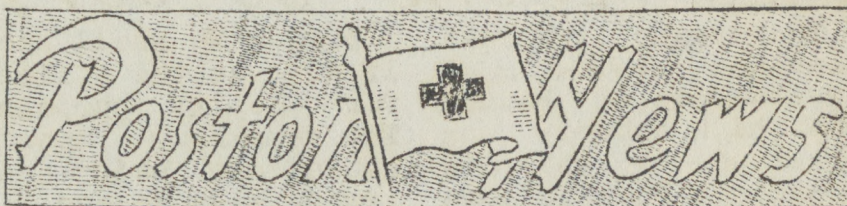
Mr. Nishioka related that, "letters, which are limited to twenty five words or less, require from 5 months to a year to reach the person in Japan via Geneva, through Washington official censorship." This service is done free of charge.

Simple rules are that each family send only two messages at a time; after three months, another two may be sent. Contents should be of family welfare nature, short and brief.

Cables which are unlimited in number of words, require \$15 deposit before it is no-

RED CROSS WARNS RESIDENTS OF "POISONOUS" SCORPIONS

Dr. H. L. Stahnke of Arizona, authority on scorpions-- described the dangers of this type of insect bites, and said there are about twenty different varieties, mostly in the southern part of Arizona state.

Of this, two are found to be very "poi-

sonous" and deadly, and immediate care should be taken by the victim when attacked. Children under two years of age are much susceptible to these scorpion-poisons, the doctor declared.

Symptoms are: Deadly scorpion---victim will not know where the insect has bitten him---will feel weak, and affected parts will become numb. Pain in other parts of the body will begin. The patient become very nervous, nausea starts, and breathing will be short---fainting follows, resulting in death. For Non-deadly bites--victim will find area bitten red, swelling occurs immediately with considerable pain.

First Aid: apply an ice pack on the swollen area, and change often keeping this up for at least three hours. If it is the hand or the leg, ice water in the large pan and ducking the whole area into it, is recommended. But NEVER PUT SALT IN THE WATER! Continue this treatment also for 3 hours, putting the wound in water for 15 minutes; one minute out; then another ten minutes in water; one minute out; then back to ten minute immersion in iced water. Repeat this until the 3 hours are up, and swollen gone.

Twice as many people have died from the result of scorpion bites than from any other insect wounds, in this state, reports told.

ANY MAGAZINES for SICK?

When Miss Elma Rood of the Public Health Department visited the Tuberculosis Sanitarium in Phoenix, she discovered that all patients from Poston were "lonesome and discouraged" and were found without much to

do in ways of diversion. The head nurse observed the sick can benefit in recovering sooner if they were occupied, and refrained from worry.

Miss Rood after her return suggested the Red Cross obtain cer-
