(Affidavits submitted to Justice Department)

After WMC has approved affidavits for submission to Justice, the following is to be done with such group:

1. Assemble in alpha order; U.S. and Japan
Check each affidavit for notary stamp, signature and no. of copies. (U.S. - original and 2 copies to Justice; Japan - original and 3 copies to Justice)
2. Pull cards; type rough name sheet from cards. Check names and birthdates against affidavits. If there are any discrepancies in either names or birthdates, check against joinder list. Names should appear as they were joined.
3. Type RECEIPTS for each group (U.S. and Japan) - 1 and ⁶ copies and type list of names and birthdates (from rough sheet), also 1 and ⁶ copies. (Note: on receipt, for those whose affidavits are being resubmitted, note with an asterisk (*) before name and at the end of the list, type "* Reprocessed." Also note on receipts that the Asst. Attorney's name should be typed in on all copies (not original) - "/s/ Charles Elmer Collett")
4. After receipts have been filed, note on cards "Processed" and the date. Label folders with same information.
5. Address form letter to each person on list; check off as the letters are written (this is done because no file copies are made of this letter and the checks serve as mailing record. For U.S. group, form letters are mimeographed and for Japan, letters should be typed on air letters. *adv to 2 Plaintiffs*)
6. File copies of Receipt; Number one according to "Order of Submission" Record in "Receipts for Administrative Processing" folder, and also enter data of Receipt on sheet attached to said folder. File all other copies of Receipt in "Processed Group - Affidavits Submitted" folder, ~~noting data of Receipt on note paper and attach to Receipts.~~ (Attach copy of mimeo. form letter to U.S. Receipt with proper information noted; attach note paper to Japan Receipt, noting same information.)
