## MINUTES OF THE CENTRAL COMMITTEE MEETING

March 9, 1945

The regular weekly meeting of the Central Committee was called to order by Supervisor, Ted Nakamura, at 1:30 p.m. on March 9, 1943, at the Civic Organization Office, Building 1608.

The roll call was taken and it was found that the following members were absent: Ben Kasubushi, Ward I Secretary, Seichi Tsuda, Ward IV Secretary, and Kenji Ito, the newly-elected Chairman of Ward VII. Mr. Tsuda and Mr. Ito were recorded as excused. Since there are no Block Managers in Ward V at the present, there were no representatives.

Since the minutes of the last meeting has been distributed to all the Block Managers it was not read. A motion was made and carried that the minutes be accepted as mimeographed.

### ANNOUNCEMENTS:

1. In regards to the making of any Co-op announcements by the Block Managers, the Enterprise has requested that it be continued through this week. Thereafter the Block Co-op representatives will make all such announcements, thus, relieving the Block Managers.

2. Mr. Howard Kobayashi has informed the Civic Organization Office that a large shipment of boiler jackets and sectionals of jackets are now on the way.

3. The Civic Organization Office at the present does not have a Route Girl. In order to straighten out the requisition files and to avoid any duplication of requests, all the Ward Chairmen were asked to inform the Block Managers in their respective wards to come to Building 1608 and clear their requisitions.

4. Due to the misunderstanding between the Block Managers and his residents in some of the blocks during the registration period, the Civic Organization Office has left the making of any announcements up to the discretion of the Managers. However, in the case of announcements which the Office deemed important and imperative, it was so designated. The same policy will prevail hereafter and all announcements will be marked "imperative" or "optional". Mr. Nakamura requested that the Managers comply accordingly.

### OLD BUSINESS:

Mr. Jack Okumura requested information concerning the new procedure for the storage and transportation of personal property. Mr. Nakamura stated that the new forms have not arrived as yet. They will be distributed to the Managers as soon as they arrive.



NEW BUSINESS:

Since Mr. Ted Nakamura, the former Central Committee Chairman, has recently been appointed to replace Mr. Robert Ota as the Supervisor of the Block Managers, he asked the Committee whether the election for a new chairman should be held presently or to wait until the new Block Managers have been assigned to those blocks which have no Managers at the present. Due to the precarious position in which the Managers have found themselves during the registration period, some of them have resigned feeling that they could perhaps do more to straighten the confusion which was prevalent at that time by resigning.

Mr. Nakamura stated that after consulting Mr. Fleming they felt that it would be wiser to wait until after the registration is over before appointing the new Block Managers. It was suggested at this time that in order to obtain a capable Manager the block residents should recommend or nominate three or more persons and that the final choice and appointment be left up to Mr. Fleming and Mr. Nakamura after interviewing the persons carefully.

As to the election of the new Chairman, Mr. Nakamura stated that in the past the duty of the Chairman was to keep a harmonious relationship between all the wards and also to attend the ward meetings to obtain informations and suggestions; however, at the present, the organization has been working together very smoothly and informations of the ward meetings are brought to the Central Meeting by the Ward Chairmen. Consequently, in view of these reasons, Mr. Nakamura felt that there is no need for a Central Chairman; but if the Block Managers wished someone to represent them in order to bring complaint or matters of resentments to the Civic Organization Office, a new Chairman should be elected.

After some discussion, the Central Committee also felt that a chairman was not necessary and that all grievances could be presented by the Committee itself. Mr. Nakamura will conduct the meetings as he has been doing in the past.

In order to reorganize and to get the Block Managers back into the working spirit again, Mr. Nakamura suggested that a general meeting of all Block Managers be held. Mr. Fleming is willing to attend and talk to the Managers.

The Committee decided that the meeting should be held on the coming Tuesday, March 16th, at 2:00 p.m. The place will be Building 1308 unless another place is obtained.

In regards to the delay of obtaining shoe ration tickets, Mr. Nakamura stated that application forms were to have been distributed to the Block Managers' offices, but since the ration scrips or tickets have not arrived, the administration felt that it would be wiser not to distribute the forms until such time. The Managers were requested to advise their residents that the forms will be sent as soon as the ration tickets arrive. The administration had planned at first



to take care of any emergency needs but they felt they could not determine who needed them the most.

Mr. Tom Maekawa requested Mr. Nakamura to obtain a new list of the names of the Administration Personnel Staff and distribute to the Block Managers.

Having no further business, the meeting was adjourned at 2:10 p. m.

Block 66's Second General Meeting was held Oct. 12, 1943 in Building 18 at 7:15 p.m.

Block Manager and Chairman, Mr. Nakamura opened the meeting by suggesting self-introduction so that the people of Block 66 can get acquainted. A motion was made by Mr. Masukawa that all residents would as time permit become to know each other, and that self-introduction would not be necessary. The motion was unanimously passed.

Explanation of the Planning Board of this Center by Mr. Nakamura was made as an introduction to the election of a Representative from this Block to the Planning Board. Mr. Tokoro nominated Mr. U. Fukuda, and he was unanimously nominated and elected.

Two Co-op Representatives to be elected was the next topic of discussion. Mr. Nakamura nominated Mr. Sugita. Since no other nomination was made, he was unanimously elected the Issei Representative from this Block. Mr. Inouye nominated Mr. Sakaki as the Nisei Representative, and since no other nomination was made, he was unanimously elected.

Barrack Captains' election was passed for later meeting since they are not needed immediately.

Block Manager, Mr. Nakamura announced that requisitions for brooms, buckets and other immediate household necessities have been made and that they will be supplied as soon as possible.

After discussion whether the laundry drying space should be erected between the laundry and the latrine buildings, it was passed that there would be more convenience of a line behind each barrack. A uniform length is to be made the entire length of each building.

The fuel shortage was next brought to attention. Mr. Kodama a member of this Block has offered to ask his friend if a truck can be available to haul the woods for fuel.

The Block Manager, Mr. Nakamura asked for any suggestions or requests from the Block members present. The following requests were made:

1. A door or entrance on the east side of the laundry or ironing building.
2. Sewing machines for the Block's use.
3. Whether an assignment for a woman-janitor is possible to clean women latrine and laundry rooms.
4. Children's play ground especially during winter months.
5. Lumber for making clothes-closets and other house-room modeling.

After no other requests were made, Mr. Fujii, Block Chief Cook made his report on the present possibilities of opening the Block Mess. Brief outline of his report was as follows:

1. That no serving spoons and knives were available at



present.

2. No meat grinders, cleavers or cooking utensils were available at present.

3. Tables are dirty and not uniform.

4. That the warehouse actually do not have the aboves in stock.

5. As soon as supplies arrive, Block 66 has been promised first service.

Next, the Chairman announced the progress of Japanese schooling in other parts of this Center. Mr. Inouye and Mr. Kuratomi are interested in promoting Japanese schooling in this Block until a definite school system is organized for the Center. Anyone interested in having his children attend Japanese schooling was requested to report to the Block Manager's Office.

The meeting was closed at 8:30 p.m.

The Third Block 66 Meeting was held in Building 6618 at 1:30 p.m. October 17, 1943.

The meeting was called in reference to the weeks two auto accidents. The meeting was called to order by the Block Manager, Mr. Nakamura. It was stated that the belief was that the unfortunate accidents of the week were due to the negligence of the WRA Authorities in charge of the Potor Pool and the Agriculture Divisions.

The purposes of the meeting:

1. To elect a Block Representatives to the Center Meetings to discuss, suggest, and report the improvements and progress of the present major questions and others to be presented.
2. Mr. Kodama reported the incidents that occurred the morning of the Farm Truck accident and what he witnesses of the accident.
3. Suggestions or requests of major importance (e.g. medical supplies, Center sanitations), to be presented and report to the meetings.
4. Announcement of Japanese School made by the respective teachers and Block Manager.

Mr. Kuratomi and Mr. Fukuda were elected as Block Representatives. Mr. Kuratomi reported on what he has viewed on the present major problem and asked for further requests of suggestions to be presented.

Following suggestions were voiced from the floor:

1. Organized and more systematic Departments in the Center.
2. Speed limits and "stop" signs posted where necessary.
3. Re-organization of Motor Pool system.
4. Replace the minor employees of the Center with more capable young men who are willing to work.
5. Requests for clothing and allowance.
6. Necessary medical supplies for this Center.

The temporary Japanese School Schedule in this Block are as follows:

Ages 6 years through 10 years-----Mr. Sugita  
9:00 A.M. to 11:00 A. M.

Ages 11 years through 15 years-----Mr. Kuratomi  
2:00 P.M. to 4:00 P.M.

Ages 16 years and up-----Mr. Inouye  
7:00 P.M. to 9:00 P.M.

Parents' cooperation at home encouraged.

Individuals who do not understand Japanese at all are requested to report to the teacher of Block Manager's Office. Young men and women encouraged to attend Japanese School.

Before closing the meeting Block Manager requested prompt attendance to the Block Meetings.

The fourteenth Block Meeting was called by the Block Manager, Mr. K. Nakamura, December 30, 1943, at 12:30 p.m. in Mess Hall 66. Seventy-nine (79) persons were present.

The purposes of the Meeting were:

1. To clarify any doubts of Mr. G. Nakahiro's status while he was temporary Mess Chef of Block 66.

2. To settle the problems in regards to the "Army Order" concerning the Block Mess Chef.

In order to clarify Mr. G. Nakahiro, a statement had been made up to the effect that after Mess Chef and part of his crew resigned, Mr. Nakahiro was elected unanimously by the residents of the Block as temporary Mess Chef until a permanent Chef is assigned. It had been approved and signed by majority present.

A detailed explanation of the change was made by Mr. U. Fukuda, one of the members on the Block Advisory Board.

Since the present Mess Chef and crews were on two weeks' trial by "Army Order"--because of the present Center's and Block's atmosphere of more important problems, and the possibilities of being moved, the Block Manager, Mr. Nakamura, suggested to the residents that the present Mess Chef and crew continue a while longer. The suggestion was voted unanimously by the sign of raised hands.

MEMORANDUM TO: All Block Managers

SUBJECT: Notice of Sixth Registration

You will please inform your residents who have attained the age of 18 years since July 1, 1942, to report for Selective Service registration in accordance with the proclamation of the President of the United States, as follows:


(a) Those who were born on or after July 1, 1924, but not after August 31, 1924, shall be registered on any day during the week commencing Friday, December 11, 1942, and ending Thursday, December 17, 1942;

(b) Those who were born on or after September 1, 1924, but not after October 31, 1924, shall be registered on any day during the week commencing Friday, December 18, 1942, and ending Thursday, December 24, 1942;

(c) Those who were born on or after November 1, 1924, but not after December 31, 1924, shall be registered on any day during the period commencing Saturday, December 26, 1942, and ending Thursday, December 31, 1942;

(d) During the continuance of the present war, those who were born on or after January 1, 1925, shall be registered on the day they attain the eighteenth anniversary of the day of their birth; provided, that if such anniversary falls on a Sunday or a legal holiday, their registration shall take place on the day following that is not a Sunday or a legal holiday.

Registration place on the Project is hereby designated as Recreation Hall in the rear of Canteen No. 4, from the hours of 9:00 a.m. to 5:00 p.m. daily.

MEMORANDUM

To: Civic Organization, and Block Managers  
From: R. R. Best, Project Director  
Subject: Reorganization of Colonial Police.

The Administration has been advised that the Colony Police Force resigned effective July 20. The reason given is that the Administration would not permit Civic Organization and the Block Managers to be used as an agency to develop popular support for the Colony Police. The Administration felt that the Block Managers could not comply with this request without indulging in political activity.

It is now necessary to reorganize the Police Department. In this organization it is felt that the Department will serve its best purpose by the residents of the Colony itself.

It is, therefore, requested that the Block Managers accept the responsibility for calling block meetings within their blocks to advise the residents of the situation. The residents of each block, either in a block meeting, or through barracks captains, or by any other means which they feel is satisfactory, are requested to select two persons to represent the block on the Colony Police.

It is intended that each Colony Policeman to be selected will have the primary responsibility of doing the police work within the block from which he is selected or at least within the ward within which he resides.

Some adjustments will be necessary to take care of such contingencies as tours of duty, relief, time off, and staff work. After the initial organization of the new Colony Police Department it is contemplated that some members of the newly selected staff will show a qualification for the performance of staff duties. In the event such duties are assigned then the block from which this person was chosen will be asked to select his substitute. It is proposed that the newly selected Colony Police force will be asked to elect from among their own number the key people of the force, including Chief of Police, Assistant Chiefs of Police, Captains, Lieutenants, and Sergeants. Any vacancies thus created in block selections are expected to be filled by new selections from the block concerned.

Those persons selected by the blocks will be accepted by the Administration without question, and will be assigned to the Colony Police force. Their work orders will be processed through the Placement Office and they will become employees paid by the Administration at the regular classified wage rates. If in any case the selection involves a transfer from another Section or Division the transfer will be processed through the Placement Office.

It is requested that the names, addresses, and identification numbers of persons selected within each block be referred to Civic Organization office not later than 4:00 p.m., Monday, July 24, 1944.

MEMORANDUM TO: All Block Managers  
FROM: From Joe J. Thomas by order of Mr. Best  
SUBJECT: Unauthorized Construction

The Internal Security has been instructed to stop all construction work within the colony on any apartment, or any building, unless such work has the written approval of the Engineering Section.

All requests for alterations, additions or changes must first be requested through the individual Block Manager and then approved by Joe Thomas, Superintendent of Housing.

These requests should contain the following information:

- A. Block and apartment number.
- B. Sketch showing location and size of addition or improvement.
- C. Statement of what material is required.
- D. Statement of where material is to be obtained.

No changes in electrical wiring or stove location is allowed to be made by colonists. If changes are necessary and are approved, they must be done by the Engineering Section.

Final approval for any changes, improvements, or additions must be obtained by Joe Thomas from the Engineering Section.
