

Fujimoto voluntarily evacuated Area #1 during latter part of March, 1942. He had been leasing and operating a farm near Arroyo Grande, San Luis Obispo County, owned by O. E. Withrow. Before leaving Arroyo Grande, Fujimoto gave one James Nakamura a power of attorney covering his interest in the crops planted on the Withrow place. Nakamura was evacuated in April and is now (July 27) in the Tulare Assembly Center. Before leaving Nakamura entered into negotiations with one Brown for the purchase of Fujimoto's equity; Brown was to apply for a FSA (Wartime) loan and pay \$150.00 for the equity. Fujimoto produced a letter from Geone Buckley, Field Agent, Santa Maria, dated May 19, 1942, which stated that he expected the FSA loan to be granted within a few days. Evidently this loan was never granted as the FSA Regional Office has no record of such loan under the name of Brown.

Dear Mr. Class:

I have your letter written on behalf of Mr. James K. Mano, on the subject of our letter informing Mano that he owed a balance of \$2.84 on his tractor contract that would have to be paid before we could return to him his contract.

I do not know what Mano's remittance receipts show, but our records show that a payment of \$204.42 was received by us on July 15. It is true that the contract showed that balance due on July 15, 1942, but Mano's records do not disclose, apparently, that the \$2.84 for which he was billed is interest on former delinquencies, not on the July 15 instalment. No doubt you have a copy of his contract at hand. If so, please check the following:

The April 15, 1941, payment was paid on April 28, 1941, and applied \$184.42 on principal and 53¢ on account of interest from April 15, the date due, to April 28, the date paid.

The September 15, 1941, payment amounted to \$189.30. On December 5, 1941, Mano forwarded to us a check for \$191.00, which was applied \$3.40 on the delinquency of \$189.30 from the date of September 15, 1941 to December 5, with the balance of \$187.60 applied to principal.

The February 15, 1942, payment amounted to \$195.94, and on March 20, Mano forwarded us a remittance of \$196.35, which was applied \$1.22 on account of interest on the delinquency in the making of the payment, and \$195.13 on account of principal.

You will note that on former delinquencies the sum of \$5.15 was charged. This amount is reduced as to the balance of the contract by slight overpayments in remittances received which were insufficient to cover interest demands.

We continue to carry the contract and hold legal title to Mano's equipment. You might be interested to know that on March 20, 1942, we had considerable difficulty in getting the February 15 instalment paid. The contract was signed by James K. Mano and K. Mano. The alien of these two was apparently picked up and lodged in a concentration camp. The son apparently neglected his farming in the knowledge that he was going to be evacuated, and ignored our letter demands that he clean up the contract. We finally sent the equipment dealer up to pick up the equipment, and while he was at the farm Mano agreed to send us the check received March 20. He also informed the dealer that he was turning the equipment over to his


landlord, who would pay out on the equipment as provided under the contract. All of this was irregular under the Federal Reserve Bank instructions that accounts should be collected from Japanese evacuees in full before evacuation.

Mano ignored these demands, and we were compelled to carry the contract on to maturity in spite of efforts being made to clean up Jap accounts before they evacuated.

Under the circumstances of a continued lack of cooperation extended to us by Mano on his contract, we have no sympathy with him, and we should like to have this small balance paid. Anything you can do towards effecting this collection will be appreciated.

I trust the explanation outlined will satisfy your inquiry on the subject of the balance owing.




