BUREAU OF PERSONNEL AFFAIRS

Section 9A of Public 252 - 76th Congress, approved August 2, 1939, otherwise known as the "Hatch ACT," provides:

"(1) It shall be unlawful for any person employed in any capacity by any agency of the Federal Government, whose compensation, or any part thereof, is paid from funds authorized or appropriated by any Act of Congress, to have membership in any political party or organization which advocates the overthrow of our constitutional form of Government in the United States.

"(2) Any person violating the provisions of this section shall be immediately removed from the position or office held by him, and thereafter no part of the funds appropriated by any Act of Congress for such position or office shall be used to pay the compensation of such person;"

It is provided in various appropriation acts that no part of the funds so appropriated shall be used to pay the salary or wages of any person who advocates, or who is a member of an organization that advocates, the overthrow of the Government of the United States by force or violence, and that an affidavit shall be considered prima facie evidence that the person making the affidavit does not advocate, and is not a member of an organization that advocates the overthrow of the Government of the United States by force or violence. Such acts provide further that any person who advocates, or who is a member of an organization that advocates, the overthrow of the Government of the United States by force or violence and accepts employment, the salary or wages for which are paid from any such appropriation, shall be guilty of a felony, and, upon conviction, shall be fined not more than \$1,000 or imprisoned for not more than 1 year, or both, and that the above penalty shall be in addition to, and not in substitution for, any other provisions of existing law.

EMPLOYMENT AGREEMENT
Contract No. 1351

October 29, 1943

The War Relocation Authority, hereinafter referred to as the Employer, hereby offers to hire _____ for the performance of work as hereinafter described. The Employer represents and agrees with the respect to said Employment:

1. The work will consist of the harvesting of potatoes, carrots and such other crops as will be designated by the Employer. The main work will consist in the harvesting of potatoes.
2. The Employer agrees that work may begin immediately upon arrival at the place of work and the period of employment will be from one month to six weeks or may be earlier terminated because of freezing weather preventing the continuance of work. Workers may put in up to ten hours a day if they so desire and if the weather permits.
3. The Employer agrees to pay the following wage scale which will be prevailing rates or better:
 - a. 90¢ to \$1.00 hour for general harvesting work.
 - b. 15¢ per sack of potatoes on a piece rate basis.
 - c. Prevailing wages or better for cooks and kitchen helpers and all other work.

The Employer represents that these wages are not less than the prevailing wages of the locality and not less than any minimum wage required by law. Furthermore, the worker will upon arrival at the place of work be assigned as regular WRA employees with all the benefits thereof.

4. The Employer agrees to provide room and board to cost not more than \$1.00 a day per person. Meals will be prepared by evacuee workers and rooms will be provided in army tents located about 3½ miles from the Tule Lake Center. These tents are equipped with stoves, cots, mattresses, floors, and other items necessary for the comfort of the workers.
5. The Employer agrees to provide transportation for the workers from Poston, Arizona, to the place of work and transportation from the place of work back to Poston upon the termination of the work agreement. The worker will be provided meals enroute. The transportation will be in special cars coupled to regular trains, said cars to contain a minimum of 25 men and a maximum of 50 to be accompanied by a Caucasian escort, appointed by the War Relocation Authority.
6. In the event of illness or injury, the Employer agrees to take the necessary steps to insure immediate attention to the worker by the nearest physician or treatment at the nearest hospital.
7. The labor conditions of this employment agreement has been approved by the War Relocation Authority, and the community sentiment of the location of work has been checked as being favorable.

8. The worker will in no event be permitted to leave the place of work to visit either the Tule Lake Center or any of the neighboring cities or towns. He shall at all times be expected to remain at the place of work, movement from said location being prohibited even under escort. This is because the location lies within the Western Defense Command Area and movement is restricted by military decree. These restrictions likewise necessitate a military guard around the place of work.

Note: It is to be understood that this work must be performed immediately in order that the vital potato crop at the Tule Lake Center be harvested before the onset of freezing weather or an unexpected early frost. The harvesting is essential in that \$500,000 worth of unreplaceable crops which are designated as part of the food consumption of the WRA Centers, is in danger of ruin. Because of a prevailing strike at the Tule Lake Segregation Center, workers who were originally intended to harvest these crops are now unavailable. The performance of the foregoing offer will not constitute "strike breaking" in as much as the harvesting of these vital crops has nothing to do with preventing or prolonging the strike, nor does it affect the residents of the segregation center in any other manner. The need for workers is an immediate urgency, time being the important factor. By doing your share in preventing the loss of this crop, you are making an important contribution to the welfare of the residents of the nine WRA relocation centers, as well as attesting to your loyalty to the United States.

TO FAMILIES WHO HAVE APPLIED TO JOIN RELATIVES IN A SPECIAL INTERNMENT CAMP

The following information has recently come. It is not new but makes previous statements somewhat clearer:

1. There will be no leaves from the Family Internment Camp except for study and for medical care which cannot be given in camp. In such exceptional cases each will be decided individually. There is no general rule for leaves.
2. The quarters occupied by individual family groups are small and the space in which personal property may be stored is limited. Each family of two adults will be allowed to bring not to exceed seventy-five cubic feet of personal effects with an additional fifteen cubic feet for each child over five years of age.
3. It will often be necessary to require teen-age children to sleep in dormitories established in close proximity to the quarters of their parents.

Families unwilling to accept the above conditions should not apply for voluntary internment.

In regard to an individual case, information came that the camp is for "wives and dependent children" of interned persons. We do not know who will be included in the classification, "dependent children."

We have no information as to when the next group will go to the camp nor as to who will be included in it.

Our records show that the following members of your family have made application for admission into a family internment camp.

Circular to Evacuees who are leaving War
Relocation Centers

Under war conditions in America, most foods and many commodities are rationed. To obtain canned fruits, vegetables, fish, meats, butter, cooking oils, fats, sugar and shoes, you will need ration stamps. Each person who lives in the United States is entitled to one ration book of each kind for his own use. It is a criminal offense for any person to apply for, or to use more than one ration book of each kind for his own use. In order to keep yourself supplied with your share of rationed foods and commodities you will need a ration book.

The Office of Price Administration has the power to, and will designate what stamps are to be used for which foods or commodities and the dates on which these stamps may be used. Newspapers and radios all over the United States will keep you informed on what stamps can be used and on what dates. Stamps not used on the dates designated become void and cannot be used.

Ration books are numbered I, II, and III. Books I and II will be given you on your release from the War Relocation Center. Book III you must apply for yourself just as soon as you reach your permanent address. Book I has a different type and kind of stamp in it from Books II and III. It has been designated as the book you will use to secure your sugar and your shoes. Watch the papers for the dates and the number of the stamps in this book that can be used.

Book II has been designated for meats and fats and for processed foods. Red stamps are for meats and fats, canned fish, oil and butter. Blue stamps are for canned fruits, vegetables and foods prepared from them. You have been given a pamphlet telling you how to use the stamps in Book II. Read it carefully.

Book III is not now in use, but will be used as a replacement for Book I and II when they are used up on or about September 12. Watch the papers for its designated use. To get your War Ration Book III go to the War Price and Rationing Board closest to the place you are going to make your permanent home. The clerks there will give you all the necessary information and the proper application blanks to fill out. War Ration Book III cannot be issued to you anywhere except at your permanent address. Make application immediately upon arriving at your permanent address.

P R O T E S T

Solely because of the ruling of Mr J G Fitzhenry, Traffic Manager of War Relocation Authority, contained in his letter of December 30, I am rendering this bill for transportation on a land grant rate-reduction basis. I do this, however, under protest. We do not concede that this is the property of the United States, nor that it is military or naval property. Our purpose in resubmitting bills on the land grant basis is solely because of this ruling and of our charges. We shall expect to follow those resubmitted bills with supplemental bills for the difference between the land grant rates and applicable commercial rates, and shall expect to pursue them through to final determination, through the General Accounting Office, the Comptroller General, or the Court of Claims.

In accordance with a recent announcement of the Director of the War Relocation Authority, it is now the policy of the Authority to locate in a separate relocation center those persons of Japanese ancestry presently residing in various relocation centers who prefer to live in Japan, or whose declarations have indicated that their loyalties lie with Japan during the present hostilities, or that their loyalties do not lie with the United States.

This position has been taken in order to promote the general welfare and to provide a place of protection for those evacuees who are known to favor the cause of Japan.

You have by your acts or declaration indicated that you desire to live in Japan or that you are sympathetic to the war aims of that country, or that you are not loyal to the United States.

It will be necessary that you transfer to the Tule Lake Center. You should discuss this situation with your family group and make an appointment with the welfare section for an interview. The appointment for this interview should be made immediately. At the interview with the welfare section, you should be prepared to indicate what the members of your family have elected to do -- whether they will accompany you to the Tule Lake Center, or whether they will remain at this center. Plans for family welfare should be discussed.

After a decision has been made in regard to the plans of your family, you will be notified of the date that transportation has been arranged for you, and certain other important items of information regarding the preparations for travel and transfer.

Evening Business School

The Night School Division of the Education Department is making preparation to offer the following evening commercial courses in each camp, providing sufficient numbers of interested students register. Each class will be of two hour duration and will be offered twice a week.

The courses to be offered are:

1. Beginning typing
2. Intermediate typing and office practice
3. Advanced typing and office practice
4. Beginning bookkeeping
5. Advanced bookkeeping
6. Beginning shorthand
7. Advanced shorthand

Registration will take place in the office of Adult Education, Block 36 Recreation Hall "C", Block 210-14-G, and Block 310-13-A, on Saturday, October 9, from 1:30 to 4:00 p.m.

The Project Outside Employment Office is constantly being referred secretarial opportunities on the outside. Most positions in urban areas pay \$25 a week to start for a person with good background and this means good business training. Although most office positions normally begin with \$25, there is no limit to the amount of responsibility, and consequently, raises that will be forthcoming after a short period of employment. Some bookkeeping positions are available starting from around \$140 a month.

Civil Service will likewise provide an excellent opportunity to qualified applicants. Beginning salaries for Junior Typists and stenographers are \$1,140 a year or \$120 a month. Nisei girls are continually being placed by government agencies in Washington and other cities.

These evening courses will afford the opportunity to become qualified for secretarial, stenographic, bookkeeping, and other office practice. It will also be an excellent means of brushing up on typing or shorthand that may have become rusty.

In connection with your employment in seasonal work, it is believed that information concerning the conversion of your seasonal leave to indefinite leave, together with advice regarding financial assistance which might be allowed you through the WRA, would be helpful to you.

Application for indefinite leave must be presented through the relocation officer of the area in which you are employed and, if financial assistance is needed by you in order to take advantage of new and regular employment in connection with your indefinite leave, such application should also be made through the relocation officer. This officer will transmit your application or applications with his recommendations to the project director of the relocation center from which you came. Action will then be taken by the project director, and the indefinite leave permit as well as financial assistance, if granted, will be sent to you through the relocation officer who transmitted the applications. It should be pointed out that all applicants for financial assistance will not necessarily receive it. However, there are a great number who, because of one circumstance and another resulting in inability to save money on seasonal work, will be able to qualify.

While the WRA, as stated above, may allow you financial assistance in getting started with your indefinite leave employment, when this initial financial help is given, no more help of this kind can be expected from that source. Should further assistance be required, you may make application to the local Public Welfare Agency in the community in which you are working. The relocation officer will advise you in such regard.

Return to centers before completion of the seasonal contract is discouraged. However, unless indefinite leave has been granted to replace seasonal work leave, you must return to the center by the expiration date shown on the leave or any authorized extension thereto. Return to centers in restricted military areas can be made only when an escort is available.

It is hoped that the suggestions herein may prove helpful, and it is also hoped that through experience and contacts afforded you in your seasonal work that you will be able to find employment that will enable you to relocate yourself and your family in a way that will bring you satisfaction.

Excellent--outstanding in all important job requirements and not below satisfactory in any respect. (Promotable one salary step within grade.)

Very Good--~~more~~ than met job requirements, and not below satisfactory service in any respect. (Promotable one salary step within grade.)

Good--~~met~~ all job requirements and, everything considered, has given satisfactory service. (Promotable one salary step within grade, up to and including the middle rate of compensation in the grade.)

Fair--generally acceptable, but in some essential respects not offset by performance in other phases of the work, has not come up to job requirements. (Salary must be reduced one step if above the middle rate for the grade.)

Unsatisfactory--failed, on the whole, to meet the job requirements. (If the rating covers 90 days or more, employee must be removed from his position by transfer, demotion in grade, or dismissal.)

In addition to being promotable, as the word is used above, an employee must meet certain legal requirements as to length of service and recency of promotion to be eligible for a salary advancement within a grade. These statements do not apply to promotions from one grade to another.

The Project Employment Division extends its greetings to you and hopes that this letter finds you well and happy in your life outside.

Because Re-Relocation is a known eventuality for the major portion of Americans of Japanese ancestry, we are devoting an "all-out" effort towards their early re-establishment in the scheme of things outside. In our efforts, however, we realize that mere advertisement of job offers and generalized statements regarding their favorable aspects hardly suffice to arouse and nurture the sincere interest of the project evacuees in the whole Re-Relocation program.

We realize that we must disseminate information of a more familiar nature which will have a direct meaning to each and everyone of the prospective "out-going" evacuees.

In this respect, there can be no more helpful information than a survey of individual and family budgeting on the part of those who have gone out from the project. The problem of making a living is most fundamental and information regarding the actual dollars and cents expenditures incurred in wartime living as against income earned would have inestimable value in orienting them to the scheme of things which they must sooner or later enter.

Your vital cooperation in filling out the enclosed form to the best of your ability is being asked because we know that you, as a representative member of the much publicized Japanese evacuees, are the only one who could have a real interest in their future welfare - an interest in them far more than as commodities on the labour market.

We trust that you will cooperate with us.

No identity will be divulged on the returning form.

Since receiving the enclosed communication from Dr. Beatty, arrangements have been completed for students to receive credit in California state colleges for work done at Poston. A number of students are planning to apply at the end of the summer for credit for all completed during the year and at the Fort Apache session. One student has applied and received credit at San Jose State College for work done in the Valley School Training Program, summer, 1942 and for supervised teaching on the project at Poston. The transcript reads as follows:



Upon checking your individual record in this project we find that you have returned to this project from the outside recently and failed to return your War Ration Books No. 3 and 4 to this office.

For your future information following are excerpts from the instruction received from the Office of Price Administration "The Office of Price Administration, in Article 17, of General Ration Order Two, has laws which definitely state any person entering an institution of fifty or more persons must surrender his ration books to that establishment, and that the institution must deduct stamps from the books for the time the person eats at such establishment, which stamps are turned over to the local rationing board. The War Ration Books, with stamps detached as required above, must be returned to the persons from whom they were received when he leaves the establishment. The reason for this is clear - the government, in the case of the WRA, has supplied points for the purchase of food for the various individuals eating in the messhalls, and for a person to retain his ration books would be a direct violation of the law."

This is not a law made especially for the WRA, but applies to any establishment in the United States, serving fifty or more persons a month at a regular mess, so please give this matter your prompt consideration and return your Ration Books to the local Ration Board, located in the Project Leave Office, without moment's delay.





The Office of Indian Affairs, under which the Colorado River War Relocation Project is administered, has designated me as Accountable Officer for this Project for property accountability purposes. Under rules and regulations promulgated by the Secretary of the Interior and the Office of Indian Affairs, I am authorized to request you to furnish an appropriate bond to me since you in your capacity of _____ are responsible for the care and preservation of Government-owned supplies, materials, and equipment.

Contrary to popular belief which has grown up in the Indian Service for many years, property for accountability purposes has been classified in three major groups: (1) fixed property (2) equipment, and (3) supplies and materials. Under the first classification, items such as real estate, buildings and structures, irrigation, water, sewer, gas, telephone and electric systems, stationary machinery, and equipment permanently installed and affixed to buildings such as boilers, water heaters, etc., are included.

Under equipment such items as automobiles; implements; vehicles; machines of all kinds; medical, surveying and scientific instruments; tools, utensils; furniture, etc., are included.

Under the third classification fall other commodities which are actually consumed or used up in operation, maintenance, manufacture, or construction. Typical items are food, clothing, textiles, drugs, medical supplies, stationery, fuel, lubricants, oils, gasoline, builder's supplies, and the like.

It will be seen, therefore, that for accountability purposes there are no longer the two main classifications, viz., non-expendable and expendable property. One of the prime requirements of the property regulations is that unless all property is properly accounted for, it is necessary to hold officers and employees of this Project financially responsible, and they will be required to reimburse the Government for any shortages or losses of property unless relieved of liability through the proper procedures.

Regulations under which we operate require the establishment of a Board of Survey consisting of five members, three of whom will constitute a quorum. This Board of Survey will be appointed and appropriate notices issued in the near future relative to its establishment. The duties of the Board and its relationship to the various officers and employees of the Project are fully outlined in the Property Accounting Regulations issued by the Secretary of the Interior. Copies of these regulations should be in your possession and studied from time to time to see that the various requirements thereof are complied with by you and employees under your jurisdiction who are charged with the responsibility of caring for and preserving Government-owned property. Copies of these regulations may be had by a request addressed to the Property Custodian.

Your attention is particularly invited to section 6, paragraph 5, supra, which reads as follows:

"Upon separation or transfer of an employee having custody of property, a complete inventory thereof should be made and if everything is accounted for satisfactorily, a clearance will be given. Certification for final salary payment should be withheld until this clearance is obtained."

There is attached hereto a sample form of bond for your use in making application to your own bonding company. In requesting your bond you should ask the bonding company to furnish a copy of the power of Attorney showing the authority of the person who signs for the bonding company, and a statement indicating that such Power of Attorney is on file with the Clerk of the United States District Court in the state in which the bond is issued. A statement should also be requested from the representative of the company to indicate that their company has been approved by the Treasurer of the United States, and that their company is authorized to do business in the State of Arizona, having received permission from the State Corporation Commission.

It is requested that this bond be filed in the amount of \$ _____ at the earliest possible date, but in no event later than April 15, 1943.
