THE MINUTES OF THE RED CROSS MEETING
held at Recreation Hall #10

ATTENDANCE: Mr. Alston, Mr. Thorpe, Mr. Kim Obata, Miss Emily Minton, Mr. Lorne W. Bell, Mr. Sus Yamashita, Mr. Yoshio Katayama, Mr. Clark Harada, Rev. Kumata, Mr. Robert Iki, Mr. Frank Yamasaki, Miss Toshi Koba, Mr. Hikoyeda, and Mrs. Takahashi.

Mr. Kim Obata opened the meeting by introducing Mr. Ray L. Alston and Mr. Thorpe, field representative from Salt Lake City. The purpose of the meeting was to discuss the feasibility of organizing a Topaz American Red Cross unit here with all its phase in Red Cross work.

At this time, Mr. Alstn took over the meeting. He said that they were interested in the activities which canbe worked out under Red Cross and to have participation just as much here as nay other place in our country.

"In the matter of determining whether you want the Red Cross established among us we want to be perfectly free in deciding that and the way in which it can be done. Red Cross is a membership organization and anyone who is a member of the Red Cross has an opportunity to participate in it and the business, organization of it, and carry its services to everyone. Mr. Thorpe is the general field representative who has this particular part of the state to work with among the units. He will be looked to in the future to give service here. I will outline briefly the general plan of organization and activities that the chapter unit might develop."

"First, to try to get the Red Cross developed as much as possible and get as many representative as possible as the unit is organized. This organization includes a chairman, vice-chairman, treasurer, and secretary as an administrative officer with the chairman of Services. Those two group with any other representative may constitute the Board of the Unit, the board being the governing and policy making body of the unit. The activities are perhaps for disaster, natural disaster (perhaps the hazard may be a fire). There are problems of home service--family welfare problems, first aid, accident prevention, home nursing, nutrition, Junior Red Cross. These are listed among the regular services. The Junior Red Cross being the Red Cross in the schools under a little different arrangement of membership and organization by participating in all the regular Red Cross activities that can be participated on the level of the school children, elementary and high school."

"A special group of volunteer services which include the production work (sewing, knitting, production of surgical dressing, canteen corp, the nurses' aid, staff assistants, motor corp, hospital and recreatin corp, assistants to the case worker and family problems) is another function of the Red Cross."

"In setting up a unit the procedure is this: that some of the membership in the community there shall be elected at least as tentative officers who will petition to the American National Red Cross (in San Francisco), the administrative unit over this territory, for official recognition of the Red Cross in this community. When that recognition has been given, then we proceed to operate officially, expanding the organization to meet the needs."

Mr. Obata said that the reason why he had asked all the people to come in this morning was that he thought that a Red Cross unit fits every one of our units here in Topaz. The wardens, firemen could come in as a unit; home service, Social Welfare department; general first aid, Adult Education and compulsory for Block Managers, wardens, firemen, and all recreational leaders; accident prevention, Public Safety Wardens, public relation, and newspaper, and recreational leaders; home nursing, hospital staff; nutrition, dietician; Junior Red Cross, education. This was a recommendation and since it hits everybody here in camp all of us would realize the value of it. The topic was open for discussion.

Mr. Clark Harada asked if medical supplies would be available from the Red Cross if case there is a need for it. Mr. Alston said that supplies for the regular use of the community are provided by the government and it may be that that is the source to go to. He himself did not know for sure.

Mr. Katayama said that the Red Cross sent 3,000 messages from Tanforan and this would come under Home Services. This service is free of charge. Mr. Thorpe commented on the arrangement of home service. The field director of the American Red Cross are stationed at all post with soldiers and in addition to that the International representatives, all in foreign countries. That group of the Red Cross has primarily the contact work with the boys in the service and the families in the area where the field director is located. That is one division. The contact with the family at the home is carried on and conducted by the chapter so that when you organize a chapter it is the responsibility of the chapter to take care of our contacts of the family with the boys in the services. That makes an important item in organizing a local group if you have boys in the services. The local group is the contact through the boys in the services or civilians through civilians in other countries. It would pass through the American Red Cross or the International Red Cross.

Rev. Kumata asked in the event that the chapter shall be made here what will constitute the membership of the chapter and the elements of the membership before that chapter shall be recognized.

Mr. Alston said that it is assumed that a great many of those in camp are members already. When you organize a chapter in any particular area, 15 is the minimum so that there isn't much handicap there. Rev. Kumata brought up the point that there are some people who were members in San Francisco and asked if they could be transferred. Mr. Alston said that they had automatically been transferred over here. Those who are members may be officers and

participate in any activity here and go on in the continuation of the chapter business. The regular period for membership being taken in the Red Cross is usually in the fall and in November of Thanksgiving Day, but this year they are leaving that period and going into March so that it won't be until March of next year that there will be any membership enrollment. At that time in every chapter and unit all over the country will be carried on the War Fund Campaign which will include membership, those subscribing a dollar or more would obtain the membership. A dollar a year is the minimum fee. This year it will be called War Fund Campaign instead of Roll Call.

Mr. Obata asked if there were any other fee connected with the membership. The reason why he wanted to know was because finances are very limited in this camp. For the campaign for next March it is planned that the budget for the year for the chapter will be worked out as nearly as can be done. Then the National organization will budget for the year for the chapter will be worked out as nearly as can be done. Then the National organization will budget its national activities and pro-rate that to each chapter, depending upon its population. Other factors will be considered and that quota for national plus that local budget for the unit will be the campaign goal in setting up a goal. These planning in respect to goal is the campaign. Anyone subscribing to that Campaign Fund of a dollar or more will be a member in the Red Cross. The membership and the War Fund which is obtained at the time during March will finance the whole program together with the share of the national program. Altogether, 50% of each membership has to go to the National to take care of the National expenses, leaving the other 50% of the dollar membership or \$4.50 of a \$5.00 membership for local work in the local treasury. It will be based on the other arrangement next March. If that is raised exactly, then the local chapter can keep what is in the local budget and send to the national what was raised for the national share. If less, it will be in proportion to the ratio.

Mr. Iki asked if there were any restrictions to citizens for membership or holding office. Mr. Alston said no. The adult organization includes all adults. The children who are in school should belong to the Junior Red Cross and that enrollment is taking place this fall and is in basis of enrollment. The fee is 50% a room for the elementary schools which pays for the subscription of the news that comes into the school room to be used in the working of the program. That together with participating in a service program constitutes the membership in the Junior Red Cross.

Mr. Iki asked what constitutes an adult. Mr. Thorpe replied usually an adult is someone 18 years or over, those who are past the school age. For those who are in high school, the membership fee is \$1 for a hundred people. There is another point there that might be important. It is not a money-making proposition that goes on and on. They make one drive a year. You do the best you can in getting the quota. The Chapter has that money in trust and if unforeseen things come up where you have to perform your obligations and the funds are exhausted in the Chapter through legitimate Red Cross work, the funds of the National is made available to the Chapter. The goal is the total for the year.

Question was asked as to how the funds were disbursed. That has been 50¢ for the National and 50¢ for the local. Anything over that goes the same way. The work is all in favor of the chapter that has the work to do. The plan is to operate on a safe yearly basis. It is not a plan to set up reserve. There is enough confidence in the people, confidence enough in the Red Cross to carry on the work as we go year by year. The plan is to budget safely as nearly as we can and then plan and utilize that in service in the way it was planned. Mr. Alston stated that they were interested in the approach, to everyone in the community for their share in the matter, sharing in the providing for the service, and share in the membership in the Red Cross. Universal participation is the thing that is striven for mostly as well as for finance.

Mr. Thorpe said that one thing the Red Cross is noted for is the voluntary participation of all the people in the work. You very seldom have a paid worker in the Red Cross. People who would like to train as instructors are trained by the National Red Cross. Those people go out into the community and do the teachings without any cost. Within a compact community like this there isn't that expense that you might think there is because of the magnitude of the program. The Red Cross is the first organization that came in the social work. "For Humanity's Sake" is the slogan of the Red Cross.

Questions were asked concerning sewing materials for the soldiers. Mr. Thorpe said that sometime the chapter buy the material and the layettes. There is the quota of the National to be made by the area office and that is broken down by the organization and the materials are sent to the organization. The materials are free.

Mr. Alston said that the anticipated needs of the local community in the production work would be a part of the local chapter's responsibility to provide. Service to the outside, the men in service, there is always production program to the able bodied men in the service and to the men in the hospital.

The yarns for the sweaters and mufflers are sent in the by National. Goods for war relief are also sent in by the National. Comfort kits that go to all the men going overseas, the National provides the material for making the bags and the local chapter participates in the filling of the bags. In case you have boys in the services here, it is your obligation to take care of the families of the boys in the service. That is the Chapter's responsibility. That is a legitimate expenditure for the funds of the chapter. But they have the emergency closet that is available to civilian emergency. In there you have your layettes and the things of that nature.

Mr. Umeta said that the attitude of the people here is: Why should we make clothes for other people when there is a need here. It all hinges together because lots of people are saying that WRA should supply us with everything. Mr. Alston replied that it all hinges in with everything. Mr. Alston replied that it all hinges in with the government service and the social service in the community. Mr. Thorpe stated that there is a very important point regarding civilian relief, with relief program of the American Red Cross.

This is the idea of the Civilian relief program. If you have a welfare agency which gives relief, have a Japanese aid society, and there is any form of civilian relief that needs emergency relief, that is where the Red Cross comes in. The Red Cross does not come in and duplicate the work of agencies. There should be no civilian sufferers in American Red Cross chapter. No civilian should suffer. The Red Cross is not a relief agency. It does not take care of things for a long period. Mr. Thorpe said that if a chapter is organized it is nice to have a membership but nobody will be barred from participation. The membership of your organization now will be from the membership which you had from the other areas. For the operation from now till March either one or both things can be done.

1. For what services are carried on and the little expense that there may be involved in them, do it out of the funds that you might contribute now yourselves if you want to be entirely independent and not have any financial assistance from the National Organization.
2. You can bring it up to the National organization and say that there are no funds here and say that it is not advisable to collect funds. Then send in a budget for that area office and apply to the area office for supplementation until the next time.

During a campaign containers can be put out and coins can be dropped in, but this is an individual thing and solicitation should be made a personal thing. Whoever contributes a dollar or more should carry their membership card which they can carry with them. That's the idea of Red Cross. Another idea of the Red Cross certainly is that everyone may participate in service to the Red Cross. Whether there are 15 or 15,000 members, all may participate in any part of the program of service.

Mr. Katayama, in explaining the way it was worked out in San Bruno, brought out the point that the average contribution is from \$3 to \$5. Mr. Alston said that the plan is to work directly with the National and become a unit of it.

Mr. Thorpe said that he had an idea that we were not going to be hit very severely on drives and another thing is that we are stressing the membership idea. Don't think in terms that you have to get membership from 8,000 people. That would be \$8,000 and there are chapters doing wonderful with only \$2000 budget for a year. He thought that the people were thinking too far ahead when they thought that about the money situation. The financial end of it shouldn't cause much worry.

Mr. Yamasaki asked if there was general Red Cross representative in this camp. He said that irregardless of the money involved, we should have a Red Cross representative here because there are aliens here. Money should not be considered at all. Miss Minton said that the important thing is to get the board and one of the responsibilities will be this very matter of finance.

Mr. Obata asked for suggestions for any other persons to get in contact with and have a really organized planned-out program before going ahead. Mr. Alston suggested that either this group or the nucleus of this group should be the group to submit a request for recognition to the National organization. Also that there should be a committee from among this group to plan out those matters and submit a letter requesting the National organization to approve the acceptance of a unit here in Topaz. Then you can proceed officially in the matter of organizing and carrying on. A suggestion was to have those present today be the first committee. This committee would send a letter to Mr. Shaffer of the area. But it was thought that it would be better to wait a little while and discuss this matter thoroughly before sending in this letter.

It was decided to meet again sometime this coming week in the afternoon. In the meantime they were to be discussing this matter and bring those people who are interested in Red Cross work to the next meeting. It was decided to have a representative from the hospital and the individual church groups at the next meeting.

The meeting adjourned at 10:30 a.m.

When the campaign is conducted in Topaz Unit it was pointed out that the National Organization isn't assigning a pro rata share of the budget to the Unit so that the goal would only be their unit budget; however, provision should be made so anyone in the Unit who desires to contribute to National and International work of Red Cross should be able to do so and the contributions sent to National Organization.

"Talk with Dr. Carlisle about Junior Red Cross, planned for immediately, he felt the children themselves not in a position to pay for enrollment and the teachers would be perfectly willing to do so so that all schools could be 100% enrolled."


The Chapter has been fortunate in booking a film for November 16-17 (Thursday and Friday).
