Apartments in this center were originally constructed only in three sizes (16x20, 20x20 and 24x20) However, because we were required to house so many small families, it was necessary to partition many larger apartments for this purpose. The report of size of rooms under Section A shows the result of this partitionary program.

In the occupancy report, under Section B, some apartments show only one occupant. This is because the persons occupying such apartments have some physical or mental handicap, making it impractical to have others with them. The small number of occupants in some apartments is explained by the fact that as of October 3, there were 1265 of our residents out on seasonal leaves. With the coming of cold weather these workers are now returning to join their families. This will naturally bring the occupancy of these apartments in most all instances again to full capacity. In fact, we are now having difficulty housing the seasonal workers who were out from Tule Lake on seasonal contracts at the time of the Segregation Program, but who are now completing their contracts and coming to Heart Mountain to join their families, who were transferred to this center under the segregation program. These additional, returning seasonal workers, of course, keep steadily increasing the number of our residents from Tule Lake.

The information on Section F, will be forwarded shortly on a supplemental report. This is necessary as we have been obliged to make drastic changes in the occupancy of quarters occupied by single persons during and after the segregation program.

There are no permanent vacant apartments here at the present time. However, adjustments in family occupancy of apartments are continually being made and a few vacancies are required for this purpose. These few vacancies, however, change from day to day.

Under Section B of this report, the apartments showing only one occupant are explained, in most instances, by the fact that these occupants have some physical or mental handicap that makes it undesirable for others to live with them.

During the month of November there has been no change in the number of apartments on the project made by partitioning or other construction, also it will be noted that the number of apartments used for other purposes than evacuee housing remains the same.

Due to the large number of persons leaving the center each day, and to the somewhat larger number returning daily from seasonal work, it is impossible to keep the occupancy of all apartments in proper adjustment, and because one or more members of so many of our families are now out on seasonal leave, the report of apartment occupancy naturally does not give the correct picture of our space assignment.

Under Section D in this report five apartments are listed as vacant. However, three of these are assigned, which leaves only two unassigned vacant apartments as of December 31st.

The population increase for December is explained by the fact that more persons returned to the center from Seasonal work than went out on indefinite leaves during the month. As of this date there are 436 still out on seasonal and short term leave. It appears probable that during the next reporting period there will be a much smaller number of persons leaving and entering the center each day and the turnover in project population should be less than for previous months.

Our greatest concern in Housing during the last two months has been to provide additional space for large families living in one room apartments. It will be noted from our report of December 31st that at that time, there were 60 families of seven members each living in one room apartments. During the month of January this number has been reduced to 28.

Another problem in our Housing Unit results in instances where large families have been recently reduced to two or three members but are still occupying the large apartment. There has always been a shortage of small apartments in this center, consequently we have no place to move these small families still occupying the large apartments assigned to them when their family was large.

About the only remedy we have been able to apply to this situation is to vacate all small apartments wherever possible that are occupied by 2 or more single or unattached individuals and move these persons in with other groups of single persons in large apartments. Perhaps a satisfactory solution to this will be found as the relocation program is accelerated and apartments of various sizes are vacated.

In the event some Relocation Center should be abandoned in the near future and this project is required to house a part of that population, it appears essential that we have certain alterations made in our present housing units before attempting to accommodate any considerable number of additional residents.

We anticipate, of course, that many of our present colonists will soon relocate. This, however, does not result in many additional vacant apartments, but as a rule, only reduces the number of persons occupying the apartments.

The factor that now contributes most to the unequal distribution of occupants in the apartments is the numerous instances where large families have been recently reduced to two or three members, but are still living in the large apartments to which these families were originally assigned. We have no small apartments vacant to which we can move these people, so there is little we can do under present conditions to remedy this undesirable situation.

It is, therefore, apparent that before attempting to accept any considerable number of additional residents that definite arrangements be made to divide a large number of B and E apartments with partitions and that sufficient material be secured for this purpose.

At the present time, in Housing, we are working toward the accomplishment of four objectives:

- (1) To correct the unequal distribution of occupants in our apartments, such as the numerous instances where large families have been recently reduced to two or three members, but are still living in the large apartments to which these families were originally assigned.
- (2) To separate families groups in instances where two families are still occupying one apartment.
- (3) To provide additional space for extra large families now living in one room apartments.
- (4) To create and lock up all possible vacant apartments. These vacancies are being reserved to house the new residents that are to be transferred to this center from Jerome at the time that center is closed.

In addition to the new residents from Jerome, we have agreed to accept for induction 35 persons from Montana who are now out on seasonal leave from Tule Lake, as well as the Tule Lake seasonal workers from Oregon, Washington and Idaho who, from time to time, come to this center upon completion of their seasonal contract and apply for induction. Also the evacuees paroled from internment camps who have families in this center. During the month of March we inducted 20 of these parolees.

In preparation for housing the new residents scheduled to this center from Jerome, Arkansas, a program of condensing the present population of the center has been initiated. This condensing process involves:

- (1) Rearranging the occupancy of small apartments in which only family member remains;
- (2) Moving families of five members or less now occupying two-room apartments, into one of these rooms;
- (3) Moving family groups who have been reduced to two members but are still living in a large apartment into a small apartment.

At the present time, we have acquired 41 vacant apartments. We expect to add to this number between 25 or 30 vacancies by the segregation movement to Tule Lake. But in order to take care of the new residents from Jerome, we must still provide at least another 65 vacancies.

Families of two members now living in a medium or large sized apartment have been informed that they should contact the Housing Office promptly for new assignments. The first volunteers for such moves will naturally get the most satisfactory locations.

In order to retain all possible vacancies, approval of applications for transfers from other centers to Heart Mountain are being postponed, except in urgent cases, until the new residents from Jerome have been properly housed.

Preparations for housing the new residents scheduled to this center from Jerome are now almost complete. This program of condensing the population in this center has been fairly successful but extremely difficult. Families who have lived in an apartment for a year or more, and have made improvements to the interior, and put in flower gardens or rock gardens, naturally resent having to move to other quarters, especially when the move separates them from their relatives or friends.

We have 131 vacant apartments with a few more that will probably be vacated within the next few days. Of the 500 new residents from Jerome, possibly 30 or more will be single persons. These can be housed in quarters now occupied by single men or women, but in which quarters additional single persons can be accommodated. We believe the present number of vacant apartment will take care of the family groups. However, we are prepared to use two Recreation Halls for temporary housing in the event our present vacancies should not prove sufficient.

Since the arrival of the new residents from Jerome, many families have asked to be moved to larger quarters or to a location nearer to their relatives or friends. Consequently, during the last two weeks, the chief activity in Housing has been to move families around in such a manner as to contribute most to their satisfaction and contentment. Unusually wet weather has interfered to some extent with this moving program and it will, therefore, probably be another week or two before we get the Jerome families finally settled.

A few additional apartments are added to our list of vacancies from time to time as project families relocate. But while many persons are now relocating, it is only occasionally that the entire family goes out and actually vacates an apartment. A good percentage of our vacant apartments are now taken up by the unusually large number of visitors in the center.

Many persons are also going out on seasonal leave. In some instances the entire family leaves the center on seasonal work. However, in practically every such case the family insists on holding their room and leave most of their belonging locked in their apartment. This practice, of course, results in many pad-locked apartments over the center. We are not able to promise these workers that their apartments will be held for them until their return, but as long as we have other vacancies available, we will hope that their apartments can remain undisturbed.

Reassignment of living quarters and continued moving of families within the center has been necessary since the Jerome transfer in order to get relatives and friends located near each other and to keep the size of living apartments in proper proportion to the size of the occupant family. Many problems have arisen during the month which could only be solved by moving persons to new locations. These have been mostly instances where friction with neighbors has developed or where persons in the same apartment, usually in bachelor's quarters, could no longer agree. A new location does not always eliminate these difficulties, but it is effective in most cases and at least seems to justify the experiment.

Repairs have been made to the closets and shelving in a large number of apartments. This repair work was required in most cases in the apartments that were assigned to families transferred to this center from Jerome. These apartments were vacant for a time prior to the Jerome transfer and as there were no padlocks available, the celotex and shelving in many instances were stripped from the closets of the vacant rooms. We now have a supply of padlocks and all apartments are kept locked from the time a family moves out until it is assigned to new occupants.

Monthly Report

Staff housing unit #23 should be complete and ready for occupancy not later than September 15, 1944. Plans and WFB application are being submitted for the removal of three Military Police Buildings to be located near the present dormitory buildings.

Root Cellar #3 and #4 should be completed and ready for use not later than October 1, 1944.

The hog feeding platform project has been discontinued at the present time and work will be resumed as soon as the dismantling of buildings at Yellowstone Park is completed, which should be completed within the next ten days.

The equipment for Filtration Plant, which is on hand, are being installed at the present time.

The community buildings project "D" consisting of the construction of two flag poles for the elementary schools, one thousand coat hooks for schools, two ladders to gymnasium roofs, dental clinic for high school, plumbing to connect chemistry desks and kitchen sinks in domestic science room, fifteen additional exists for recreation halls, door for high school office vault, toilet facilities at swimming pool, building of 120 tables with benches attached and roll call panel for evacuee in U. S. Military Service. This project is in the course of construction and should be completed in the near future.

The project including the screening of windows and doors of the center is practically completed and discontinued at the present time.

The toilet facilities for the gate house is in the course of construction and will be complete in about ten days.

The counters for the diet kitchens are completed.

On September 1st, we had 15 families of seven or eight members living in one room apartments. Now, at the end of the month, this number has been reduced to eight.

Because so many residents of the center, at this time of the year, are going out on seasonal work and others returning from their seasonal jobs it is impossible to keep the occupancy of all apartments in proper proportion to the size of their living space. On September 27th, a special train took 257 seasonal workers out to potato harvesting jobs in Idaho.

When the evacuee arrived at Heart Mountain it was found that the sizes of the families did not at all correspond to the sizes of the apartments that had ~~not~~ been constructed for them. To take care of the new arrivals, many more small apartments were required and Housing finally succeeded in initiating a program of dividing up large apartments into small ones and also in moving partitions between apartments, thus altering the size of the units to fit the needs of the occupants. By this means an additional 108 small apartments were created and alterations were made to 38 other units.

There has recently developed a strong demand for additional divisions and alterations to apartments and many convincing arguments are advanced as to why these changes should be made. However, as we are now acquiring an increasing number of vacant units, Housing has established a policy of declining to ask for any further alterations. Under present conditions, the necessary adjustments will be taken care of by movement of families rather than by reconstruction.

The large number of visitors continuing to come to the center creates a serious housing problem. The most difficult factor, however, in taking care of visitors is the matter of checking back in the government property issued to them for use during their stay on the project. This is because the time of their departure, in most cases, cannot be pre-determined.

Fifteen of the apartments listed as vacant on this report are now occupied by visiting families. In addition to this group there are numerous other visitors in the center staying with relatives. While this latter group does not require any additional housing space, in most instances it is necessary to furnish them with beds and blankets.

In order to work out some more systematic method of caring for our visitors and for checking in their government property, a meeting of all personnel concerned was recently held with the Project Director. An arrangement was agreed upon whereby visitors leaving the center will be required to turn in their government blankets to the Block Manager, who will record this action on the visitor's Gate Slip. This notation will be required of all departing visitors to whom bedding has been issued.

This arrangement, we hope, will assure the proper return of Government blankets and assist the gate clerk in making the necessary collection for use of quarters.

In comparing the condition and appearance of the 2870 apartments in this center with that of a year ago, we observe considerable deterioration, especially in the interior appearance. This is due mostly to smoke and dust that has accumulated on the wall surfaces and to shelving and built-in conveniences that families have placed in their apartments and taken down and carried with them when moving to other locations. Of course, the apartments in which there has been the greatest turn over in occupancy have suffered the most damage, also those apartments that have housed families with several small children show most marking and damage to the lower walls.

Many of our apartments' interiors have been decorated by the occupants and in some instances the project has furnished the brush and kalsomine where the occupant was willing to do the work. Practically all apartments now need kalsomining, but with the labor shortage and the prospect of the center closing in the near future, it is doubtful if a redecorating project can be instituted in the center except in cases where the occupant is willing to accept the material and do his own work.

As our families relocate from the center, naturally our number of vacant apartments increases. This increase, however, is not a true index of the departures from the center, as in most instances, the entire family does not relocate at one time. Also in many cases when a small apartment is vacated and an unusually large family lives next door, the newly vacated unit is assigned to the large family to relieve their crowded condition. The present number of vacant apartments is 54.

It appears that in the very near future one or two mess halls in the area will be closed. In that event, these vacant apartments will be made available to any families desiring to move from the block in which the mess hall service has been discontinued.

Two double apartments in the area have been equipped as offices and assigned for the use of the Immigration and Naturalization Service who are now interviewing some 800 aliens as a part of the Post Exclusion Program. This organization will require the use of these field offices for about four or five weeks. At the end of this time Welfare plans to retain these two offices in the area for our own use in connection with the relocation of dependents and handicapped persons.

As provided in WRA regulations 50.5.72, Mess Halls serving less than 150 persons may be closed. In accordance with this provision, Mess Hall 7-30 was closed on February 15th. The residents of Block 7 have been given the opportunity to move to vacant apartments in the blocks where Mess Halls are in operation. As a result, several families have moved out of Block 7. However, the large majority of families in this block seem to prefer to remain in their present apartments and walk to mess halls in adjoining blocks.
