Dear Sir:

I desire to acknowledge receipt of pages 2 and 3 of the four-page map of your county which was sent to you in connection with the Alien Land Law survey being made by this office, and also the map of the City of Sebastopol. Your courtesy and cooperation in connection with the completion and return of these maps are greatly appreciated.

As yet I have not received pages 1 and 4 of the county map which was sent to you. It may be that there are conditions existing in your county which led you to believe that there was no justification for the completion of these pages. On the other hand, the task may be requiring more time than I might anticipate. I am finding these maps generally very useful in connection with the national defense work being done by this office, so I would like very much to have you fill in any vital defense points on pages 1 and 4 of the county map and return these pages to me at an early date, even though there are no Japanese occupied lands included within the areas covered by these maps.

I do not know if there are any other city maps which I should have from your county. So far as these maps are concerned, I shall leave it up to you to determine whether they will have any value to us. If you do not consider that these maps will serve any useful purpose, I would appreciate it if you would so advise me in order that I may make the proper notations on my records.

I presume that there will probably be material changes in connection with the maps of your county which are designed to reflect the location of Japanese thereon. If at any time in the future any changes seem sufficiently important to justify it, I would appreciate it very much

if you would advise me of these changes so that I can make the proper notations on the maps of your county which have been sent to me. If you should deem it advisable, I will be glad to return to you all or a part of these maps and thus enable you to make any changes, corrections or additions that may be necessary.
