Hon. Sir :

I would like to ask your special consideration to parole my family under some financial support of your office or any other organization.

All of the Renunciants and most of the Peruvian Group were paroled and this camp has become extremely lonesome, and we are very anxious of our future.

Formerly I was desiring to return to Peru and was temporarily paroled to Chicago about one month to study plastic industry to prepare for future life in Peru.

However unfortunately there is not still any reliable prospect about the possibility of our returning to Peru in the near future.

We are really tired out of the long internment life, especially in such lonesome circumstance. We are sincerely wishing to be paroled like other Peruvian group. However due to the following difficult situation of my family, I am hesitating to go out from this camp.

That : My first son, Eurique, is invalid and always in bed since his birth and needs our constant care.

That : My wife, Fusaye, is suffering from nervous disease since February of last year during her pregnancy and cannot work hard to make our living.

That : My youngest baby, Jeanne, was born on Oct.8, 1946 and now 11 months old. She needs also our care.

I am afraid that my works might be sometimes disturbed because of such circumstances and I cannot have enough self-confidence to make our living at outside.

If your office could arrange to issue relief fund to my family about \$20 a month per a member (totalling \$100 a month for whole family) I would be able to find some sponsor for our parole at any time.

I think our living in the camp might have been spending much more money than \$20 a month per a person. Considering of such big amounts of our living in the camp, if I could make our living at outside under such small support of relief fund, it would be economical to both side.

I heard that some of my friends in Seabrook Farms are receiving relief of State of New Jersey, because of their hardship case.


Please kindly consider of my case and help us to be able to live in free world as soon as possible.





Dear Mr. Commissioner:

Taro Ohashi and his family, a Peruvian-Japanese family, heretofore detained by the U.S. Immigration and Naturalization Service at Crystal City, Texas, and now paroled, temporarily have been situated in the city of San Francisco. He has a son named Ken Ohashi, born December 24th, 1947, who is mentally defective urgently requiring institutional placement. The mother of the child is enceinte and the family is unable to give this child the institutional treatment required.

If the Public Health Service has not facilities to arrange for placement of this child, I would be obligated were you to arrange with the State of California for an institution here to provide for such care until the said family may be returned to Peru. It is my opinion that the child is entitled to such care at the expense of our government inasmuch as the said government itself is responsible for the child's presence in this country and the family is still technically held in custody of said authorities.

Pursuant to warrant of arrest served on you on 30 March 1946 and 2 April 1946, you are advised to appear 1:00 P.M., on 31 July 1952, in Room 1346 at the above address, for a hearing to enable you to show cause why you should not be deported from the United States in conformity with law.

The hearing under said warrant is being held pursuant to authority contained in and jurisdiction conferred by Sections 19 and 20 of the Act of February 5, 1917, as amended (8U.S.C. 155, 156).

It is asserted that (1) you are an alien, and (2) that you are in the United States in violation of law on the charges contained in the warrant of arrest.

You are advised that at the hearing you have the right to be represented by counsel of your own choice and at your own expense, or by any other person duly qualified to practice before the Immigration and Naturalization Service. You are further advised that you should bring to the hearing any documents which you desire to have considered in connection with the case. If any of these documents is in a foreign language, you should bring the original and certified translation thereof.

You are further advised that if you are deported or if you depart under an order of deportation you will not be permitted to enter the United States within one year after the date of your departure. DISCUSSION AS TO DEPORTABILITY: This record relates to a 50-year-old male, his 42-year-old wife, both natives and citizens of Japan, and their 13-year-old daughter and 11-year-old son, both of whom are natives and citizens of Peru. All of the applicants are of the Japanese race. The adult male alien's only entry into the United States occurred at San Pedro, California, on February 6, 1943, at which time he was excluded on the grounds set forth above, but paroled into this country for interment as an enemy alien. The adult female alien and the two minor aliens entered this country on July 15, 1943, at New Orleans, Louisiana, at which time they were excluded on the ground that they were not in possession of valid immigration visas and were ineligible to citizenship. They also were paroled into the United States for interment as enemy aliens.

The entire family had been residents of Peru, and at the outbreak of World War II, were arrested as enemy aliens and brought to this country in custody of United States military authorities. At the time of their entries, they were not in possession of valid immigration visas, nor did they have passports issued to them by the country of their nationality. Therefore, they are deportable under the Immigration Act of 1924 and the Immigration Act of 1918.

DISCUSSION AS TO ELIGIBILITY FOR SUSPENSION OF DEPORTATION: The record shows that in addition to the minor applicants, the adult aliens have two other children who are natives and citizens of the United States. The adult male alien is self-employed in the operation of a small hotel and also engages irregularly in the export business. His average income during the past four years has been

about \$4,500 a year. Family assets consist of savings bank accounts with a present balance of about \$500, a \$5,000 equity in the home in which they reside and household and hotel furnishings with a total value of \$4,300. The adult female alien is unemployed and she and the children are entirely dependent upon the husband-father for support. It is clear from the record that deportation of the adult aliens would result in a serious economic detriment to their two minor citizen children.

As indicated above, the two minor applicants entered the United States in 1943, and the records of this Service show conclusively that they have resided in this country in excess of seven years, and were so residing on July 1, 1948. It is established that they have met the residence requirements for suspension of deportation under Section 19(c)(2)(b) of the Immigration Act of 1917.

As the respondents are of a race ineligible to citizenship, they are precluded from obtaining immigration visas by the provisions of the Immigration Act of 1924. Accordingly, they could not adjust their immigration status to that of lawful permanent residents through voluntary departure.

A check of the appropriate local and federal records has failed to reveal an arrest or criminal record relating to the adult respondents. The adult male alien registered under the Selective Training and Service Act of 1940, but is not presently required to register under the Selective Service Act of 1948. Inquiry has disclosed that the aliens have no connection with any subversive groups. Witnesses have been produced to establish that the respondents have been persons of good moral character for the preceding five years. On the record, the aliens have established their eligibility for suspension of deportation.

ORDER: It is ordered that the deportation of the aliens be suspended under the provisions of Section 19(c)(2) and 19(c)(2)(b) of the Immigration Act of 1917, as amended.

IT IS FURTHER ORDERED that if the Congress approves the suspension of the aliens' deportation, the proceedings be cancelled and the aliens, if quota immigrants at the time of entry and not then charged to the appropriate quota, be so charged as provided by law.


