QUARTERLY REPORT OF PROJECT ATTORNEY

The office of the Project Attorney was opened on October 26, 1942. Prior to that time, two evacuee attorneys, with the assistance of two secretaries, had been conducting the Legal Aid Office at the Center. At the time the Project Attorney's office was opened, the staff consisted of the Project Attorney, two evacuee attorneys, and two secretaries. Later, one of the evacuee attorneys accepted a position to teach in the Naval School at ~~the~~ Colorado University and the vacancy in the legal staff was filled by another evacuee attorney. In December, an Insurance Counsellor was added to the legal staff. At the present time, the staff consists of the Project Attorney, two evacuee attorneys, an Insurance Counsellor, and three secretaries.

The work of the Project Attorney's office may be segregated roughly into four categories, to-wit: first, Personal Legal Problems of the Evacuees; second, Legal Services to Community Government; third, Community Enterprises; fourth, Legal Services to Project Staff.

Personal Legal Problems of the Evacuees

Evacuees are faced with many legal problems due to the fact that they did not have sufficient time to wind up their business affairs before evacuation.

Arrangements were made for this office to supervise the absentee voting and a large number of evacuees voted in this manner around the first of November. This accounts to a considerable extent ^{for} the fact that 289 notarial acknowledgments were taken in this office. Although not necessarily a legal problem of the evacuee, but indirectly connected with it, is the work this office has done in connection with repatriation. There have been 86 cases involving repatriation considered by this office which involves numerous consultations. The Selective Service questionnaires were also checked by members of the legal staff. The alien nationals and blocked nationals are faced with numerous restrictions; proper licenses must be obtained and proper reports made. The majority of the banking problems above-mentioned were in reference to blocked accounts. Affidavits were required by a majority of the evacuees in connection with their personal business problems. Many legal questions have arisen as to whether evacuees were entitled to unemployment compensation from the California Department of Employment. In addition to the above, numerous legal situations have arisen which cannot be properly classified.

Legal Services to Community Government

Since the office of the Project Attorney was opened, the organization commission in the community government was created and the legal staff has assisted the organization commission in the preparation of the proposed form of government. Many legal questions were involved in attempting to establish a charter for local government in the Center, but a charter has now been submitted which is satisfactory with the War Relocation Authority. This proposed charter is now being published in the newspaper and will soon be submitted to the residents for their approval or rejection. If approved by the residents, then arrangements will be made shortly thereafter for the election of a new council.

Community Enterprises

Several questions have been submitted to this office by the managers and operators of the community stores. These questions involve problems of taxation, reports, tax returns, banking problems, insurance, public liability coverage, and wage and hour regulations.

Arrangements are being made to incorporate the community enterprises. Proposed drafts of Articles of Incorporation and By-laws are being and have been reviewed. It is contemplated that the community stores will be incorporated in the very near future.

Legal Services to Project Staff

From time to time this office is called upon to interpret and construe administrative instructions, and is presented with a variety of questions from practically all the Division Heads and other administrative

officers.

A great deal of advice is given to routine matters involving problems of safety, health, criminal offenses, as well as questions of administrative policy.

All in all, this office seems to have more than enough work to keep the members of the staff busy.

2. PROGRESS OF CURRENT WORK:

- During the past week, the Project Attorney spent Friday, Saturday, and part of Sunday in Salt Lake City in a conference with the Project Attorney from Minidoka going over in a general fashion the work of the Project Attorney at the relocation centers in relationship of his office and that of the branches of the center administration as well as the particular problems arising from the work of the resident division of the office.

The most striking thing about this latter phase of the conference was the fact that so many problems in one office seemed to be peculiar to that center and had not arisen in other centers.

- The Project Attorney's secretary, Sumi Miho, terminated her connection with the office on March 2 and has now left for Rohwer to be repatriated.

- A conference was held in Salt Lake City with a member of the staff of the Unemployment Insurance Commission concerning liability of the local Cooperative to contribute to the Unemployment Compensation Fund of Utah. The outcome is still undecided.

2. PROGRESS OF CURRENT WORK: (cont'd)

- Another problem under study is presented by Mr. Roscoe Bell concerning closing of certain roads running into the project area.

- One of the evacuees' problems was presented during the past week--one divorce case of long standing, property matters of some of the residents who were leaving for the staging center for repatriation, as well as the usual addition of property, insurance, income tax and other problems.

- One phone call was made to San Francisco to attempt to get a permit for two residents to return to their former ranches for implements needed to do beet farming in Idaho. The request was refused.

2. PROGRESS OF CURRENT WORK:

- Consumer Enterprises Cooperative has now been registered with the State of Utah as a foreign corporation entitled to do business in the state, and proper filing of the Articles and Power of Incorporation have been taken care of in the county clerk's office of Fillmore.

Administrative instructions concerning rental payments by Consumer Enterprises to the W.R.A. have not been received, and this is delaying the execution of the rental agreement between W.R.A. and Consumer Enterprises. The operating agreement between W.R.A. and Consumer Enterprises is in the process of completion and the Project Attorney has suggested to Mr. Honderich that this matter be taken care of in the near future. The liability of Consumer Enterprises for State Unemployment Compensation contributions and State Workmen's Compensation Insurance is under study.


- The Project Attorney met during the week with a committee from the Community Council concerning ordinances, arbitration procedure, and procedure and work of the Judicial Commission. The Project Attorney is urging the Community Council to enact ordinances as soon as possible.

2. PROGRESS OF CURRENT WORK: (cont'd)

- A long-distance call was made to Public Utilities Commission of the State of Utah concerning franchise held by coal haulers in order to determine the possibility of the Procurement Division obtaining coal for less money.

- The Project Attorney's office is meeting the usual rush of last-minute income tax inquiries. An item was placed in the project paper notifying residents that the State of California has ruled that the residents of California living within the project is subject to California State Income Tax on income, regardless of its source. Blanks have been obtained for California residents to file with the State of California.

- Property inquiries are still numerous and constitute a considerable portion of the work of the office. A memorandum was prepared authorizing the shipment by the San Francisco office of 3 carloads of residents' properties to the project.

- The Project Attorney, during the week, made a trip to Nephi, Utah, where he consulted with Judge Will L. Hoyt of the District Court, and the County Attorney, Mr. Milton Melville. Included in the discussion were commitments of insane persons to the State Hospital, closing of roads into the project and the project area for Mr. Roscoe Bell, county gravel allegedly taken by the W.R.A., and the handling of criminal matters by the state authorities including deputization of heads of the Internal Security.


- The Project Attorney this week moved his office to the space formerly occupied by the Pass Division of the Internal Security.

2. PROGRESS OF CURRENT WORK:


- Some attention has been given this week to matters of appliances with state tax and other laws affecting the Topaz Consumer Cooperative Enterprises, Inc.

2. PROGRESS OF CURRENT WORK:

- Matters dealing with enactment of ordinances by the Community Government and criminal matters arising on the project have occupied more of the attention of the Project Attorney's office than has previously been the case.

- Question of policies relating to Internal Security have also been under consideration, and the Project Attorney has assisted the Internal Security Chief in conducting two interviews with persons relative to their clearances, on request from Washington. Others have been prepared to the County Attorney relative to deputization and roads, and one long-distance call was made to the County Attorney to use the Fillmore jail.

- Assistance to persons going out on leave, particularly to agricultural jobs, in the way of reviewing contracts, assisting in obtaining of property, etc. is also increasing in the office.

- Preparation of the projected administrative manual and working with the Community Council on ordinances constitute the most pressing work at the present time.



Regulations doing with traffic and Juvenile Board have been discussed with members of the respective committees and with members of the appointive staff concerned; in each case, with satisfactory understanding with the committees involved, looking toward an acceptable set of regulations.

- The first criminal hearing of Topaz before the Project Director took place on Friday, April 2. Three young men pleaded guilty before the Project Director for violating Administrative Instruction No. 85 with reference to unlawful use of property, in this case a W.R.A. car, and was placed on probation for three months, and their overtime and pass privileges taken from them, subject to review at the end of thirty days.

- The work of the resident division is concerned principally with insurance and property matters and requires no special comment.



Mr. Milton Backman, Attorney for the Army Engineers who is completing the purchase of irrigation stocks for the project called upon the Project Attorney to assist him in closing purchases of irrigation stock on Saturday. A conference with Mr. Dudley Crafts, Attorney in Delta, was held concerning some of the problems of the project. 


