INTERNAL SECURITYFire Department:

To ascertain efficiency of the fire department, intensive fire drills for the fire fighters and auxiliary fire fighters were inaugurated the middle of the month. The first surprise fire drill was called November 15 at 1:19 A.M.

The fire of November 28 emphasized the need of proper fire fighters uniforms. Many of the firemen suffered from the water and freezing temperature - the hair as well as their clothes froze stiff.

This will correct an error made on the weekly report of November 21. Blocks 22, 23, 24 and 25 were not equipped with fire extinguishers. Installation of same will be completed soon as the needed additional extinguishers have arrived. Fire protection officer has arrived.

Social Service:

Issuance of government clothing stock to colonists are charged against their clothing allowance.

The Coordinating Council, a volunteer, non-political group, represented by the existing WRA departments, Civic and National Organizations, Religious organizations and others interested in the welfare of children and youth was organized for the prevention, initial purpose, and disposition of juvenile delinquency and to advise the judicial commission on same. This council is primarily interested in the problems that are involved in the case.

HOSPITALIZATION:

GENERAL COMMENT:

Dental equipment and materials have been coming in satisfactorily lately so that the dental departments have been able to function more efficiently. Dental clinic No. 2 in the Center has been in temporary quarters which we hope to have equipped with water and sewage system to facilitate sanitation.

We are advised that our staff of registered nurses is to be strengthened by two and possibly three additional nurses which will lighten the load of the present staff of registered nurses considerably and relieve some strain on the medical staff as well as increase the efficiency of the entire health department.

INTERNAL SECURITY

Fire Department

The Fire Protection Officer arrived on December 1, and left his post the following day. Two major fires were extinguished ~~consequently~~ by this department, but these fires proved the need of gas masks, additional hose and bunker suits. Gas masks are essential items of the firemen's equipment because dense smoke from burning celotex does not leave the usual ten to twelve inches of fresh air near the floor common in ordinary fires. William Hoffman visited this Center December 14 making survey of problems confronting the Project.

Work has been started on converting a dump truck into a fire engine according to drafted plans.

Police Department

Subsequent to the termination of Robert C. Griffin on December 1, the acting chief of police who had resigned, and two suspended policemen were reinstated by Project Director C. E. Rachford following an investigation which disclosed no evidence for suspension. The reorganization of the police department, supervised temporarily by the chief of community services, is progressing and is endeavoring to increase the force to patrol the area more thoroughly.

SOCIAL WELFARE

With the exception of families with minor discrepancies, October and November clothing allowances were paid this month to eligible families. 373 cases were approved for Public Assistance Grants on a permanent basis and 2,631 recipients' accounts were charged with warehouse clothing.

Two cases were received for probation from the judicial commission.
