1. 5 steps - Acceptance

1) Admission to College

2) Evidence of sufficient
financial support for year.

(Could include jobs) Reasonable

3) "Statement from" some
"free officer" from community
to which going - indicating
he had (personally) to student
coming — naming the specific
student, meant ^{appears} to be
for every student

4) Citizen who had
never been in Japan. (At
one time WRA would ~~let~~ ^{not} let
out Kihei — while WCCA issued!)

5) Had to be approved by
62* FBI & Army Intelligence

3 shifted & changed from
time to time. SRC stretched
