F.D.R. SIGNED BILL REGARDING CITIZENSHIP RENUNCIATION

Pres. Roosevelt signed a new law Bill which has been in effect since July 1. Any American citizen who wishes to renunciate his citizenship at his own accord would be possible.

Regarding the Bill, Mr. Lindley expressed his comments as follows: "The Bill signed by Pres. Roosevelt is not enforced to renunciate citizenship of any citizen; furthermore, it is not plundering the citizenship against the will of any citizen."

The only basic principle of this Bill is that when a citizen renunciates his citizenship, it must not in anyway violate against the national defense, nor effect it; otherwise, his renunciation would be possible. This prevents a person of conscription age to renunciate his citizenship, who might take advantage of using the Bill as another step to evade military service.

This Bill is only effective during America's engagement in a war; moreover, it does not come in effect until the Judicial Department issues the publication of its secondary ordinance regarding the bill.

CANCELLATION OF FREEZING IN HAWAII

According to news from the "Hawaii Times" of June 23, it was reported that all Japanese subjects are freed from freezing. That is to say, all the Japanese subjects in Hawaii are not to be treated as frozen nationals, and that they are in general, freed as frozen subjects.

Up to the present time, Japanese subjects in Hawaii were classified as frozen nationals only for the reason of their Japanese subjects, and their business enterprises were frozen.

This privilege does not indicate the application to the internees and their properties, or those who returned to Japan, nor to those who reside within the sphere of newly acquired territories by the Japanese Government.

SEGREGATION PROBLEM

Mr. Ike's Statement

JULY 9

The removal of the twenty-six Issei who have been involved in the riot which occurred last November in Tule Lake have finally been segregated to the internment camp which is under the jurisdiction of the Justice Department.

Mr. Ike announced that the removal of the foreigners have settled the problem in Tule Lake, but there are still twenty-five Nisei remaining in the center. (Issei)

Since November 4, 1944, when the riot started, the center was under the jurisdiction of the Army, and at that time, there were one-hundred and eleven foreigners and two hundred and twenty-nine citizens who were temporarily segregated for the reason--suspiciously dangerous people.

The <sup>W.R.A.</sup> ~~W.R.A.~~ organized the Committee of Investigation and held hearings of the segregated people. The Director of the said center was presented and advised. After a long investigation, the Issei were removed to the internment camp and the Nisei, who has previous record of disturbance has been kept in the center.

It was also announced that Issei and Nisei who have been recognized by the authority as not showing dangerous actions be ordered to return to their house after keeping them in confinement two to eight

months.

At first, the W.R.A. had intentions of keeping nisei rioters in the Lupe segregation camp in Arizona, but they reconsidered the situation and realized that a few of the people were left within the fence. However, the re-opening of the Lupe Camp is indefinitely postponed.

MOVE GAINING FORCE TO LET JAPANESE RETURN TO COAST

SAN FRANCISCO, July 8--For the first time since 112,000 persons of Japanese ancestry were evacuated from the West Coast two years ago, the Coast is awaking to the realization that reopening of the doors for their return is inevitable, perhaps even before the end of the war.

More and more, in speeches and resolutions dealing with the Japanese-American question, the phrase "constitutional rights" is being stressed.

All of this does not mean that persons--and they are many--who favor an economic and social boycott of those of Japanese blood look with <sup>(admission)</sup> equanimity upon the prospect of a resettlement of the evacuees in West Coast States. But even the hardest speakers now are talking of constitutional rights and finding it difficult to muster words that will meet the mute arrangements of the Purple Hearts won by the Nisei in Italy.

ROME--JULY 17

Japanese Ambassador in Rome, Ken Harada, announced that the Pope is to be recognized by the Japanese Peace Agreement including the safety of living condition and avoiding to continue this indecisive war.

WASHINGTON--JULY 17

Secretary of State, Hull, made an announcement to hold an informal post-war conference of the Four Powers in Washington.

NEW YORK--JULY 17

Tokyo Broadcast --

Adm. S. Shimada resigned from the Minister of Navy and the successor was named as Adm. N. Nomura. However, Adm. Shimada still holds the position as Chief-of-the-Naval General Staff.

CHIANKING--JULY 17

The Imperial Japanese Army force finally is attacking the streets of Henyaung region and is almost annihilating the railroads of 1000 mi. under the Japanese force.

PEARL HARBOR--JULY 17

American Asiatic Fleet again attacked Guam Is. for the 13th consecutive time. However, it is reported that landing seems to be possible.

PORT CHICAGO, CALIFORNIA--JULY 19

Two navy ammunition ships were blown up by explosion which occurred late last night. Some 650 persons were killed, and windows of the adjoining towns were broken into pieces.

WASHINGTON--JULY 15

A broadcast was received from Singapore regarding the American fliers who bombed Yawata recently, and were captured somewhere in China. It emphasized that the captured may be persecuted by the Japanese Military Department.

LONDON--JULY 16

The Eastern wall of Germany has been broken and she is confronted with a most dangerous and serious condition.

U.P. BROADCAST--JULY 13

A broadcast from Manila under Japanese Military control, stated that the missionary organization in the Phillipine Is. has been arrested. This organization included the head of the society, and other important personnels.

LONDON--JULY 17

Allied Supreme Headquarters

The attack on St. Lo. by the American Force is continuing in a fierce dogfight between the German forces.

PEARL HARBOR--JULY 16

Adm. Nimitz made a statement that his naval force is continuing to attack the former American base, Guam, with rocket guns and bombs.

U.P. BROADCAST--JULY 16

It was reported by the Tokyo Radio that 85 American planes attacked Guam and nearby islands which is situated 700 miles from the

homeland.

ROME--JULY 15

A broadcast from American Communique was received reporting that Gen. Clark was almost killed when he and his staff of officers were investigating the Gulf of Auzio. It was reported that the shells came from American ships killing one officer. Two of the other officers were critically injured. 



Subject: Relocation Story (George and Tokuichi Takagi, formerly of Heart Mountain Relocation Center)

George Takagi and his father, Tokuichi, on July 8 marketed their first tomatoes at Omaha, Nebraska. The elder Mr. Takagi says, "These are even earlier than California tomatoes."

The tomatoes brought more than twenty cents a pound, although the price will probably be lower as additional tomatoes come on the market. The Takagis say that in Nebraska plants are kept in a hothouse until they are quite large, and this explains the early marketing date. They are considering buying the place, part of which they now operate on a share basis, and they believe that it will pay for itself in about three years. No irrigation is necessary, the annual thirty inches of rainfall being sufficient.

PROBLEM OF LAND LAW INVESTIGATION

(1)

Advice from W.R.A.

Following are outstanding points advised by the W.R.A. Those who have been investigated by the Committee of Investigation should put forth special attention.

I. It is permissible to hire an attorney in regards to investigation. However, it would develop into a very important conference concerning the problem of confiscation. If the W.R.A. recognizes such a need for hiring an attorney for any evacuee, the administration can offer an assistant to hire the attorney.

II. The evacuee has perfect right to refuse any suggestion or question asked by the Committee if the evacuee is not being called by the writ of summons.

But one must remember that the authority might arouse unnecessary suspicion on the evacuee because of his refusal to give the report. Because of the refusal, the authority might interpret that one is concealing important evidence.

III. According to the laws of the three States along the Pacific Coast, the American citizens has rights to own land. We have seen many cases where the land is owned by a citizen but the purchaser is his parents.

Again, according to the above States, if the citizen actually owns the land, the parents are permitted to purchase it. But, if the parents is using a citizen's name only and taking full rights to receive profit from the said land in order to avoid the Land Law, the States has rights

to confiscate the land.

IV. In order to prosecute the confiscation of the land without a fault, the authority must depend on the evidences taken during the conference with the evacuee; however, the evidence might add favorably to the situation to the authority, which would be useful and effective in case of confiscation. Therefore, it would be very important and necessary in order to transfer the land to a citizen, that the transaction does not interfere with the case of land-law and it is also important to explain the situation clearly and that the said transaction is not based on misinterpretation.

# PRESENT SELECTIVE SERVICE POLICIES TO BE CONTINUED

WASHINGTON, July 22--Present draft induction and deferment policies are expected to be continued, with most Selective Service boards filling their needs from manpower pool under 26 years. This was revealed in Saturday's report by the house military affairs committee, according to Associated Press release.

The national military manpower strength of male registrants, 18 through 37 years of age, as disclosed in a periodical summary compiled by Col. Francis V. Keesling, Jr., for the committee was about 22,212,000 as of July 1. Of which, 10,251,000 were members or past members of the armed service.

The armed services, having reached their authorized strength, will make induction calls only for maintaining the net strength.

A breakdown classification of registrants showed:

- ① Class 4-F, rejected for military service, 3,982,000.
- ② One-A, processed for pre-induction examination, postponed induction, appeals, 1,434,000.
- ③ Two-A and 2-B deferred in occupation other than agriculture, 4,105,000.
- ④ Two-A (L), 2-A (F), 2-B (L) and 2-B (F), deferred in occupations other than agriculture and not qualified for general military duty, 313,000.
- ⑤ Two-C, deferred in agriculture, 1,641,000.
- ⑥ Two-C (L) and 2-C (F), deferred in agriculture and not qualified for general military duty, 92,000.
- Unclassified, mostly 18-year-olds, 65,000.
- All other classes, 274,000.

## WRA STORAGE POLICY ON EVACUEE PROPERTY GIVEN

WRA will provide storage space for property left in the evacuated area or in a center by an evacuee who either relocates or is inducted into the armed forces as long as West Coast exclusion act remains in effect, according to Paul J. Fischer, evacuee property officer, yesterday.

The recently revised regulations further indicate that although the WRA will assist in moving the household, personal and commercial property of evacuees going out on indefinite leave, it cannot assume responsibility for the storage or care of a relocated evacuee's property at the point of relocation. This

It was the purpose of educating the leaders of the next generation that twenty-nine students have already been sent out and enrolled in different universities from Topaz relocation center. The plan was carried out last year, but the financial difficulty involved, however, with the profits of both the movies and the carnival made the financial possibility with the amount of \$3193.25 (three thousand one hundred ninety-three dollars and twenty-five cents.)

After the enrollment, the students receive the subvention from the Committee of Student Relocation of Japanese-Americans which is located in Philadelphia.

In this connection however, the Committee of Student Relocation of America is supported by the religious organizations, educationalists, Carnegie and Rockefeller Foundations respectively.

Pvt. Joe Yasuda left Amache as a volunteer to Camp Shelby, and after having received his training, he was sent to the European front among the 442nd Infantry Battalion.

Another sad news was reported from the War Department to Amachean, Mr. Y. Oki, whose son Corporal Arnold Oki's heroic death also took place at the Italian front

Mrs. Y. Oki lives at 9F - 7A.

Mrs. M. Mamizuka also received a note telling her that her son had been wounded in action. Her son, Corporal Richard Mamizuka is receiving the treatment at one of the Army Hospitals.

Pvt. Calvin Saito's heroic death in action was notified by the War Department to his father, Kiichi Saito, who is relocated at the present time, but Mr. Nishizaki of 8K received the notice.


