to Mr. Lincoln Kanai asking what they can do in the name of Y.M.C.A. I wonder if you should write to Whitney <sup>asking</sup> if he can do anything in legal end. I am permanent resident since 1906 and my official capacity with Mitsui Ended April 12-1939 and with my record in social services during my life in this country, I believe I should not be detained like this as suspicious alien. There are many Japanese here who seems to be only circumstantial victims and of absolutely innocent. You may personally consult with Whitney in writing if he can do something legally. Or if you think Dr. Giles letter is efficient enough, you may wait but I think we should do everything possible in order to get prompt release.

During blackout Saturday night, I was sitting at end of the hall and could not come back to my bed until it was over.

Rev. Ozaki wrote me today with others (Uyehara, Uno, Inoue, Mizota, Koso) signing

My Dear folks:-

With about 85 Japanese,  
I entrained and left Oakland about  
4:15 P.M. and after 48 hour ride arrived  
here Friday P.M. about 4 and  
have settled in the Camp - all in  
good spirits. The Camps are all  
new, so beds and beddings are much  
better than the D.F. quarters, so is  
food, and atmosphere is altogether  
much freer and better, the train  
grew on the way with the cars from  
L.A., Portland and Seattle etc and  
upon arrival, found so many  
old acquaintances and families  
faces all over the camps, I had  
good talk this morning with  
Narusue and Ito, bosses from  
the <sup>La</sup> Sum, they said they feel  
quite relieved as Kuremai is



at home. also I talked with  
6 people from Portland and  
from them learned Yasin in  
Hood River, Lakeview ~~it~~ others in  
Portland are held <sup>there</sup>, they seem to  
be transferred here later. Shingor  
from La. is here too, Everybody  
here feels so settled and relieved.

The authority here declared  
they want to treat Japanese  
in self autonomy as much as  
possible and they are going to  
elect Mayor and a Council-  
men for Japanese Community  
here. I don't know when the  
hearings will commence and  
newspaper reports members  
of board of review have been  
appointed but it must move  
very slow before the board  
acts and takes up each case. <sup>so</sup>  
Every body seems to be determined  
to stand long waiting. so  
people at home must understand

and conform to such thinking -

Have you written to Whitney, if not yet, suggest to do so. Sending copy of Dr. Gill's letter so that he would know what has been done <sup>by Dr. Gill</sup> and asking him if he can do anything further for an early release. These things may not mean any help but must do very best mean. I wonder if Mr. Kanai <sup>2 + 1</sup> did anything at Y.M.C.A. You may also send me a copy of Dr. Gill's letter for my reference.

All mission people are well. Mr. Kazama is only one left in I.F. quarters. Mr. Suzuki, Takiguchi are here but Abr. Alim father is still in I.F. but they will come later.

You don't have to worry about me at all, because treatment is getting better every day and I feel just fine with chances meeting many

old friends. How's everybody at home? believe everything is OK.



Dear Jacks at home:-

Received your letter of 20th last night and was very happy to know that you are all well and things are settling at home. Very grateful to know that friends are so kind but 15 visitors a day are certainly too many and Mom must take it easy not to get tired. Try to live in simple way. The Satchel & Paper box containing suit <sup>etc</sup> were delivered to me this morning and I found every thing contained <sup>to be</sup> very useful and helpful. Needle & thread worked rightaway in Mr. Nakao's new shirt, family picture was appreciated and admired by friends. Coat hangers were distributed to each. First aid package is very useful too. Thank you for every thing.

It is snowing now and the ground is thinly covered but we don't feel cold much. The house is well heated and ventilated and all are in good health and high spirit, camp is conducted in very good order and in harmony.



I am feeling the best of my health, no trouble at all. (No more Neuralgia 40.) regularity in food, sleep and living seems to be making good time. I get up 6:30 A.M. with everybody, take cold rubbing (Reisui Masatsu) then take Exercise outside about 15 minutes before going to breakfast (today's breakfast was Toast, Mush., butter & Jam Coffee, quantities more than I can take) After breakfast ten men of the camp starts cleaning camp and twice a week we have lectures for half an hour (Seishin Shugyukai) then boys do washing, playing Go. Cards, games etc. Luncheon today was baked fish Potatoes, spinach, Egg Sea. Starting tomorrow Kitchen will be in charge of Japanese and they say more Japanese food will be served for each meal and tomorrow on Xmas, they are going to <sup>give</sup> Turkey dinners and Xmas candy and nuts are to be distributed. Laundry is to be operated by Japanese soon and shirts, undershirts Pajamas only are to be handled once a week. Hides & Sox are to be washed by individual.

Today. My personal properties  
were released except Cash up to \$15—  
and am writing this letter with my  
own Pen on the paper you sent—  
The Keys were retained by F.B.I. official  
in S. F. who will probably inspect  
the safety Vault in Berkeley after  
which the Keys will be returned to  
Kay— In the safety Vault, I keep  
the \$ Bonds of mine <sup>+ 4 NYC City</sup> (28) of Kays (15) the  
churches (2) Mothers (2) Mr. Logan (8)  
and number of Stock Certificates,  
Pass Ports, Marriage Certificate, Auto Pink Card  
etc. I do not think F.B.I. try to take  
out any of them except inspection but  
if you find anything wrong in the  
Vault next time, Yoshi should notify  
to the bank and F.B.I. <sup>office</sup> in S. F. accordingly.


Kay, is glad you got the bank book  
from the office and did you draw out  
the cash as I told you? Let me know.

I do not know if Yokohama Specie Bk  
in S. F. is operating business by this  
time. I know it was closed once but  
it bring<sup>a</sup> state bank handling deposits  
for the public including American Citizens,  
is inclined to believe it is now open  
so I'm sending you herewith enclosed



My check for \$50.00 in your favor  
for living expense of the family. You  
should check up <sup>first</sup> ~~some~~ <sup>when</sup> ~~there~~ if  
the bank is operating and if so  
you may try if the check can be cashed  
or deposit in your saving ac<sup>t</sup>.

I do not think Mr. Kido could do  
anything for me. We have to be very patient,  
it may take 6 months, one year or more,  
I know hearing will be conducted  
some way but everybody here is determined now  
not to expect early development. You had better  
watch the Chronicle carefully on this matter.

Your Xmas package was delivered to  
me this afternoon and I was so happy.  
I have received so ~~much~~ <sup>thoughtful</sup> of present - slipper  
is just wonderful. Mission men were also  
so happy to be remembered by you. The  
wrapping paper, Ribbons, tags were decorated  
on the little Xmas tree in our camp which is  
only one among all camps, and there two   
artificial trees were so attractively placed in  
front of the tree. Song Cards were also appreciated  
by the boys. I was only one in the camp  
to have received Xmas packages today.  
~~For~~ Cards were pinned on the bulletin Board  
and every bit of Xmas color was appreciated

Last Night, about dozen boys enjoyed playing shooting game. This morning the Domino was played by a number of men. The other presents (to Imai, Ischi Nakao Yabu) must be also enjoyed in other camp. Hoshino, I Mr Sato of Sumitomo bank are here together. Candles and Mats were distributed by the Government. Heavy Army like Coat, Pants and Snow shoes are also to be given by the authority if required, but I don't need any as you sent me all necessary things. May, if you could draw fund from my saving ac in BK of Amr, send me some more blank slips so that I can sign and send them back for your future requirement. Please let me know about the regulation both in BK of Amr also Yokohama Sp. Bank. Did you get my greeting telegrams last night. Wishing you all a Merry Xmas -

I am sure you are all in good health and everything in Berkeley is O.K. How was Christmas Eve in the church? I forgot to tell you that I put my Xmas donation for the church \$15.00 which I presume you have duly paid for me.

Early yesterday, another train load of Japanese arrived here from Seattle Portland and L.A. areas among which I found a good many old friends. Mr. Nosaka of Berkeley (Mgr. of North American M. Co.) who was left in S.F. in our first shipment, came here yesterday but Mr. Abe, Alice's father, stayed there again in S.F. Mr. Iwami of Hood River and a number of old timers in Portland came and they say that they had quite hard times in County Jail up there & before being moved here and every body is very happy now with better conditions all around and better food, better surroundings. Last Night, we had a service in

Each camp and Mr. Nakagawa from Seattle spoke in our building over "American flag" and I presided over the meeting. On Xmas day, I received tel. greetings from Kumai & Geo. Koso, Hiro and a candy box from Kumai. Have plenty to eat in the meals and Canteen was opened with a capital of Each stock of \$200 and we can buy fruits candies and stationaries so you don't have to send me any food.

3 P.M. 29th

Have just received your airmail letter of 12/22 which came to my hand ~~later than~~ after 7 days, probably Xmas rush of mails delayed it. Since the kitchen was taken over by Japanese on the 26th the food is getting better. We had Roast Beef. Mashed Potatoes, string Beans - Broad Beans black tea for lunch today. Kay, I'm glad to know that you got some funds from my a/c and is good that you are trying to transfer the a/c to Berkeley so that you don't have to cross the bridge every time.

I enclose herewith the authority to <sup>for withdrawal</sup> Kay to sign on my behalf on bank slip addressed to Bank of Am. so that you don't have to send me for my signature each time. Be sure to draw from my a/c for living expense as much as permitted each month. If the account can be transferred to your name, it is better. you may ask them in this regard. please report me <sup>of</sup> ~~of~~ your efforts.

I don't feel it that bad and we are all comfortable enjoying living day & night. Every gentleman is to make his <sup>own</sup> laundry work now - for Mr. Imai & Mr. Tacka are doing their washing. I'm doing well in every way and my health is better so please do not worry about me.

Please thank Mother & Sister for what they are doing for me. Please remember me to Mrs. Harpentin, Miss Hayt and other friends. With Love. Yrs. J. Uchida

It is a beautiful Sunday with the sun shining brilliantly on snow covered hills in Missoula today and am writing this letter at my bed side thinking of you so dearly - Thank you for your New Year day telegram and one received yesterday. I was very busy all day yesterday trying to secure tonight's speakers for service in 17 Camps which is my duty as the chairman of Relief Committee and ~~forgot~~ almost about our anniversary and was very happy when I got <sup>your</sup> wire to remind me of it, so wired you back at once which I hoped to reach you Jan 3- Did you get it on Saturday? I showed your telegram to my neighbors, Mr. Hoshino and Mr. Sato. (mgr. of Sunintomo Bank. D. F. + Christian) who was also much enlightened and congratulated me heartily so, I made three cups of hot lemonade and served them with Ritz, they toasted to Mr. + Mrs. Bellina's health; later Mr. Sato and another friend joined us and my private celebration of <sup>our</sup> anniversary was just lovely. F. - Oh yes, it was some party which started 7 P.M. preceded by Mr. Hoshino and

Every one of the ~~men~~<sup>Camp #30</sup> took part in singing, dancing, and making speeches congratulating me, I sang of course (Kino-Hummi) and Everybody was very happy, a few friends came over from other camp and joined in celebration. Mr. Tacka put some message on the card (Used one from Kumei) and all men signed it which I am sending you for your Governor herewith enclosed. Oh it was a wonderful party. Everybody was so sincere and happy in congratulating me for the occasion - I shall never forget this party for my life and want to inform you that I was so happy and told them after thanking them that I would send this card to you together with their good wishes.

"Ozoni" was served afterward and the happy party ended about 10. P.M. after we all sang in unison "Our Camp" recently composed. I took 'Nihonburo' and went to bed with such a sweet memories of the past twenty five years. May God bless you, Mom. Kayama go. Please write of this to Mother in L.A. briefly -

I was somewhat surprised to know that four letters reached you on some day. Postoffice may be alright but Censorship must be the cause for delay - You must know by this time something about our lives in Missouri - Everybody feels so settled now.

About warm clothes, my light overcoat is enough. The weather is quite severe but the house is well heated and moreover the Government furnished <sup>us with</sup> warm pants, waist, coat, shoes etc whenever necessary is and although I got such coat, pants & waist, I rented to Mr. Yacui from Hood River because he being late comes, did not get such supply yet in spite of the fact he had only summer suit on - By the way, I went <sup>today</sup> to Portland Camp to coach singing "our camp" They were very happy to sing with me as a coach - About 30 came from Portland and I know about half of them, Mr. Inuzuka is one of them. Did I tell you Rev. Nakajo was is here too? I applied for an assembling hall for whole camp but so far unavailable, we are conducting meetings in each dormitory, but as soon as we get one, we intend to send for American Minister to preach in our service for whole camp and use the hall for other religious meetings.

all Mitani men are well. Hoshino & I are in this dormitory all others in #18. They say average age of those men held here is 59.3 or something like that so you see most of them are older than I am, some of them 76. (Mr Okuda of Seattle) oldest is reported to be 82. 2 men have been sent to the hospital outside and they are reported to be seriously ill. It's too bad indeed. One man said, he has three sons serving as drafters and w/ the welfare committees are planning to petition to give those old people (over 70), sick people and those fathers having drafter son preference in the hearing. Oh I feel pity for those elderly men, <sup>when I see them</sup> sitting in our dining table.

Monday, Dec 5th  
a.m.

Last night, Mr. Shimano, principal of L.A. language school spoke in our camp, he spoke very well about his experience and hope in postwar times, after every meeting, Mr. Ling "our camp" and I took bath (Mikuburo) which is good to warm up before going to bed every night. I inspected the Laundry plant which is now being run by Japanese and I sent out my pajama sock work which came back same day. Mr. Sakata (Gao's father) has taken cold and confined in bed last few days, I made hot lemonade, last night for him and he was very happy, he is taken care of by a doctor and nothing is serious.

The kitchen is to be operated by a new plan, cooks failed to work voluntarily and commencing today, each dormitory has to send out 6 men (2 Campers each day) to work as cooks & cooks help, so there being over 600 men in the camp now, I have to work as a cook once in 100 days, it must be fun to wear a white cap & serve food in dishes, this is extra job outside of waiters (20 helps from each camp every day) We also have 'toban' 3 men from each camp to help in our hospital, clean the room and to take care of the stores there.

So, you see we have just enough work and don't have to worry how to kill the time.

Now, I like to know something about Berkeley, <sup>even</sup> did every radio with short wave turned over to authorities then as newspaper report? How is Japanese business there? Are they running as usual. How is Masai Laundry? Please tell Masai I was worrying about their business. From the news available here, the retail business <sup>seems</sup> to be now running in L.A. S.F. and also in the North, if so the people will have enough to earn for their living during the war. How is Mr. Mori's business? Is the church running alright? Please remember to Rev. Ozaki and all members.

Dear Folks at home;

Thank you for your letter of Dec. 29th which came <sup>me</sup> to/on Jan. 10th a few days after yours of Jan. 2nd which was airmailed so you will naturally know that airmail is better than ordinary mail and I'm now expecting to receive another one in a few days. Very glad to learn that Kay had three interviews. How was result? You don't have to be discouraged even in case you do not get the job at once because you will have to do a quite bit to help mother and I would rather like you to get the work in Berkeley so that you can be always <sup>near</sup> to Mom.

Today I got a letter from Martha which I acknowledged by a post card, it was very nice of her to write me and you will please thank her when you see her. Mr. Yasui was sick for last few days, he worried so much and was weak on top of which had a cold, I rented some of my warm clothes and visited him every day but fortunately he was better today and got up for the first time to walk to the dining room by himself; Mr. Takeoka twisted his loin when he tried to raise a heavy pile of trays while working in the kitchen and is reported he will have to stay in bed for a week, so many people have cold and are confined in the dormitories but today the weather being very warm with the sun up all day, most of the boys went out of the house and had exercises in the snow, we played catching ball, horseshoe throwing and making snowman and <sup>all</sup> ~~every~~ boys were happy.

I am in the best of the health and am keeping busy as much as possible with my job of welfare committee, we got one building for the chapel, library and reading room for Japanese and today we got the materials for benches and tables etc. the carpenters being busy with his work in the hospital, we shall have to wait until next week for <sup>fixing</sup> the chapel; we expect to have christian



service on Sundays as official one and later other religious sects like Buddhist and Konkokyo to have their services in the chapel, by the way in my dormitory, MR. Fukuda of Konkyoko and Mr. Ishida Nitten of Nichiren sect are living together and we all are very friendly. Mr. Fukuda composed a number of songs for the boys like "Our Camp" "Missoula Bushi" etc and we a few boys went around all other dormitories singing the songs, that was very good to cheer them up.

The inspection of parcels became very strict in this camp recently all wrapping papers and boxes are carefully inspected, some one is reported probably to have sent a package with some message in it, You should take due note about this even I know you are well aware about the postal regulation.

It is now nine oclock, so I am going to ~~ake~~ take bath, (Japanese bath) which is quite joy for every night before going to bed and will finish my letter tomorrow. so Good night for today.

Jan 15th. 11. a.m.  
To day, the boys from this dormitory (#30) went to work in the kitchen, some ones are working in the laundry so, I worked with a few to do morning cleaning of the dormitory. Mr. Yasui is well now and Takeoka is much better. the warmer weather is helping every body.

How is the church getting along? I'm thinking of <sup>the</sup> annual meeting which is to be held on the third Sunday of this month.

Dear Jacks at home:-

Thanks for your air mails of Jan 3 + 9th and glad to know that Everybody is well at home particularly glad May + Yo got the N.Y.A. job, that is fine you both got the work in Berkeley and trust Yo can get along with her school work not being interrupted. Too bad Laddie does not behave these days, he must be missing us terribly. Please pat him for me, I sometimes think of him much and also the garden. Are the sweet peas in good shape? -? Roses must now be pruned, Please ask some one to attend.

Very happy to know Mom got beautiful flowers and had a party for the Silver wedding. By this time you must have a happy news that I had been in Minoula in same night - Jan. 3rd.

Yesterday, Sunday we had Union Service (Christian, Buddhist + Shintos) in the Headquarters Recreation Hall for the first time for which Welfare Committee was responsible and 275 people gathered and stayed for 2½ hours so reverently. It was indeed a wonderful sight <sup>that</sup> 275 men bowed their heads in prayer for the peace and safety of



their beloved families. I could not keep from my eyes welling in that pitiful sight. Some people here have not yet heard from home over three weeks and feel naturally very uneasy. The Govt hearing starts in near future for Wash. people and also for So. Cal. but nothing heard about the hearing for S. F. The Board from respective place is supposed to come over here and conduct the hearing for the people in their own districts. Now about the business:

- ① Kay, you don't have to file income tax return same as last year because your income is not enough for the report. For Minn, I can not file return without my book, so I will notify S. F. Collector accordingly.
- ② Regarding bus on my car, think it expires in Feb. so you can talk to Mr. Sato to renew it.
- ③ Mails here seem to be crowded for censorship, so, do not send me any copies of recommendations. Please keep them for file.
- ④ Kay's affidavit, if you got one, you should send it to Mr. M. D. Collier, Supervisor - U. S. Long. Camp, Missoula, Mont., not to Mont. district Atty because I understand, U. S. Dist Atty from S. F. is supposed to come here with the Board to handle the hearing for S. F. district.
- ⑤ According to my friend here, Federal Reserve Bank Circular #14 - General Licence #11 dated Oct 10 - 1940 revised, I am entitled to withdraw up to \$500 - per month for living & travelling expenses etc - so next time you



Go to Bank of Am., you should try to  
withdraw \$500.00 for Jan or Feb. and put  
it in your check ac for the family's living  
expenses. Because I do not want to spend  
Kays' saving for family's living expenses if  
possible, it should be paid from my  
deposit as much as possible. I saw the  
letter from Fed. Reserve Bank and this must  
be in line with the law. (my ac was not blocked me)

⑥ It was good that you bought some defense  
Bond. If you can withdraw as above from  
my deposit, I would also like to buy for  
my ac \$100 bond. Please let me know what  
you can do.

I could do that all time <sup>outside</sup> but because the cold weather, they made me stay in. So many people had same trouble because of the severe cold. In the big hospital, there are a number of patients of more serious nature. Last Sunday, the new chapel completed and had Christian service for the first time, I attended of course & it was good. 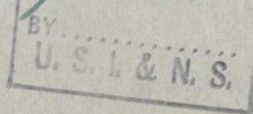

Your Registered letter has just come and I hasten to return the pink slip of my car with my signature fixed on its back for transfer and I hope you can get the approval of the F. R. Bank. I note you are also acting on the balance of my Credit account with Schwabacher Co. (Mr. Royal Cutler is my man to whom I wrote to transfer) and really hope you will accomplish the transfer the ap. In any case, you should try your best to draw from my ap for living expenses of the family instead from Kay's ap because the law permits such withdrawal from my ap up to \$100 - or up to \$500<sup>00</sup> per month under General License #11. I have just returned from the service which commenced in lland it is now almost 2 P.M. because Dr, Smith, thr superintendent of the Methodist church and Mr. Nicolson happened to be <sup>in</sup> the service and the latter gave us a short talk and Dr, Smith delivered a very good sermon after which they wanted to talk with many of our menthey know and the boys were very happy to talk <sup>with</sup> them who came a long <sup>way</sup> to visit us after seeing some of their people at home, we knew that Dr, Smith was in town but we could not get difinite information if he can come to our Sunday service, am trying to have them get the approval of the authority to come back tonight and have a special meeting for the christians in the camp and if possible, to have another service for the men in the camp at large which seems to be rather difficult on account of the hearings that will commence tommorrow for S. F. and L. A. people <sup>out</sup> ~~out~~ <sup>mk.</sup>

Last night I got your letter of the 25th and was very happy to know about things at home being O. K. Now a few thing about the business for Kay;

#1 I wrote to Mr. Dooley at the Mitsui office today copy of which is herewith enclosed and you are requested to deposit to my saving account in case you receive the checks referred to in the letter, it seems that those dividend checks in my name should be deposited to my blocked account.

#2 In case you receive the approval of the Federal Reserve to deposit the credit balance from Schawbacher Co. (Mr. Cutler) to my blocked saving account, I suggest that you order to buy further defence bond \$500. to \$1000, in hname of Kay and Yo but if the application was refused by the bank for the transfer to my deposit, you apply again on condition that you buy for the whole amount of the credit, that is, I understand, to be a little over \$1800, in which case I am sure the application would be granted because similer cases have been reported here that some of the men here bought the bonds out of blocked account,

It was very good that you made a pledge to the church same amount as before. I really hope the Federak bank will O. K. your living expence withdrawal up to \$500. a month as I advised you before;

Well, this is about all I can think of today and the biggest news for you is that I was formally advised the hearing for us is now set on Fe. 3rd Tuesday 9A<sup>30</sup> M. but I am afraid they would not have time enough and it is most likely my case will be delayed because so many San Franciscans received same notices. I hope that the papers you sent to Billings would reach here in time.

After the hearing is over, the papers are to be sent to Washington with recommendations and the decision is to be made by the attorney General there which will naturally take more than several weeks so we are to be more patient here and everywhere concerned,

I received a letter from Misaki the other day please thank her for it, will try to write later,

Yo, am enjoying the sox you sent immensely, thanks, you do not have to send any thing to eat as I can buy most anything in our canteen and all candies that come from outside are dumped out to a bag, they do not allow any wrapper or container from outside and it is rather pity to see those pretty things tore to pieces for dump, this is all today, with love and regards,

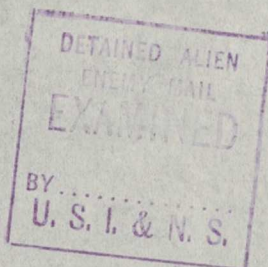

Dear folks at home:

Thank you for your letter of Jan. 28th which came to me last night and the package containing the dollars, ties and envelopes which was received yesterday, am so happy to know that you are all well and things at home are taken care of in good order, please thank Hiro, George and Koso and other friends in helping you in taking care of my garden which I miss very much.

Here in Montana, the weather is very much milder now and I have taken off one of the blankets out of my bed, the melting of snow and warm rain made the ground of the camp so muddy but it helped the people very much in

their cold: I am in good health and have been rather busy last few days because the educational committees now set up their force and I had to co-ordinate with them in preparing classes in our assebling hall and moreover one of the detainees here, 74 year old Japanese from L. A. passed away from pneumonia last Tuesday and we had to take care of the arrangement for the memorial service in the camp, poor old man, he was said to have married to his second wife at sixty and have three children eldest of whom to be only 13 living in L. A. running a small restaurant. As the chairman of the welfare committee, I had to officiate the memorial service in the recreation hall same night without the remain which was being shipped directly from the morgue to L.A. and with over 500 men packed in the hall, it was very impressive service in Buddhist faith which ended in exactly one hour with the government guard watching the meeting.

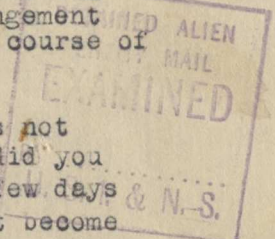
All men in the camp donated ten cents each which amde more than sixty dollars, we ordered a pair of flowers at fifteen dollars, candles and incense etc. and the sympathy of the whole camp was so deep and we sent also a wire of condolence to the family and the remain of the donation; Mr. Taaka, Mayor read written condolence while all me stood up in silent prayer and every body wept when the priest mentioned about the children and mother left behind.

Another sad news was that a 24 year old boy of a man from San Pedro met auto accident and died on Jan. 31st in so. Cal. and last night we had a memorial service in our hall last night with about 200 people there, one of his friends here conducted the meeting.

We have a number of men still in the hospital and one of them is reported quite serious, the case is said to be aftermas of stomach cancer operation so there is no hope for him, he was arrested in his sick bed early in Dec. and was brought up here in bad condition and was put in the hospital right after his arrival here. Well, this is rather full of bad news but I can not help it.

Very glad to hear that Mom and Kay went to the bank and were given to to understand that my understanding as to the limit of the withdrawal for the living expence was right. I earnestly hope that the arrangement of the transfer of Schawabacher co.s' credit to be in order in due course of time, Please let me know when the arrangement has completed.

I understand Mr. Motoyoshi in S. F. Immigration detention is not feeling well and Matsumoto boys were there to see him every day, did you see them too? It is reported that more men are coming here in a few days and it may be that Mr. Motoyoshi is in the group, Do you know what become of Mr. Abe, A lices' father?

D id I tell you in my last letter that I met Dr. Smith, yes I think I wrote you about the sermon he delivered last Sunday in our service with Mr. Nicolson from the S outh both of them are said are working in the hearing of Seattle people as interpreter or character witness; Mr. Morphy of Seattle was here too and I had a chance to talk with him out in the yard when he stepped out of the office, I did not recognize him first but I heard some body else calling him by his name I began to talk with him who also could not recognize me first, was very happy to chat with him for a few minutes.

The hearing for the Sanfrancisco people began on Monday Fe. 2nd and my case was calendered first on Tuesday but has been delaying every day and with S aturday tomorrow, I have not yet been heard, hope it will come out alright in a few days.

I am glad too that Kay did not get the new job that requires her to stay out which I do not like; as long as you can withdraw from my account for living expenses, the girls do not have to work out much, I would rather have you both stay with mother while I am away.

On Jan 23rd I wrote to S. F. office FBI 111 sutter St. asking to return the keys they retained but so far have not received them yet and it may possible that the keys be returned to Kay Uchida in which case you will please let me know so that I colse my file here.

Through the Radio and the press I hear that the government has ordered to move some of the Japanse in particular areas and I hope that Berkeley has nothing to do with it. In Oregon it is reported that all licenses for Japanese first generation have to be revoked as of Feb 16th and some of my Portland friends here are quite worrying. by the way, Mr. Yasui has recovered and one of his sons came up here from Hood River in his hearing and two daughters of Inazuka (Florist you remember Mrs. Masuda, sister attended in their birth) also came up to see their father who is here.

This is all for today and if you can you will please forward this letter to grandma after your reading. With Kindest regards and love,

Dear Folks at home,

Thank you for your letters of Feb, 1st which came to me on the 9th and was read with interest as usual, I note Mom had a cold and had to stay home on Subday but trust that its over by this time, Here in Mont, the weather is fine every day tho the ground is still covered with snow but its much warmer and every body seems now <sup>has</sup> done away with their cold.,

My hearing was conducted on the 10th that is yesterday and which I donot know what will the boards! decision be, I think I did pretty well and the most of the papers and affidavits were there and now I have to wait for another month or two before the decision is made in Washington and the supervisor advised us menthat it is better not to be too optimistic and disappointed but be rather pessimistic and be determined for the worst which may turn out in happy end, I do not think there is any chance for release for those who are in status of treaty merchants, and most of them are ready to stay here during the war, there may be little to be released.

Now, our day school has started every day, from ten thirty to eleven thirty, we teach English conversation and 1:30-2:30 English Letter writing, ~~#####~~ 2:30-3:30 American History and every other night we have a class of Lecture on Law and every class we <sup>have</sup> students 75 to 90 most of them forty to sixty years old and they are so earnest and the teachers are all my friends, I have to cooperate and take charge of the hall for the classes so I attend every class and find them very interesting which keeps me very busy and I like it,

Last sunday over ~~more~~ more Japanese arrived here most of them being from Southern Cal, and I found Mr. Tanaka, of L. A. Union church, photographer who said he was arrested on Jan, 18th, I understand many more Japanese detainees were sent to North Dakota by same train detached including people from S. F. , Portland and Seattle; Mr, Matudaira (三十八) who was at Mikis! place was among S. F. detainees, poor him to be sent out to North Dakota without friends there, Hosino telegraphed him last night, there must have been some other Japanese from S. F. I wonder if Mr. Abe and Motoyoshi were included in the group.

Toki & Kaoru wrote me letters, Please thank them

when you write to L A and also tell Kumai to thank on my behalf to Rev. Abe and Rev. Watanabe who were kind enough to send me their letters of recommendation which came to me on the day of hearing, the Kumais were probably responsible for that. I receive more letters recently which of course makes me happy but we have regulation here now that only three letters <sup>a week</sup> are permitted for each and I cannot acknowledge them all, please explain to friends,

I understand from the paper that alien enemy in certain areas in the coast have to be removed and notice that in Berkeley the section where most Japanese people live is not affected, is that right? Please let me know, how about Mrs. Uyeyamas and Mr. Kitagawas which I understand are affected, Most of Alameda people are affected I believe, How about Uno san? and in Oakland Mr. Mori who is not affected I hope, but Marthens home must move I think, it is too bad indeed that those peaceful permanent residents are so disturbed but under the war emergency this can not be helped and they should be thankful for not being interned like so many people here who are mostly innocent victims of the circumstances.

The typewriter, 25 years old of Mr. Suzuki, teacher of Kimmion Sakura has been taken away, so will finish my letter by hand writing. I received what "Keyu Set" "Go" alright but I'm not using it at all, as my leg is OK and no trouble. Monons Mr. Ishida of Nichiren Church is in my camp, so if I have any physical trouble, I expect to have him "Okeyu" so please do not worry.

The laundry is operating and all dirty clothing except handkerchief & sock are taken care of. One sheet towel, pillow case are also washed by them, so the people here <sup>even</sup> now say they want to stay here permanently. Ha! Ha!

The Airmail Envelopes you sent, are held and not yet released; think I will get them soon -

Dear Mom, Kay & Yoshi,

I am writing on the 25 year old typewriter which Mr. Suzuki of Kimmon-Gakuen got from his home where they kept in their basement unused for many years but it works alright and it is a great help for us because it is only machine in this dormitory,

Thanks a lot for your letters of Feb. 4th glad to know that mother is better and trust, is up by this time, and happy to know that you drew the amount you mentioned from the bank and hope that Kay will be successful in getting the permit for transfer of my credit balance of Schawbacher Co. (Mr Cutler) to my saving a/c Please try to keep after and in case the application is definitely refused, you had better file a new application with the condition that the fund to be paid for the defense bonds in which case I am sure the application will be granted as I heard the same case being granted for the people here, Please let me know the results, I do not care much for transfer of the car, it does not make much difference but if you can not transfer you simply take the other way of sale, it must be very simple.

I enclose herewith the card for Bank of America with my signature on, I think you have already received the other one too also enclose the clipping showing the Whitney's bride, this is all I got from L. A.

Last night, Spanish consul and vice-consul in S. F. came to this camp for the inspection, they represented Japanese interests in U. S. and in course of conversation with me they said they would be glad to telephone you on their return to Cal, telling you that I met them so someday they may call you up by phone, You know Spain represent Japanese interests in U. S. during the war.

Kay, you will please write in my name to Sacramento that I am now detained in Missoula pending the hearing and therefore will not be able to file income tax return by April 15th, I already notified Federal office about same subject and also notified F. R. Bank about financial report to be filed by Feb. 15th by enemy aliens.

Its indeed too bad that Mrs. Uyemura, Mrs. Koike have to move and so are Oshimas Hayakawas but it is much better than the master of the house to be detained in Mont. I hear by radio that many more people have been taken to custody in S. F. and also in the coast area, by the way, Miura family in Monterey will have to move.

 by Japanese Church Federation in Seattle through Mr. Kodaira  
 as I made request in the name of Welfare Chairman -

 The supervisor made special approval to pass and we  
 used the hymns for the first time.

Dear Folks at Home:

Thanks for your letters of 15th, 18th 17th registered which reached me earlier than the other two and your telegram of 20th made me very happy, glad Kay got the both licenses and fixed my bank a/c OK think you can withdraw from either bank for the living expenses.

I previously informed the F.R. bank that I could not file required financial report ~~By~~ the limited time but as you sent me forms, I made out the report in my best memory subject correction and mailed it directly to the bank by registered airmail which will reach them by Feb. 28th, I reported approximately as I advised you previously.

I think two Bonds (city of Tokyo) which belong to the church should be turned over to the new treasurer as I am not any more the officer of the church so suggest Kay or Mom take them out whenever you go to the bank and deliver to the new officer of the church, Very sorry to hear that Hayakawas and Uno families had to move out of Alameda and the church naturally to be affected in financial support.

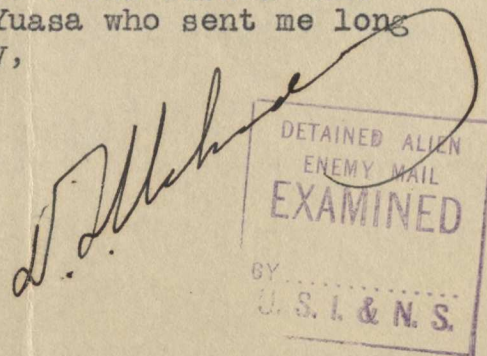
Regarding my income tax return, I wrote a letter to the Collector of internal revenue in S. F. and have received a response stating that I can file the return on my return to Berkeley with affidavit for the explanation, so I think this is OK.

The most of the people here are through with their hearing and feel quite relieved and last <sup>night</sup> we were all invited to the concert given by the Italian internees here which every body enjoyed, I learned from the radio and Sacramento papers that Mr Kitagawa was taken to custody and we all friends felt so sorry for him because every body knows he is home loving man and will most likely sent to N. Dakota because we have not any more accommodation <sup>here</sup> to take care more people, in fact we had to give up our new chapel which was nearing to completion in order to take care more people who came from the North west a few days ago and our hall is now consolidated with Post Office and the store with smaller space that made me very sad but could not help.

I received a letter from Mrs. Seki yesterday and card from Shubo, Please thank them over the phone because I was warned that I write too much and today am writing to Dr. Yuasa who sent me long kind messages on a card. this is all for today,

My Dear folks at home:

Thanks for your letters of 22: & 25th which came to me last night & today, happy to know that you are well and Kay likes her works and the people treats her so nicely and you dont have to worry for the delay in receiving the new papers from Sacramento for the car because I know they have been slow before.

Im returning you herewith enclosed the following papers  
with my signature duly affixed thereon;

#2 for Byron Jackson CO.

#3 for American Trust Co.

Monday, I sent you wire asking to send me \$30, for my pocket money which I trust is receiving your attention, I also suggested to draw March allowable for living expense promptly and this advice may be good for Kay to pay prompt attention for future to act on first ~~month~~ every month, thanks for information on my claim against Farmers Ins. Co, which sound no good to do any thing further,

Here is [redacted] an oldman from L. A. passed yesterday morning in the hospital and I had to officiate last night a memorial service in the recreation hall, about [redacted] [redacted] men stood with their heads down so reverently when Mr. Taoka, mayor read his condolence representing all men in the camp, each donated ten cents each bought [redacted] wreath and one of our carpenters build a cross and the service was good, the man was sick when he was taken to custody after cancer operation and his children came up here twice to visit him and again they came up on last Sunday when the man was released on account of sickness, he died in early morning several hours before his children arrived. This was the second victim since we came here.

I understand many more arrests were made in the coast and feel so sorry to know that Mr. Uyebara was one of them, most of them are to be sent to N. Dakota, please send my comforts to Mrs Uyebara. I sent a card to Iwabuchi Ellis Isld N. Y. and received a wire from him yesterday in which he stated that he is well and some of his friends have been transferred to other camp,

I learned Dr. Kiyasu was also taken, is that right? How about Maris' father? Mr. Kitano was also taken.

If Kumai lost job and has no income, suggest you to send \$20. monthly to grnadma for allowance which will be some help.

I do hope that the reported mass evacuation will not come true and hope to know the real situation there.

Have just received the sox you sent and thank you very much, the climate is very much warmer and I expect to send for summer wears pretty soon and I might use this pair you sent in next winter if I have to stay here.

Tnanks for Tel. & letter of Mar 3rd from which I note th that the people out there are calm but you are getting ready for any possible order to leave, some of the people here have received the order of being freed under parole but with condition that they are not to go home which is in prophibited area and they have select a place outside of the area with some guarantor there which is very much hard for them and naturally they do not know what to do and are consulting with their folks at home, no one from San Francisco group has received the decision from Washington <sup>yet</sup> and Dr. Gill has just written to me has heard nothing about my case, the most of the people here are quite worrying about evacuation order and are inclined they would rather stay here with friends than to go any other p place without friends and family in a strange place.

Grace Obata wrote me a letter for which please thank her as i am not going to aknowledge it, I must not write letter more than three in a week. understand Mr. Nakamoto of Berkeley was taken, was there any one else from Berkeley? Was Mr. Iyeki of Oakland taken? How about Mr. Aoki of Oakland M. E. church? Understand many more Japanese were taken allover the coast and we feel very sorry for them.

I had the other day good talk with Mr. Eto, Marys' father who is staying in the dormitory next to mine and so is Mr. Shinosaki who gave me some Unagi (fish) at the lunch today, it was fine. Please send me by parcel following:

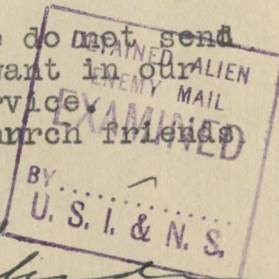

Cal, were sent to [REDACTED]

Yesterday, I received all my keys returned from the FBI San Francisco after writing them twice and you do not have to worry about the missing keys,; The process in Wahington seems moving very slowly and we do not hear from them yet about their decisions on the hearings for the N. Cal. group and most of us all are determined to meet the worst any time, only a few people have been released up to this date. (Not from our group)

I also received the Pamphlets that Rev. Ozaki sent to me and you will please tell him that I am going to distribute among the people, tell him thanks, Miss Hatuye Sato wrote me a letter today and as I am not going to acknowledge it, please call her up and thank for it telling Mr. Hoshino also read the letter.

Did I write you in my last that I got the new pair of sox you sent which Im now using, thanks a lot and that check you sent was duly received also. Did you withdraw the March allowance? presume you can from American Trust too for April, do it on the first every month.

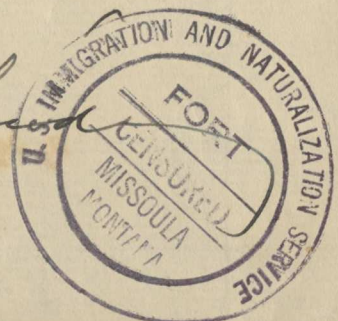

Dearest Folks at Home:

Thanks for yours of the 4th & 9th, latter reached me today as there is considerable delay in censor these days, am glad you are all well and getting ready packing things for the order to evacuate, here I'm well as usual spending busy hours daily with new and old friends, there being 4-5 classes a day it's just like regular school and to-night I have again to officiate a memorial service for a man who lost his only boy child in L.A.

Dr. Learned wrote me a letter last week so did Shun Nishibayashi, I acknowledged both of them and Dr. Learned told me he has not been outdoors since last Aug, think he is weak now, asked him to pass my letter to Miss DeForest there so that she can know of my recent wellbeing.

Congratulations, Yp for 4As 1B, am sure the University will give the seniors their graduating credits and you will get the degree alright: From the press (we are taking S.F. Examiners here) I have a feeling that the evacuation order may not come for those living Berkeley particularly so for women and children and if it comes, it must be sometime later in seven or eight months because I believe that the accommodations in the Owen valley or any other place can not be completed in such a short time to take care of 200 thousand people and I earnestly hope that those residing in Eastbay will not have to evacuate eventually.

In any case, you don't have to work so hard for packing, take plenty time and give away those things in the back room to needy people. Do you need any of my keys? if so I will mail it, so you let me know about it.

Grand Ma and Kumai did not even acknowledge my telegram sent in Feb. and they might have misunderstood about the mailing restrictions here, you tell them that there is no restriction for incoming letters, glad to know that Grandma is now fixing her teeth: If Kumai & Hiro both out of job, they may need some of our financial assistance, you ask her sometime and if so, please <sup>do</sup> whatever you will for them.

We are preparing for the Easter Sunday service here and three men are going to be baptized on the Easter.

This is Sunday afternoon, just returned from the dinner after the baseball game between S.F. and Seattle in which our team won in big score, dinner menu was roast beef, spinach, rice and can peaches, it was so good.

Thnaks a lot for your tēlēgram which came to me yesterday PM and I certainly appreciated your kind thoughts and Kumais sent me fruit cake and some canned eels with their birthday greetings so I had a tea party last night with boys in the camp and every body was very happy, Hoshino got some other cake from his ~~friend~~ in S.F. which also was donated to the party: Some of our ~~friend~~ friends here having left for the Southern camp in Oka, we lost almost half of the boys in our dormitory and it <sup>was</sup> so sad for every body to part, Oh, every body cried and cried I <sup>was</sup> so sad too so my birthday <sup>cake</sup> party made them a little cheering and I told them that the fruit <sup>cake</sup> came from L.A. was probably baked by my mother eighty years old, that made them happy.

You told me in your tel. that Geo. & Misaki married, I am ~~sure~~ sure they must be very happy, Im going to tel. greetins tomorro morning.

I told you in my tel. of 9th that my prospects are entirely uncertain and I do not know how soon my status will be fixed, none of S.F. people has been released yet but we expect in a few weeks the decision to be made for us all; in the meantime I thought it would be better for you if permit obtainable to move to Sacramento or Fresno which may be now too late but I believe the Government will permit voluntary evacuation some more within reasonable scope I learned Matsumoto family moved from Seattle to his brothers home in Spokane, Wash.

You say about the disposal of your piano, furnitures etc. I think your arrangents are good, I do not care much about the furnitures and you may dispose them just as you think best, most of the things in the back house must be given away to Sal. Army. Im receiving our church bultins weekly and can learn what is happening in the church, please thank Rev. Ozaki for that. I do not understand what Byron Jackson Co. said, you had better send me their notice.

Will you please forward this note over to grandma so that she can know how much the fruitcake was enjoyed?



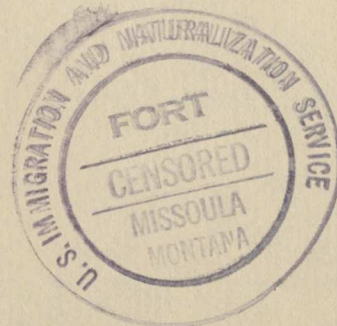

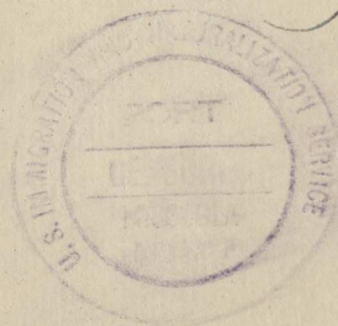
