QUESTIONNAIRE REGARDING INTEREST IN ADVANCED STUDY

Because considerable interest has been shown recently in an advanced course of study in the Certificate Program and also in a scholarship program, an Advisory Group of the Alumni Association has developed a questionnaire to measure this interest. At the meeting on February 24, a preliminary questionnaire was distributed. Based on the results of this survey, a revised questionnaire was developed, a copy of which is enclosed herein.

There is little doubt that advanced courses will soon be offered in such areas as recent developments in labor law, health and welfare, prepaid dental and medical plans, and workshops in grievances and arbitration. The problem now is to determine exactly what format should be followed to best meet the needs of the Association. It is hoped that your cooperation in replying to the questionnaire will help us to decide these problems. It is now anticipated that we will start the program this summer with a Grievances and Arbitration Workshop if sufficient interest is shown.

Another subject on which your opinion is sought concerns the possible creation of a scholarship fund. Through this fund the Alumni Association would sponsor deserving individuals in the Certificate Program.

As soon as the questionnaires are completed and returned to us, we will report the results in the IR News.

PREPAID DENTAL CARE CONFERENCE - April 29 and 30

Because prepaid dental care has become an important new fringe benefit in collective bargaining relationships, the Institute will co-sponsor with the Alumni Association a community-wide conference on prepaid dental plans. The April conference at the Statler-Hilton will study costs and quality of dental care, facilities available, and alternate approaches to dental care.
