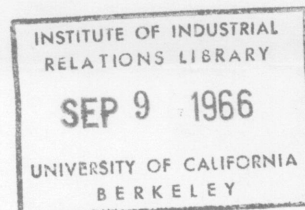

NEWS BRIEF
ON SPEAKER
FOR SEPTEMBER

Mr. Charles Hackler, A.B. and L.L.B. degrees from Kansas University; member of Phi Beta Kappa; engaged in general practice of law in Missouri becoming Regional Attorney of the National Labor Relations Board in Saint Louis, Missouri, 1941; continued as Regional Attorney and Chief Law Officer of the National Labor Relations Board in Saint Louis and Los Angeles (with time out while serving as Gunnery Officer in the Navy) until 1953; 1953 to date, private practice of law in Los Angeles, specializing in the field of labor law representing unions; clients include Teamsters, Ladies' Garment Workers, Operating Engineers, Newspaper Guild, Typographical Unions, Upholsterers Union, Electricians, Los Angeles Building Trades Council, and a number of other unions.

In addition to all of the above accomplishments Mr. Hackler enjoys a reputation as a stimulating and informative speaker.

Topic: "Current Trends in Industrial Relations"

Mr. Peters is the author of two well-known books in the field of Labor Relations, CONCILIATION AND ACTION, and STRATEGY AND TACTICS IN LABOR NEGOTIATIONS, both published by National Foremen's Institute. The latter has recently been published in paperback form. He is also the author of numerous articles on Industrial Relations which have appeared in the Labor Law Journal, Personnel Journal, and California Institute of Technology Publication. At the last meeting of IRRA in New York, Mr. Peters presented a paper on "Recent Literature in American Labor History," which has been reprinted by the Institute as #157. Mr. Peters has taught Industrial Relations and Collective Bargaining courses at UCLA, Loyola University, Catholic Labor Institute, and the University of San Francisco. He has appeared frequently before Town Hall as well as PIRA meetings, and enjoys great popularity as a speaker for labor and management organizations and various service clubs.
