Fatigueness from manual labor still prevents me from doing any mental work, such as writing letters and reading books. But all in all, I'm enjoying this life in spite of the many inconveniences.

It is certainly surprising how quickly most of us can adapt ourselves to the new conditions. Everything is simple and wholesome even the meals. The very simplicity of this camp life provides us the incentive for creative activities. For the first time, some of us are beginning to see that most of the luxuries, and many of the so-called comforts of life, are not only unnecessary for comfortable living, but are positive hindrances for elevation of our group. In the past we have been so concerned with dollars and cents that we never had time to appreciate the simple things.

If it isn't asking too much, I'll appreciate very much if you can send me Box 1A containing books, bulletins, etc. In the box are numerous informational notes which I wish to use in this camp. You will find attached to this letter two dollars which I hope will cover the expense incurred in sending the package to me.

Should you find time, I certainly hope you and Dr. Thomas can visit this camp. You'll find it very interesting and worth while.

Dear Virginia,

It has already been well over five weeks since my ~~first~~ arrival to this Center, and I still don't know whether I've accomplished any thing worth while. One thing, however — I'm still unemployed, that is, in the sense that I'm <sup>not</sup> on the official WCCA payroll. Actually I have no definite job — but volunteer to do almost anything where my service can be helpful to the residents of this Center.

Early this week I submitted to the Recreation Dept. a design of miniature golf course for this Center. I spent several days on the design and the general lay-out of the course — even calculating the exact amount of lumber, nails, and other materials needed for the construction. But I discovered yesterday that because of shortage of lumber in this Center, the project can not be undertaken. Anyway it was fun while I was working on it.

At present I have on hand two or three tasks. One is to prepare a series of quizzes as a part of the recreational program for children and young people. And boy, what brain twisters I have for them. If you care to get some idea of what I mean, I shall be only too happy to send a copy of these quizzes.

I'm also working hard on a community-wide Treasure Hunt which is expected to last approximately two weeks. Handling the messages to be used in the Hunt is my task. I really believe that I have the most interesting phase of the planning end.

Planning Victory Garden projects is also my task — but exactly what can you do with only 7 packages of seeds (beans, peas, carrots, radishes, squashes, chicokory, lettuce)? After careful calculation as to the amount of space that would be required for planting of these seeds, I found that the garden plot would be no larger than 30'x10' — which is indeed very, very small. But strangest part of it all is that I'm suppose to distribute the seed packages equally among seven Recreational Centers. This means that each Recreational Center will only receive enough seeds to occupy a space of 5'x6'! Now what in the name of Heaven can you do with that!

You mention Sam Nakano of Fresno. Yes, I do know him and I might add here that he has been of tremendous help to me during the three or four months when I was working as an agricultural coordinator of JACL.

On the matter of where and when we are going, Mr. Fyler of the W.R.A. informed me three letters that the W.R.A. is unable to say, at this time, just when we will be moved from Tanforan. And the place to which we will be moved depends to a large extent on which Centers are completed first and their proximity to Tanforan. Most of the residents of this Center hope that they can be moved to the Tulelake Project - but I ~~don't~~ doubt this very much in light of what is taking place at present.

Dear Virginia,

Thanks a lot for your letter of July 18. I'm sorry I could not have answered it sooner. Lately we have been having so many social activities that most of us have very little time to do any writing. Every night in the week there are approximately five or six social events going on simultaneously at various recreational centers in this camp. Just to mention some of the events taking place each night, we have such community-wide events as folk dance (Mon), musicale (Tues), Town Hall (Wed), variety show (Thurs), jitterbug session (Fri), social dance and Saturday concert (Sat), church programs (Sun). Beside these, we have the following events at recreational centers: Boy Scouts, bridge classes, movie nites, young adult nites, dance classes, knitting classes, mix social nites, bingo nites, family nites, chess and checker nites, appreciation nites, etc. You can readily see that we have a wide variety of activities which should help to fill the leisure hours of those in this center.

I'm still with the Recreational Department and am thoroughly enjoying my work, however at present I'm having some difficulty in that I am running low in ideas for new recreational activities.

In regard to the data on property losses and agricultural evacuation that was supposed to have been collected by the southern branch of the JAFL, I can say that I have definitely no information. I would, however, suggest that you write to the National JAFL Headquarters in Salt Lake City (Beason Building). Perhaps they may be able to assist you on this matter.

Dear Nobu:

I received your letter of the 25 but have been working at home so haven't been to the office to answer it. I did an analysis of property loss in southern California due to the evacuation. It is very interesting, but I just don't have enough material. I am writing Kido in the hope that he can give me some further information.

Tanforan seems to be booming with recreation. I haven't had a chance to come down for a long time but I hope to see a marked change when I do. You certainly sound busy. Are you working on your agricultural material. You know, that holds the most interest for me too.

I can't remember if I told you that I took a trip to Tule Lake. It was surprisingly nice. I think it has the possibilities of a thriving little city. It has a very nice climate and, of course, good soil for agriculture. The administration is very fine so I expect that this place will prosper.

All I can find out about Gila is that it is very hot, otherwise reports are as you'd expect---some good, some bad. It no doubt presents a lot of opportunity for agricultural work. You could be of great help, I believe.

I shall try to get down to Tanforan, perhaps next Tuesday. If so, I hope to be able to see you.

Dear Virginia,

Last week we received official words that we will be leaving Tanforan very shortly, probably between September 15-30. Although we have no information as to where we are moving, it is rumored that we'll be relocated on the Utah project, near Abraham, in Millard County. Most of the residents are dead sure we'll be moving there, but I've got my fingers crossed. My past experience has taught me never to be too sure of anything. Now that we know just about when we're leaving, there might be a let-down in various activities among the residents for the next few weeks. Chiefly, it would be up to the Recreation Dept. to keep the morale as high as possible to the last day.

Once relocated, I am not certain as to what I'm going to do. If conflicts should arise among certain groups, and I hope not, I may not get the opportunity to work in the agricultural field. Besides, anyday the Army may get me. When? I don't know; but it seems as if the Army is really anxious to get me. But whatever job I get, whether it be in the Relocation Center or in the Army, I'll do my best.

Since we'll be moving out here very shortly, I would like you to send me my second box of books, pamphlets, bulletins, and notes....BOX 1B. I am enclosing one dollar to defray the cost of forwarding the box to me. Thanks.
