

May the birthday be a happy one. We'll share it in spirit.





I am sending you copy of a letter I am writing him today, which is intended as much for you as for him. You'll pardon me for not writing another letter, but time does not permit.

My dear Jack:

I am this morning in receipt of your fine letter of August 4. I have read it with the utmost interest of course. I am hastening to respond to one or two things in it.

First, you are quite right - that if I am going to get into a political fight I ought not to be required to come to California, and yet everybody there insists that unless I do, the whole situation is gone. It is a pitiful thing that the next three months, which will be the most important months in reality must be devoted by me to my own State. I speak of course, tentatively, because I have announced no candidacy, and possibly the situation, within a very brief period, will develop so I will not. I ought, however, to be right on the ground here, or between New York and Chicago, so that instant decisions may be made, and, in any event, the ground work laid, so that an intensive campaign could be made, if desired. The only person with whom I have written with any plainness is C.K. McClatchy. I am going to send him copy of this note to you, and I am going to write Arch, in substance, what I am writing to you. The entire political situation is in the air. Certain

including some Senators of the politicians/have decided to let the matter ride for the present as if they were going along with Coolidge, and see how he will develop. Certain others, however, ^{not Senators} and no inconsiderable number, embracing people in New York State, Illinois, Iowa, Missouri, Kansas, Nebraska, and some few scattered in the South, are most anxious immediately to go to the bat. They argue that delay means people being tied up to the power that is actually and actively in the fight, and that an avowed candidate like the incumbent of the presidency of necessity will get adherents when there is nobody in the open in opposition. The people from the West want to pit the West against the East, that is the West against New England, and in response to the cry that New England should be solidly behind a New England man, make the comparisons now between the importance of the West and New England in population, resources, wealth. Those who are interested in me want me to stay right here quietly, and get together my friends in New York City, in Chicago, in St. Louis, Kansas City, Omaha, not necessarily in public gatherings, but let them understand, that they may proceed intelligently and may not be left, during the early days of a strenuous fight on the part of the Administration to tie up everything, in doubt as to what my intentions may be. Indeed, in South Dakota, they have served notice on me that they will pay no attention to what I intend to do, that my name will go on the ballot, and in the first direct primary, they will carry the State. I don't know whether this is over-enthusiasm, or whether there can be accomplished what these gentlemen think can be accomplished.

I am obsessed with the fear that in the midst of the whole thing, unless I come to California, California is going awry. Nobody here knows yet what Hoover is going to do. The consensus of opinion is, however, that he is going to stick in the Cabinet, that Coolidge is going to utilize him, and that Hoover will be the residuary legatee of Coolidge as he had expected to be of Harding. Lowden is already in the field. At a gathering here on Wednesday before the ceremonies even in the Capitol, and on Thursday morning, at breakfast with certain people from Illinois he whined like a child, and said he was entitled to the Illinois delegation as a favorite son. Wadsworth wants to sneak the New York delegation in the same fashion. Watson is scheming to do likewise in Indiana. The politicians who are here from New England and some of the Senators have adopted the course indicated above, and ostensibly are for Coolidge temporarily. Coolidge may dramatize himself in the coal strike, over some relief to farmers, or in some other fashion, so that he will be impregnable before the people, and if he does, they want to be able to say, they always expected it of him. On the other hand, he may render himself unpopular by some supposedly popular move, or he may remain negative in character, and somebody else may capture the imagination of our people. And so these politicians and senators want to keep things in a tentative sort of mood, where they can jump as they see fit.

There is a Providence that watches over me perhaps, as was demonstrated in the Moses incident today. For eight months

Moses has been after me to declare myself a candidate. He has used every art of persuasion. He has been pledging people for me, apparently, and making a great pretense of what he was going to do. He was to be a part of the banquet in New York, claimed he was sick, and sent a telegram. He wrote the article on me published by George Henry Payne in Payne's "Forum". There was always just a note about him that was unreal. A man of ability, with a real head on his shoulders, he is as irresponsible morally as George D. Collins. I never acquiesced in his arrangements, and never consented to go forward with him as a candidate. Only Wednesday night he dined at our house. Only Wednesday he pledged his fealty anew. Without a word this morning he announced himself for Coolidge. I had a narrow escape and was saved only by the sixth sense that has enabled me to deal with human beings since I have been in political life. What he has done, however, rather makes me sick to my stomach, just as if I were observing something decaying, and rotten, and stinking. I have had several telephonic messages this morning from outside of town, from people to whom he has talked in the last few months. All of them are perfectly aghast. All I can do is to laugh and say - that is Moses' way. He never came near me yesterday, and it was simply the tone of his voice on Wednesday, when he visited in my office, that gave me an inkling of what might be contemplated by him. His sudden conversion was yesterday afternoon when he had had a secret confab with Coolidge. I have nothing

to give, and Coolidge now has much. In that, with a man as immoral as Moses lies the answer.

But what I started to write you, and I have drifted far away, was concerning coming to California. I don't want to come, and the coming would most seriously interfere with a hair-trigger situation, which I can not direct three thousand miles away, and which in the brief period now of two weeks, I can not get in shape. The next three months, which all my friends say, will be absolutely necessary to get California into shape, will possibly remove any hope nationally, and all hope will be removed if California is in bad shape. So, there you are, and I am putting the matter up to you. I would appreciate it if one of you boys would have an intimate talk with Mr. C.K. McClatchy, McCabe, Boynton, and perhaps one or two others (not too many or the whole thing will leak out) and then write me very fully.

I had a very fine letter from Theodore Roche in which he spoke of some sort of demonstration on my arrival. Under the circumstances I think there ought to be nothing of this sort at all. If I do come out, I ought to come quietly without any great todo. It would be, in my opinion, inappropriate to reach California in three weeks with a great blare of trumpets, and a reception which could be taken but one way, a candidacy for the presidency.
