Dear Congressman Scheuer:

I am writing to urge you to vigorously condemn the recent aggressive steps taken by the United States in bombing oil depots and other targets in Hanoi and Haiphong. Defense Secretary McNamara rationalizes these actions by using the hackneyed argument that these attacks were necessary in order to reduce infiltration into south Vietnam. He says this in spite of the fact that infiltration has apparently increased since U.S. air raids against the north began over a year ago.

I am at a loss to understand what this new aggression means, except to conclude that President Johnson and his advisers are intent on destroying all of Vietnam and provoking a catastrophic war with China. You will recall that I strongly supported your letter calling on President Johnson not to initiate attacks against Hanoi and Haiphong. I trust that you will now protest this action as strongly as possible.

I also wish to advise you that in keeping with its unannounced policy of squelching dissent I have been called up for induction by the Selective Service System. I have been outspoken in my criticism of the Vietnam war and have participated in many demonstrations. However, for the past year I have also been enrolled in a full-time graduate program leading towards the Master's Degree. I have even won a competitive scholarship to enable me to continue my studies (on a full-time basis) in September.

Furthermore, my wife and I recently used our life savings to open a small bookstore in Harlem near C.C.N.Y. My wife works to support us and I operate the bookstore, which is not yet self-supporting. If I am inducted then we must lose our life's savings and all the time, energy and hope we have invested in our small business. I informed my Local Board (No. 62 in Atlanta, Georgia) of these circumstances and appealed the 1-A classification which was assigned to me. My appeal was denied and I have now been called up for induction on July 7th. In view of the facts outlined above I can only conclude that the Local Board is "out to get me" because of my protest activities.

I bring this matter to your attention because it is a flagrant example of the use of police-state tactics in crushing dissent. That such tactics are employed by the Selective Service System, which has life and death control over the destinies of millions of young men, is all the more horrifying. I hope that you will bring this matter to the attention of the House Armed Services Committee which is currently conducting hearings on the Selective Service System, and take what other action you can to alter this highly unjust and anti-democratic System.


Dear Friend:


Dear Mr. Allen:

Dear Senator McCarthy:

I am writing to express my support for your call for a Senate investigation of the Central Intelligence Agency.

I have serious misgivings concerning certain activities of this agency. While there may be a legitimate need for intelligence activities, there can be no doubt that democracy has been dealt a mortal blow when it is revealed, as for example in the Bay of Pigs fiasco, that the CIA initiates and conducts a foreign policy different from that publicly proclaimed by the U.S. Government. Indeed, it is my understanding that the power of making and implementing foreign policy has never been mandated to the CIA. If this agency has appropriated such power, then it is the clear duty of Congress to remedy the situation and act to limit the CIA to those activities prescribed by law.

Furthermore, the CIA is responsible for disbursing large sums of the public monies, yet no accounting for these expenditures is made to the American taxpayers. I firmly believe that it is high time the principle of accountability be extended to include the semi-autonomous Central Intelligence Agency.

I think that if the above recommendations cannot be implemented within the present framework of the CIA, then perhaps the entire organization should be abolished and some more satisfactory arrangement found to replace it.





I have for acknowledgement, your letter of April 5, 1965 mentioning that in your experience in travelling by our buses you have never seen a Negro bus driver nor any other Negro employees performing other than menial tasks.


Let me state first of all that our company is a member of the Plans for Progress Program conducted under the auspices of the President's Committee on Equal Employment Opportunity. We are also an Equal Employment Employer. We employ Negroes and members of other minority groups in every department of our company as well as in supervision.

As to your statement that you would be interested in any figures concerning the total number of Negroes employed by our company, I desire to advise you that this information is confidential and we are not permitted to release this information. These statistics are furnished annually to the President's Committee on Equal Employment Opportunity. We enjoy an excellent relationship with the New York Commission on Human Rights and if you are interested in an overall evaluation as to what our company is doing in this area, I refer you to Mr. D. Robert Ricciardi, Acting Director, Regulatory Division, Executive Department, New York State Commission for Human Rights, New York City. I am sure Mr. Ricciardi will be glad to inform you of our progress.

Should you care to call upon me, I will be glad to have a member of my staff point out to you the many Negroes that we are proud to have as members of our organization.
